

## **VOLUNTARY BLOOD DONATION ASSOCIATION IN NAGALAND**

(Temjenkaba, Information Assistant, DIPR)

To increase voluntary blood donation in Nagaland, a group of likeminded donors came together to form a voluntary blood donation associations. Thus, the Voluntary Blood Donation Association Kohima (VBDK) was formed in 2011 understanding the need for an action oriented approach to help the people who need blood.

Till date, the districts of Kohima, Dimapur, Mokokchung, Tuensang, Zunheboto and Peren formed the district association, with the objectives to donate blood and to facilitate those who are in need of blood. These associations are actively involved in assisting many patients in times of need. Creation of awareness by organizing voluntary blood donation camp, celebration/observation of special events like the World Blood donors Day 14th June and National Voluntary Blood Donation Day 1st October all over the state. Such events are supported by the Nagaland State Blood Transfusion Council (NSBTC) and the Nagaland AIDS Control Society (NSACS) as well as contributions from various organizations, donor agencies, private enterprises and individuals. The technical support for the blood donation activities is assisted by the respective district Blood banks. It is the result of such activities, that there is a significant increase in voluntary blood donation across the state. However, this momentum needs to be maintained with the active support from the general mass.

### **Goals and objectives:**

- To motivate people to donate blood voluntarily
- To create awareness in the society in science of blood and blood donation
- To make people aware of the Safe Blood Transfusion
- To conduct blood donation camps throughout the year for Government Blood Banks
- To organise training programmes for blood donor motivators
- To recruit new donors and create donors of tomorrow through motivational programs in schools, campuses and youth groups
- To publish posters, booklets to promote voluntary blood donation
- To help the Government and other regulatory bodies to frame policy / rules / regulations in relation to voluntary blood donation
- To propagate the message of optimum utilisation of blood amongst the blood users
- To create an atmosphere to make available blood to all in the state collected from non-remunerated voluntary blood donors.
- To co-ordinate and facilitate the relationship between voluntary blood donors and blood donor organizations thus promoting Blood Program in Nagaland.
- To create public awareness and disseminate information on voluntary blood donation and safe blood.
- To fight against the superstition and social taboos related to Blood Donation

## **P & AR INFORMS ON PIMS**

Personnel and Administrative Reforms Department (Personal Information Management Cell) in an office memorandum stated that the Personal Information Management System (PIMS) was inaugurated on 21<sup>st</sup> April 2016. It is a comprehensive web-enabled personnel management system for the State Government to address the administrative requirement for managing its employees right from the date of their joining into service till they retire. PIMS will help in getting instant access and accurate information about State Government employees including details of transfer and posting details and service history. Availability of timely information is the key to efficient management of service matters of State Government employees. Therefore, all Departments may adhere to the following instructions with regard to PIMS.

On the basis of the information supplied by the Departments, P&AR Department has made entries in the PIMS database and generated unique employee code for each employee. Details of existing employee in PIMS database should be updated continuously on daily basis, including details of service confirmation, posting, promotion, retirement etc., by the Departments.

In case of all appointments made after 15<sup>th</sup> April, 2016, a letter enclosing a copy of appointment order along with either post creation order or document showing vacancy against retirement, resignation, death etc., and filling up the 21 mandatory fields may-be submitted to the P&AR Department (PIMS Cell)-, for registering in the PIMS. P&AR Department will then generate a unique employee code.

All Departments should regularly participate in training & capacity building exercise conducted by P&AR Department for their Nodal Officer for PIMS and other officials involved with the PIMS.

## **BAN ON APPOINTMENT ON CONTRACT BASIS**

The State Government has laid down the revised procedures for appointments in Government service vide Office Memorandum No.AR-5/ASS0/98(C) dated 26.02.2001 laying down inter alia that all appointments shall be made strictly in accordance with existing rules/procedures in force, i.e., through the Nagaland Public Service Commission (NPSC) or through open advertisement or through Employment Exchanges. It has been made clear in the O.M. that as per existing rules in force, all ad-hoc/casual/temporary/work-charged appointments are banned. However, for the posts coming under the purview of the Nagaland Public Service Commission (NPSC), in the event of extreme urgency, a person could be appointed on contract basis (not ad-hoc/casual/temporary/work-charged etc.) after placing requisition to NPSC, prior clearance of NPSC and approval of the Cabinet. In the event of delay in recruitment through NPSC, the contract appointment could be extended beyond one year with prior clearance of NPSC and P&AR Department and approval of the Cabinet.

It has been observed that over the years, the pre-conditions for making appointments

on contract basis have not been adhered to in many cases, resulting in irregularities in such appointments and their extension. A consequence of irregular contract appointments is that the Government's policy for reservation of posts for backward tribes is not implemented properly. Another consequence is that such appointments, being discretionary in nature, violate the principle of equality of opportunity. The Gauhati High Court, in W.P (C) 255(K) of 2011 filed by 29 unemployed Veterinary Science Graduates against State of Nagaland & others, pronounced a judgment on 14.11.2014 holding that the rules governing recruitment to public posts and offices are required to be followed scrupulously. The Court held that appointments made without following appropriate procedure under the Rules holding the field and without inviting applications from open market would amount to infringement of Article 14 and 16 of the Constitution. The judgment was based on the Supreme Court's judgment in Uma Devi's case holding that appointments made without open advertisement were ultra vires of Article 14 and 16 of the Constitution.

In view of the position brought out above, and in modification of the P&AR Department's O.M. No. AR-5/ASSO/98(C) dated 26.02.2001, it has been decided that no appointment shall be made on contract basis, henceforth. In other words, appointment on contract basis is banned. Thus, a post coming within the purview of NPSC can be filled up only by appointing a candidate recommended by NPSC on the basis of open recruitment and it cannot be filled up, even temporarily, in any other manner. Any appointment made on contract basis, henceforth, shall be null and void. The Administrative Head of the Department and the Head of the Department concerned shall be responsible to ensure that no appointment is made on contract basis and disciplinary action will be initiated against them in case of any violation.

This has the approval of the Cabinet vide Memorandum No. CAB-2/2013 dated 12<sup>th</sup> May, 2016.

### **DIPR NOTIFIES ON PUBLICATION OF VIPS PHOTO**

The Department of Information and Public Relations in a notification stated that the Supreme Court has reviewed its judgement dated 13th May, 2015 passed in Writ Petition (C) Nos. 13/2003,197/2004 & 302/2012, as a result of the Review Petition (C) Nos. 1879-1881/2015 and has made the following changes to the extent indicated below:

- i. The exception in the aforesaid judgement dated 13th May 2015 permitting the publication of the photographs of the President, Prime Minister and Chief Justice of the country, subject to the said authorities themselves deciding the question, is now extended to the Governors and the Chief Ministers of the States.
- ii. In lieu of the photograph of the Prime Minister, the photograph of the Departmental (Cabinet) Minister/ Minister In-Charge of the concerned Ministry may be published, if so desired.

- iii. In the States, similarly, the photograph of the Departmental (Cabinet) Minister/ Minister In-charge in lieu of the photograph of the Chief Minister may be published, if so desired.
- iv. All other observations/directions in the aforesaid judgement dated 13th May,2015 shall continue to remain in force subject to the above modification.

All concerned are hereby directed to adhere / comply to the guidelines with immediate effect. This notification was issued in supercession of this Department's notification of even number dated 27th August, 2015.

### **P & AR DIRECTIVES FOR RECRUITMENT OF GRADE-III & IV**

Personnel and Administrative Reforms Department (Administrative Reforms Branch) in an office memorandum stated that in supercession of this Department's Office Memorandum of even number dated 16th November, 2015, the Governor of Nagaland is pleased to make the following provision for recruitment of Grade-III & IV posts in the District Offices with immediate effect.

1. All direct recruitment vacancies occurring in Grade-IV posts in the District Offices shall be filled up by the indigenous inhabitants of the respective District.
2. All direct recruitment vacancies occurring in Grade-III posts under the establishment of Deputy Commissioners in district administration shall be filled up by the indigenous inhabitants of the respective District. However, vacancies in Grade-III posts in other district offices, other than the district administration, will continue to be filled up by the respective Heads of Departments by following the normal recruitment policy of the State Government.
3. The Indigenous Inhabitant Certificate may be verified with the help of the latest census records to rule out possibility of multiple Indigenous Inhabitant Certificates in the name of the same person.
4. All vacancies in the above posts occurring in the Districts, excepting the Grade-III posts to be filled up by Heads of Departments, shall be filled up through open advertisement and a District Selection Committee shall be constituted by the respective Deputy Commissioners. The Selection Committee will be headed by the Deputy Commissioner and will include two District level Heads of Office, an Administrative Officer, and the Principal or Senior Lecturer of local College to be nominated by the Deputy Commissioner. The Committee shall follow the reservation policy for persons with disabilities in respect of Grade-III & IV posts, and the reservation policy for backward tribes in respect of Grade-III posts, except in the case of Dobashi posts. However, all appointment orders in respect of Grade-IV posts excepting those under the District Administration, will be issued by the respective Heads of Departments on the recommendation of the District Selection Committee.

## **OPENING OF ACCOUNTS UNDER PRADHAN MANTRI JAN DHAN YOJANA**

Finance Department in pursuance to the Ministry of Finance's direction has informed all beneficiaries of Direct Benefit Transfer Schemes in the State who have opened Basic Savings Bank Deposit Account (BSBDA) under Pradhan Mantri Jan Dhan Yojana (PMJDY) as per the guidelines of the Reserve Bank of India is provided with the following minimum common facilities to all customers:

1. The accounts shall not have the requirement of any minimum balance.
2. The services available in the account will include deposit and withdrawal of cash at bank branch as well as ATMs; receipt/credit of money through electronic payment channel or by means of deposit/collection of cheques drawn by Central/State Government agencies and departments;
3. While there will be no limit on number of deposits than can be made in a month, account holders will be allowed a maximum of four withdrawals in a month, including ATM withdrawals; and
4. Facility of ATM card or ATM-cum-Debit Card.

In case of those persons who do not have any of the 'officially valid documents' as stipulated by RBI can open "small accounts" with banks. A "Small Account" can be opened on the basis of a self attested photograph and putting her/his signature or thumb print in the presence of an official of the bank. Such accounts have limitation regarding the aggregate credits (not more than Rupees one lakh in a year), aggregate withdrawals (not more than Rupees ten thousand in a month) and balance in the accounts (not more than Rupees fifty thousand at any point of time). These small accounts would be valid normally for a period of twelve months. Thereafter, such accounts would be allowed to continue for a further period of twelve more months, if the account holder provides a document showing that she/he has applied for any of the officially valid document within twelve months of opening the small account.

## **CHANGE IN EDUCATIONAL STANDARDS FOR RECRUITMENT INSOLDIER (GD) AND TRADESMEN CATEGORY IN THE ARMY**

With the development taking place in every field across the country and increase in sophistication of holding equipment profile of the Indian Army, it has been felt that matching education/technical know-how is mandatory for the future generation soldiers. Therefore the education standards for recruitment in the Indian Army for Soldier GD and Tradesmen have been changed including the category candidates hailing from backward areas like Scheduled Tribes etc from existing 8th class to 10th class. For all future recruitment rallies in Nagaland and Manipur, minimum educational qualification requirement for recruitment have therefore been revised by the Army as under:-

There is no change in respect of remaining categories.

## **DEPARTMENT OF AGRICULTURE INFORMS ON CHANGE OF OFFICIAL e-MAIL ID**

The Department of Agriculture, Nagaland has informed that the Department has migrated its official email ID from agrilan@rediffmail.com to their new email ID agrilan-ngl@gov.in. This change has been made as per the email policy of the Government of India 2014.

All official correspondences to the Department of Agriculture, Nagaland that is routed through email should be done through the new email ID. This was issued in a circular by Director Agriculture, D. Suokhrie.

## **PAPER NAGAR POST OFFICE RENAMED TZUDIKONG**

The Director of Postal Services Nagaland, R.M. Patel has conveyed the approval to the competent authority that the 'PAPER NAGAR' Post office is being renamed as 'TZUDIKONG' in account with Kohima Head Post Office, Nagaland Division with immediate effect.

## **ADHERANCE TO NEW ADVERTISEMENT POLICY**

Government of Nagaland has notified its new advertisement policy 2015 w.e.f 15th October. Consequent upon the policy, a single window channel for release of government advertisement and payment of such bills have been entrusted to DIPR; except for the CSS and Flagship Programmes. Government departments and editors of Newspapers are therefore requested to take cognizance of the policy. The department of IPR shall make payments to only those advertisement released through DIPR.

# State Round Up

## STATE CELEBRATES SECOND ANNIVERSARY OF NDA GOVERNMENT

The Democratic Alliance of Nagaland (DAN) government celebrated the completion of two year governance of the National Democratic Alliance (NDA) led by Prime Minister, Narendra Modi at the Multi Purpose Hall B, Indira Gandhi Stadium, Kohima on 2nd June, 2016. Union Minister for Law & Justice, D.V. Sadananda Gowda, Minister of State for Panchayati Raj, Nihalchand Meghwal and National Vice-President, BJP, Vinay Sahasrabudhe graced the celebration. Chief Minister, T.R. Zeliang and a host of Ministers and Parliamentary Secretaries took part in the celebration.

Union Minister, D.V. Sadananda in his speech highlighted the achievements of

NDA government made during the last two years. He mentioned that the Prime Minister Narendra Modi believes in governance at the grass root level and personally directs the ministers to go to the people interact and understand the needs and get suggestions from them.

He also said the NDA government under Modi has taken the initiative to bring transparency, financial accountability and financial inclusion, social security among others. The Union Minister mentioned that the measures such as bringing back black money stashed in foreign banks, direct transfer of financial benefits to the bank accounts of the people and affordable insurance to the poorest citizens etc. were introduced during the last two years.

Vice President, BJP, V. Sahasrabudhe, who also authored a book on Nagaland,

claimed that no scandal or corruption case was charged against any Minister within the two year rule of the NDA government. He also said that unlike the previous Congress government, the NDA government has given sufficient funds to the DONER. He also added that the government goes to the districts of the North Eastern states, unlike other times.

Chief Minister, T.R. Zeliang said that the NDA government has introduced many path-breaking reforms during the two year rule such as the introduction of Make in India, Skill India, Digital India, Swachh Bharat etc. most of which were brainchild of the Prime Minister. He expressed hope that the BJP and its NDA allies in the North East region would work out a strategy of cooperation and adjustment through the newly formed North East Democratic Alliance (NEDA)

Taking the example of the Framework Agreement of 3rd August, 2015, Zeliang lauded the Prime Minister for sincerely taking bold and positive steps to resolve the Naga Political issue through peaceful means.

Chairman, DAN & President, NPF, Dr. Shurhozelie in his address highlighted the genesis of DAN government. He said that NPF was the oldest political party in the North East India which was established in October 1963. He added that the association with the BJP was not a new one.

Shurhozelie mentioned that the Naga Political problem was distinct which called for the political approach for its solution. He expressed happiness over the determination shown by the Prime Minister to solve the problem during his time.

Minister of State for Panchayati Raj, Nihalchand Meghwal also addressed the gathering. The function was chaired by Vice-Chairman, DAN & State President,

BJP, Visasolie Lhoungu. MP, Rajya Sabha & Secretary General, K.G. Kenye said the welcome address. Minister for Transport & Civil Aviation & IT, P. Paiwang Konyak said the vote of thanks.

## **UNION MINISTERS INTERACT WITH MEDIA**

Addressing a press conference at Raj Bhavan on 3rd June 2016, the Union Minister for Law & Justice, D.V. Sadananda Gowda and Minister of State for Panchayati Raj and BJP National Vice President Vinay Sahasrabudhe said that the present government led by our visionary and dynamic leader, Narendra Modi has been touring to all nook and corner of the country since its formation. He said the main motive of touring to different parts of the country and get interacted with various sections of the people was to know how far the new initiatives introduced by the present government have been percolating down to the lowest stratum of the society so that no one is deprived of their rights. At the same time, to know their problems and grievances and also to take note of their suggestions if there is ways and means to be taken into consideration.

Chotisuh Sazo, Speaker, Nagaland Legislative Assembly accompanied by Imtikumzuk, Deputy Speaker and a team of officers from Nagaland Legislative Assembly attended the 15th North East Region Commonwealth Parliamentary Association Conference at Agartala, Tripura from 30th May to 2nd June 2016. Sumitra Mahajan, Speaker, Lok Sabha inaugurated the Conference. In the Conference, various issues confronted by States in the Region were discussed. Besides that two vital topics (1) To Strengthen the NERCPA for Further Development of North East Region States and (2) Soil Erosion in North East India and its Impact on the Local Populace and how

Political Intervention could help resolve the issues were deliberated. Chotisuh Sazo, Speaker took active part in the discussion and suggested that NERCPA appeal to the Government of India to implement suitable policies and programmes for the development of the North Eastern States.

Vandanshan Lotha along with all the officers and staff from the Directorate, Regional Employment Exchange, Kohima & Govt. Industrial Training Institute, Kohima.

## **NAGALAND VISION 2030 LAUNCHED**

Nagaland Government 'Vision 2030' Document and website was launched by Parliamentary Secretary for Planning & Coordination, Evaluation & Monitoring Cell & Taxes, Neiba Kronu on 6th June 2016 at Chief Secretary's Conference Hall, Kohima.

The Government of Nagaland has decided to bring out a Vision 2030 Document with a perspective, or roughly in the context of the next 15 years for the purpose of guiding the planning and development process of the state. This exercise is to be completed by the 31st of July 2016.

An expert group of Secretaries has been set up with Alemtemshi Jamir, Retired Chief Secretary as the Convenor. Besides this a dedicated team and a small functional Secretariat is being established whose temporary operations centre will be located in the Capital Convention Centre. An Economic Consultant, namely Dr. Manoj Pant of the JNU has also been appointed to assist in guiding the Vision Document.

This vision document shall be an inclusive document involving the people and not based on only the views of the government departments. It has therefore, been decided to solicit views from all sections of the society and also from interested persons. Accordingly, while correspondences are being initiated to the civil societies, tribal organizations, academic institutions, development NGOs and the churches, it has also been decided to establish appropriate platforms for the members of the public to participate in the process by providing their valuable ideas and contributing to the process of evolving a vision for the state.

To prepare a document that envisioned a sustainable, progressive and viable Nagaland a suggested template was given. The suggested nature of the sub missions are:

- It should be a simple and understandable
- It should lay down the perspectives of what Nagaland can be within the time frame of 2030
- It should outline the short term (3 years) mid-term (next 7 years) and long term (15 years) perspectives and action plans to achieve such perceived goal
- It should address issues and work out a plan of action to tackle them. For example, IT can covers ideas like:
  - Evolution of an economy in the state or formation of a major driving economics activity covering issues such as production and productivity, services, trade and commerce and so on.
  - Designing an economic development model of Nagaland including designing the infrastructure that will create the enabling

environment for achieving and sustaining the perceived economy of the state.

- Addressing regional disparities especially pertaining to areas like the eastern Nagaland areas and bringing about equitable development in the state.

- Human development issues with emphasis on youth employment and gender-both urban and rural.

- Spread of urbanization and addressing related concerns of urban development especially pertaining to livelihood, living environment and sustainability of the urban inhabitations.

- The ecology and environment and sustainable development of Nagaland.

- Funds, Finance and resources from an integral part of any vision and the document has to focus on how the revenues of the state can be supplemented through internal generation. It should also focus on the best approaches for the judicious harnessing of our human and natural resources to achieve the vision. Natural resources would include aspects like oil, coal, limestone, water, forest etc.
- Any vision for Nagaland has also to be in consonance with the policies of the GoI and take into account the quantum of financial support that can be extended by GoI including the process of devolution of funds to the states. It should also cover the various aspects of the CSS and Central Government policies. It also needs to keep in mind the implementation of the 'Look/Act East Policy' NE vision 2020, the BBIM (Bangladesh Bhutan India &

Myanmar) and IMT (India Myanmar Thailand) Agreements.

- Side by side the projections should also take into account the global economic scenario including investments in the state through multilateral and bilateral agencies, EAP as also FDI and private investment.
- Suggestions for the vision could include views on the governance issues of the state with a focus on democratization, decentralization and participatory approaches to development that will enhance transparency and accountability. In this, views on VDBs, communitisation and urban bodies will be vital.

Target for blood collection 2014-15 was 11000 and 2015-16 is 10000 and number of camps for 2014-15 target was 57 and 2015-16 is 71.

A weeklong Workshop on “Participatory Springshed Development” and “Field Training” for the Officials and Staff of the Land Resources Department (LRD), Government of Nagaland has been successfully conducted at Ziphenyu, Tseminyu Block from 30th May to 4th June, 2016.

The Workshop has been conducted by Dehradun based People’s Science Institute (PSI). The Resource persons from the PSI were Research Assistant, i/c of NE, Awi Tsuhas, Geologist, Vergish, Geologist, Sreedip and Research Assistant, Ankit Saxena.

As culmination of the weeklong Workshop and Training, a Valedictory Function was held at the Conference Hall of LRD, Kohima on June 14, 2016 with Secretary, LRD, Y. Kikheto Sema, IAS as the chief guest.

Speaking at the function, the chief guest said that the kind of training given to

their staff even by going to the fields in all the eleven districts of Nagaland would go a long way in changing the face of the rural people. “It will definitely uplift the economy of the rural people and their standard of living.” he added.

The Secretary said their field visits for testing groundwater, geology and types and characteristics of Himalayan rocks, hydro geological mapping, discharge and water quality with the communities taking part showed huge positive outcome. He also expressed his satisfaction on the Power Point Presentations by officials and staff as the outcome of their field visits to the eleven districts of the State.

Kikheto Sema also reminded that we have so many springs in all the villages of the State. “Some are used while many are not used nor identified.” He stressed the urgency to create awareness to “preserve our springs, rivers, streams.”

He expressed his happiness that such Workshop and Training under PSI was first of its kind in the State. He also disclosed

that it was also the first time that such Workshop and Training was organized by the Department without getting any fund either from the Government of India or the Government of Nagaland. "Yet, we could organize it and our concern is less money, more concern on the community-based developments," he said.

The Secretary also said LRD did not have much budget. Their staff – regular, casual and fix pay ones - in Nagaland are less than 200 and they consume less than Rs 6 crore in a year. It comes less than 0.13% of the total salary of the Government employees in the State. And the Annual Approved Plan for the Land Resource Department is Rs 264 crore but allocation is just Rs 28.20 crore. Out of this, about Rs 10 crore would be spent on salaries of the employees and honorarium for about 540 employees of the Project Management Team, he added.

Earlier, Director, LRD, Mathung Yanthan, presented Keynote Address. He said such Workshop and Training would transform the facade of the people on the rural areas. He also said PSI was their partner in the training and it would go a long way and further disclosed that after that training, they would approach the right authority for funding.

Research Assistant, PSI, incharge of NE, Awi Tshuhah gave the background of the Springshed Management Development and how they had conducted the workshop. Additional Director, Hoto Yeptho delivered the vote of thanks.

1. 2. The House entrusts the Parliamentary Working Committee along with all elected members of the Legislative Assembly including 2 MPs, under the leadership of the Honourable Speaker of the Assembly and the Chief Minister, to go to Delhi and put pressure on the Central leadership for an early solution and also to find out the latest developments taking place in the negotiations between the Government of India and the NSCN(IM);

3. The House also appeals to the Forum for Naga Reconciliation (FNR) and the Political Affairs Committee (PAC) to be more pro-active in bridging the gaps between the different political groups so that they can contribute towards solving the Naga Political problem at this crucial juncture.

This was issued in a press release by Commissioner & Secretary, NLA, N. Benjamin Newmai.

## **T.R. ZELIANG LAUNCHES NFSA 2013**

Chief Minister Nagaland T.R. Zeliang on Monday 27th June 2013 launched the much awaited National Food Security Act (NFSA) 2013 at the Directorate of Food and Civil Supplies Dimapur.

Launching the NFSA, Zeliang informed that the main reason for delay in implementing NFSA in NAGALAND was due to tug of war between Government of India and Government of Nagaland on the issue of transporting foodgrains from FCI to the destination. He further informed that the transportation costs comes to around 12 crores where resource crunch state like Nagaland was not in a position to bear the costs and therefore wrote to the GOI for transport subsidy. Towards this the GOI gave a negative reply and finally suggested for 50:50 but when the state government explained it's inability, GOI understood the position and agreed to share the transport cost on 75:25 basis, Zeliang stated. There was no option left but to agree to that so after that agreement the food and civil supplies department with the cooperation of GBs, Village Councils and district administration worked on war footing and finally the scheme could be launched today the chief minister maintained. Informing about the many criteria relating to NFSA Zeliang urged upon the officers to be mentally prepared to meet the challenges

ahead of them while implementing the new system. He also dwelt on transparency at all levels while implementing the scheme.

Zeliang also announced about the decision of the government where the eldest woman in the household who is not less than 18 years of age will be the head of ration card because of the fact that women manages the kitchen and termed the Act as significant. Emphasizing on the importance of Aadhar number seeding with the ration card in the present system for identifying genuine beneficiaries, the chief minister reminded that unless the authorized ration card holder comes personally, ration would not be delivered and appealed to the people of Nagaland to go for Aadhar card remuneration. He further called upon all the stakeholders to take up the mission seriously for the benefit of the people.

Director F&CS, Alun Hangsing informed that although NFSA was passed by the Parliament and adopted in the year 2013, NAGALAND could not see the light of the day due to the funding pattern. He lauded the CM Nagaland also incharge of F&CS department who on realising the importance of the Act devotedly initiated for implementation of the Act by mobilising departments from top to bottom and because of which the scheme could finally be launched in Nagaland and would benefit a large number of population. He informed that both Above Poverty Line (APL) and Below Poverty Line (BPL) have been amalgamated under the name of Priority Household as per the Act and together with Antyodaya Anna Yojana AAY, the department would cover 14,05,956 beneficiaries.

The function was chaired by Secretary F&CS, Ramongo Lotha. Joint Director F&CS, proposed the vote of thanks.

With the launching of digital Cable T.V in Mokokchung town it would enable efficient utilization of the spectrum bandwidth available on the Cable and thereby drastically enhanced the capacity to carry channels on cable. It also brings in transparency as the signals of the cable operator are encrypted and can be received only through a Set Top Box (STB) after authorization from the service provider. The Digital cable T.V and internet Broadband service in Mokokchung Town has become a reality following collaboration between Symbiosis Private Ltd, Global Chapter, Dimapur and Mokokchung Channel.

At the launching programme, I. Temsu Jamir, the owner of Mokokchung channel and local cable operator said, it was just a starter towards digital cable T.V in Mokokchung and expressed apprehension that there must be teething problems initially but optimistic of overcoming the hurdles through joint efforts of the Symbios, Global Chapter and Mokokchung Channel.

Delivering his key note address, Managing Director, Symbios Private Ltd, Mongkum Jamir said Symbios is the only broadband internet service provider other than BSNL in the state who have laid optic fiber cables for the purpose. He said Symbios is looking forward to make joint efforts in the IT fields for the welfare of the customers. The digital cable T.V and internet Broadband service was formally launched by Tsukti Lkr, President Mokokchung Chamber of Commerce &

Industry. The Mokokchung Channel presented a Set Top Box and Broadband internet Router to the Mokokchung Chamber of Commerce and Industry.

## WHAT TO DO DURING AN EARTHQUAKE

Stay as safe as possible during an earthquake. Be aware that some earthquakes are actually foreshocks and a larger earthquake might occur. Minimize your movements to a few steps that reach a nearby safe place and stay indoors until the shaking has stopped and you are sure exiting is safe.

### If indoors

- DROP to the ground; take COVER by getting under a sturdy table or other piece of furniture; and HOLD ON until the shaking stops. If there is no a table or desk near you, cover your face and head with your arms and crouch in an inside corner of the building.
- Protect yourself by staying under the lintel of an inner door, in the corner of a room, under a table or even under a bed.
- Stay away from glass, windows, outside doors and walls, and anything that could fall, (such as lighting fixtures or furniture).
- Stay in bed if you are there when the earthquake strikes. Hold on and protect your head with a pillow, unless you are under a heavy light fixture that could fall. In that case, move to the nearest safe place.
- Use a doorway for shelter only if it is in close proximity to you and if you know it is a strongly supported, load bearing doorway.
- Stay inside until the shaking stops and it is safe to go outside. Research has shown that most injuries occur when people inside buildings attempt to move to a different location inside the building or try to leave.
- Be aware that the electricity may go out or the sprinkler systems or fire alarms may turn on.

### If outdoors

- Do not move from where you are. However, move away from buildings, trees, streetlights, and utility wires.
- If you are in open space, stay there until the shaking stops. The greatest danger exists directly outside buildings; at exits; and alongside exterior walls. Most earthquake-related casualties result from collapsing walls, flying glass, and falling objects.

### If in a moving vehicle

- Stop as quickly as safety permits and stay in the vehicle. Avoid stopping near or under buildings, trees, overpasses, and utility wires.
- Proceed cautiously once the earthquake has stopped. Avoid roads, bridges, or ramps that might have been damaged by the earthquake.

### If trapped under debris

- Do not light a match.
- Do not move about or kick up dust.
- Cover your mouth with a handkerchief or clothing.
- Tap on a pipe or wall so rescuers can locate you. Use a whistle if one is available. Shout only as a last resort. Shouting can cause you to inhale dangerous amounts of dust.
