




FIRE HAZARDS AND ITS PRECAUTIONS DURING THE WINDY SEASON (ADIPR FEATURE)

BEFORE:

- Do not take illegal connections or tinker with power connections
- Review escape routes with your family
- Make sure windows are not nailed or permanently bolted
- Teach family members to stay low on the floor (where the air is safer) when escaping from a fire
- Clean out storage areas. Do not let trash such as old newspapers/magazines and polythene bags accumulate

FLAMMABLE ITEMS:

- Store flammable liquids in safe containers in well-ventilated storage areas
- Never smoke near flammable liquids
- Discard all rags or materials that have been soaked in flammable liquids after you have used them. Safely discard them outdoors in a metal container.
- The chimney should be at least three feet higher than the roof. Remove tree branches hanging above and around the chimney.

MATCHES AND SMOKING:

- Keep matches and lighters away from children, and, if possible, in a locked cabinet
- Never smoke in bed or when drowsy or medicated

ELECTRICAL WIRING:

- Have the electrical wiring in your residence checked by a certified electrician
- Inspect extension cords for frayed or exposed wires or loose plugs
- Make sure outlets have cover plates and no exposed wiring
- Make sure wiring does not run under rugs, over nails, or across high-footfall areas
- Do not overload extension cords or outlets.

DURING FIRE:

- If your clothes catch fire, you should stop, drop, and roll until the fire is extinguished. Running only makes the clothes burn faster
- While escaping from a burning house, it will help if you could cover yourself with a thick blanket
- Never use the palm of your hand or fingers to test for heat - burning those areas could impair your ability to escape a fire (for ladders and crawling)
- Crawl low under any smoke to your exit - heavy smoke and poisonous gases collect first along the ceiling
- Close doors behind you as you escape if you can to delay the spread of the fire
- Do not re-enter once you have escaped. Call the local fire department

AFTER FIRE:

- If you are with burn victims, or are a burn victim yourself, cool and cover burns to reduce chances of further injury or infection
- Go to the nearest medical doctor for help.

RIGHTS AND LEGAL PROVISIONS TO SAFEGUARD THE INTEREST OF WOMEN

The concept of rights and duties have progressed along with the growth of civilization. With the Declaration of Human Rights by the United Nations Organisation (UNO), it laid down standard code of Human Rights applicable to everyone, men and women regardless of race, caste, colour, sex, religion, language or place of birth. Since then, the UN has been at the center of a growing global movement for women's rights. This Declaration also greatly influenced the framing of the Indian Constitution.

The growing assertion of rights of women continues to coincide with the growing violence of all kinds against them. Women's issue highlights the deprivation and discrimination to which they are subjected to in all the societies. This deprivation is merely on the basis of sex cause by the division of male- female roles in the society.

In India, due to the low literacy rate of women, they are considered as one of the most backward in the world. Although Nagaland has 76.11% female literacy, the crimes committed against women go unreported due to ignorance of their legal rights and also due to the fear of social stigma. Though there are not many female foeticide cases in the State unlike other parts of the country, there is a notion that a girl is a liability and a boy an asset. Women have always been considered to be inferior to men by nature, but the societal setup downgraded them to lower status that gender discrimination is on the rise. Because of this discrimination, women have been deprived of basic education, health and child care as well as legal rights and freedoms.

Women play a vital role in the economy of the country as well as the State. Women's income in the poverty groups is critical for the household survival even though they are the worst suffered in these groups. Therefore, there is an urgent need for emphasis on women's access to economic resources like credit, loan, skill upgradation organisation etc.

The legal structure aims at providing basic minimum to women to live a life of dignity. Some progress, have to some extent, done away with social practices which directly challenge the dignity of women. In other cases, laws do exist but social practices attacking the dignity of women also still persist.

The offence against women in the society can be broadly classified as under:

SEXUAL HARASSMENT

- Asking for/or demanding sexual favours
- Making comments with sexual overtones
- Insulting publicly by saying something demeaning /humiliating
- Making obscene remarks, cracking obscene jokes and singing obscene songs

- Talking with unnecessary touching, brushing against another's body
- Leering or staring at another's body, and/or sexually suggestive gesturing sexual harassment at workplace
- Display of pornographic material or sexual explicit written material such as pin ups, cartoons, graffiti, or catalogues of sexual nature
- Sexual assault, stalking
- Gender stereotyping.

What you can do:

- Seek assistance from NGOs associated with women's right.
- Register First Information Report (FIR) under Section 154 of the Criminal Procedure Code (Cr.P.C) before any police station.
- If it is in a work place, report to a superior officer
- A sexually harassed victim can also file a Writ Petition under Article 32 in the Supreme Court and under Article 226 in the High Court declaring that her fundamental rights have been violated and ask for compensation.

Where an aggrieved woman institutes any suit or legal proceedings in a civil court in respect of an act of sexual harassment which is unlawful, no court fees will be payable by the woman.

It may be:

- An act, omission, commission or conduct that leads to physical, verbal, psychological, emotional, sexual and financial abuse
- An act or omission that hurts or degrades a woman by the husband/male partner, relative and other family members who are living together in a common space or shared household.

REMEDIES AVAILABLE UNDER THE PROTECTION OF WOMEN FROM DOMESTIC VIOLENCE ACT, 2005.

- Protection order to stop violence immediately
- Residence order orders not to throw the woman out of the home, alternate place to reside, orders to restrain the abuser from entering the home of the woman
- Monetary relief payments for basic needs
- Custody order and secured access of woman to her children
- Compensation order for medical and other required services
- Restraining order to prevent violence at home and workplace.

What you can do:

Seek protection from any of the following Protection Officers:

1. Officer of the State Government not "below the rank of Block Development Officer
2. Representative of NGO
3. Representative of any registered service providers such as voluntary association or a registered company

If the Protection Officer refuses to help you, you can make a complaint to the Magistrate. The Protection Officer can be punished with 1 (one) year imprisonment and/or fine up to Rs. 20,000/-

RAPE:

Rape is the most common physical offence faced by woman. Here, the Penal law is very stringent as provided under Section 376 IPC, the punishment is not less than 7(seven) years to life imprisonment Section 375 IPC: Under this Section a man is said to commit 'rape' with a woman under the following six circumstances :

- Sexual intercourse against the victim's will.
- Without the victim's consent
- With her consent, when her consent has been obtained, "by putting her or any person in whom she is interested in fear of death or of hurt.
- With her consent, when the man knows that he is not her husband.
- With her consent, when at the time of giving such consent, by reason of unsoundness of mind or intoxication, or unsoundness of mind and does not understand the nature and consequences of that to which she gives consent.
- With or without her consent, when she is under 16 years of age.

What should a woman do when raped?

- File a First Information Report (FIR) to the police station. FIR should mention in detail, all the happenings either in written or in verbal to the police.
- All material evidences such as semen, blood, pubic hair, cloths worn at the time of crime should be submitted to the police to prove the case and for serological and DNA test
- Before washing up, she should go to the doctor for check up and medical proof.

UNDER INDIAN PENAL CODE (IPC) STRINGENT PUNISHMENT ARE BEING PROVIDED IF A PERSON IS FOUND GUILTY FOR COMMITTING AN OFFENCE AGAINST WOMEN, SUCHAS:

SOME OTHER IMPORTANT RIGHTS FOR WOMEN:

1. Rights at the time of arrest

- No woman shall be arrested after sunset and before sunrise except in exceptional circumstances and that too after obtaining the prior permission of the Judicial Magistrate.
- A woman police constable must be present when arrested and you can be searched only by another woman
- You have the right to know the ground of arrest and the particulars of the offence- the police cannot arrest anybody without disclosing the grounds of arrest.
- You have the right to inform your relatives or friends of the arrest.
- During interrogation by the police, your lawyer can remain present
- While in custody, you have the right to meet your lawyer

FREE LEGAL AID

Free Legal Aid is provided to ensure that opportunities for justice are not denied to any citizen by reason of economic or other disabilities.

Legal Services includes rendering of any services in the conduct of any case or other legal proceedings before any court and giving of advice on any legal matter.

- If you are poor, you have a fundamental right to be defended by a lawyer at the cost of the State.
- If you are an ST/SC or a woman you have a right to Free Legal Aid.
- To avail Free Legal Aid you need to produce an affidavit which proves that your annual income is below Rs. 50,000/- (Fifty thousand) only.
- You have to write an application to the respective District & Sessions Judges or Member Secretary, State Legal Services Authority, Nagaland to avail Free Legal Aid.

OFFICIAL ORDERS AND NOTIFICATIONS

FINANCE DEPARTMENT NOTIFIES ON GST

The Finance Department (Revenue Branch) in a notification informed that in exercise of the powers conferred by clause (g) of Sub-rule (2) of Rule 89 of the Nagaland Goods and Services Tax Rules, 2017, read with notification F.NO.FIN/REV - 3/GST/1/08 (Pt-1)/52 dated 26th October 2017, the State Government has notified the following, as detailed in column (2) of the table below, as evidences which are required to be produced by the supplier of deemed export supplies for claiming refund, namely:-

Sl. No.	Evidence
(1)	(2)
1	Acknowledgment by the jurisdictional Tax Officer of the Advance Authorisation holder or Export Promotion Capital Goods Authorisation holder, as the case may be, that the said deemed export supplies have been received by the said Advance Authorisation or Export Promotion Capital Goods Authorisation holder, or a copy of the tax invoice under which such supplies have been made by the supplier, duly signed by the recipient Export Oriented Unit that said deemed export supplies have been received by it.
2	An undertaking by the recipient of deemed export supplies that no input tax credit on such supplies has been availed of by him.
3	An undertaking by the recipient of deemed export supplies that he shall not claim the refund in respect of such supplies and the supplier may claim the refund.

LABOUR DEPARTMENT NOTIFIES

In exercise of the power conferred under Section 6 of the Payment of Wages (Amendment) Ordinance, 2016, the Government has declared the following establishments as industrial or other establishment wherein the employer shall pay to every person employed, their due wages only by cheque or by crediting the wages in his bank account.

The list of Industrial or other establishments are:

(1) Factories (2) Hotels & Restaurants (3) Bakeries & Confectionaries (4) Shopping Malls (5) Print Media (6) Automobile Workshops & Showrooms (7) Private Institutions (8) Private Hospitals & Nursing Homes (9) Contractors Establishments (10) Petroleum/Diesel Pumps (11) LPG Agencies (12) Local Authority.

In another notification, in exercise of the power conferred under Section 1 (5) of the

Payment of Wages Act, 1936, read with sub-clause (h) of clause (ii) under Section 2 of the Act (Central Act No. 4 of 1936), the Government has declared the following establishments as industrial or other establishments for the purpose of the said sub-clause with immediate effect:

(1) Factories (2) Hotels & Restaurants (3) Bakeries & Confectionaries (4) Shopping Malls (5) Print Media (6) Automobile Workshops & Showrooms (7) Private Institutions (8) Private Hospitals & Nursing Homes (9) Contractors Establishments (10) Petroleum/Diesel Pumps (11) LPG Agencies (12) Local Authority.

TRANSPORT COMMISSIONER NOTIFIES

In supersession of the "Public Notice" issued vide No.TC-23/MV/2007(PT-I)/1077- 88 dated 01/08/2014, wherein holders of non-digitized/booklet form of Driving Licenses had been directed to digitize their licenses in the National Application "SARATHI." Holders of non-digitized format of Registration Certificates or Driving Licenses are given a moratorium period for digitizing both vehicle Registration Certificates and Driving Licenses on or before 30/04/2018, failing which, the Registration Certificates or Driving Licenses shall be nullified.

All non-digitized Registration Certificates and Driving Licenses digitized till date shall also be treated valid for all legal considerations.

This is in accordance to the observations made by the Supreme Court Committee on Road Safety in item No.11 of its letter No.23/CoRS/2014 dated 28/09/2017 and as per the directive of the Government vide TPT/MV/20/2017(PT-I) dated 20/11/2017.

GOVERNMENT NOTIFIES SCRAP RATE OF CONDEMNED VEHICLES, MACHINERIES & UNSERVICEABLE MATERIALS

Transport Department in a notification on 30th January 2018 has informed of the partial modification of the Department's Notification No. TPT/SPL-5/1/2012 (Pt-I) dated 14th March 2012, on scrap rate of condemned vehicles, machineries and unserviceable materials. As per the notification, the scrap rate of condemned vehicles, machineries and unserviceable materials has been fixed at Rs. 15.00p per kilogram with immediate effect. The notification has been issued with the concurrence of the Finance Department vide RFC No.256 dated 15th November 2017.

RBI APPROVES CONVERSION OF SBI AGHUNATO TO BANKING TREASURY

Fulfilling the hope and long expectation of the people, the Reserve Bank of India has finally accorded permission to SBI, Aghunato Branch to conduct State Government's business (converting Aghunato NBST to Banking Treasury) vide letter No.BD (Guwa) 570 /11.02.008 /2017-18 dated 20/11/2017.

Accordingly, the Principal Director, Treasuries and Accounts, K. Tiayanger Tzudir has requested Assistant General Manager (AGM), SBI Regional Business Office, Mokokchung, to direct SBI, Aghunato Branch to promptly take over the State Government's business.

COMMISSIONER OF STATE TAXES NOTIFIES

In exercise of the powers conferred by clause (d) Sub-rule 14 of Rule 138 of the Nagaland Goods and Services Tax Rules, 2017 (herein after referred to as the "said rules") the Commissioner of State Taxes, Nagaland, Dimapur hereby notify the 1st day of June 2018 for intra-state movement of goods (movement of goods which commences and terminates within the State). Provisions of Rules 138 of the said rules relating to furnishing of information prior to commencement of intra-state movement of goods within the State of Nagaland and generation of e-way bill for such movement of goods will apply on and from, the 1st day of June 2018, for all taxable goods of any value. No e-way bill under Rule 138 shall be required to be generated on intra-state movement of goods within the State of Nagaland till the 31st day of May 2018.

E-way bill can be generated from the common Goods and Services Tax Electronic Portal www.ewaybillgst.gov.in before commencement of movement of goods.

He also informed that the Nagaland Heritage Studies Text Books series have been compiled in a standardized curriculum.

help in preserving the local dialects of the State. REPORT ON NATIONAL ACHIEVEMENT SURVEY (NAS) CLASS X – CYCLE 2

The Ministry of Human Resources Development (MHRD) conducted National Achievement Survey (NAS) for Class X Cycle-2 through National Council of Educational Research and Training (NCERT). Through National Achievement

Survey, it sought to gain an in-depth insight into the learning outcomes/levels of the students across varied geographies in the states so that the Government can design policies and action plans accordingly for improvement in the quality of education. The major objectives of this Project Survey are:

- To study the achievement levels of students of Class X in four subjects i.e. English, Mathematics, Science and Social Sciences.
- To study the difference in achievement levels with regard to area, gender, social group, board and management of schools.
- To study the effect of intervening variables like students' home background, school and teacher etc. on achievement levels of students.

According to the Chairman, NBSE, Asano Sekhose, for the State of Nagaland, the Nagaland Board of School Education (NBSE) had been entrusted to conduct the Survey in 426 selected schools both from government and private institutions. The Survey was conducted on the Class X students in all the 11 districts of Nagaland. In Nagaland, the National Achievement Survey (NAS) Class X Cycle-2 was conducted on 5th February 2018 along with the rest of the country.

The District Education Officer and Sub-Divisional Education Officer from all the 11 districts of Nagaland were appointed as District Coordinator for their respective districts. Teachers from Primary and Elementary section were appointed as Field Investigators for a fair conduct of the Survey. A training program on the conduct of the National Achievement Survey 2018 was organized by the NBSE, Kohima for the District Coordinators on the 19th January 2018. Thereafter, the District Coordinators conducted trainings for the Field

Investigators in all the 11 districts.

With the support and cooperation of the State RMSA, the District Coordinators, Field Investigators, and the registered schools of the Board, both government and private, the Survey was conducted fairly and successfully throughout the State.

schemes and to help the targeted group.

A meeting with various bank officials from Kohima and Dimapur was called by Governor Acharya for the first time in Raj Bhavan where 16 banks in total attended the meeting. Principal Secretary to Governor, Piyush Goyal IAS welcomed the bank officials. The meeting was also attended by senior officers from the Governor's Secretariat.

ECI IS COMMITTED TO DELIVER FREE, FAIR & TRANSPARENT ELECTIONS: O. P. RAWAT

The Election Commission of India, on their two day visit to Nagaland, held a press conference at Japfü Hotel, Kohima on 15th February 2018.

Chief Election Commissioner, O. P. Rawat said that they met the representatives of various political parties to understand their issues and concerns besides noting their suggestions for holding free, fair and peaceful elections. Political parties besides requesting Observers to be more proactive in taking actions, also suggested on translating election related guidelines to local languages, he added.

There are 11.91 lakh electors in the State with 6.01 lakh male and 5.89 lakh female electors according to the final electoral roll published on 10th January 2018 with 1st January 2018 as the qualifying date, Rawat stated. The percentage of photo coverage in the electoral roll is 99.99% and EPIC coverage is 99.99%. Efforts are being

made for 100% PER and EPIC. 59 constituencies in the State are covered by ETPBS and all ROs have transmitted postal ballot to the service electors through ETPBS.

There are a total of 2194 (Main) and 2 (Auxiliary) Polling Stations at 2017 polling locations. Polling will be held in 2156 polling stations of 59 Assembly Constituencies of State. Rawat also apprised of the status of Assured Minimum Facilities of the polling stations.

EVMs with VVPAT machines will be used in all the 2156 polling stations of 59 Assembly Constituencies of the State. The Commission, Rawat stated, has directed that one polling station of each constituency be randomly selected and VVPAT slips of this polling station be counted and matched with EVM results.

Election Expenditure Monitoring Teams as per ECI instructions has also been constituted at all DEOs. Adequate number of Expenditure Observers (including expenditure sensitive constituencies) has been deployed by ECI for effective expenditure monitoring. Income Tax officials have been deployed for expenditure monitoring. 178 Flying Squads and 84 Static Surveillance Teams have been operationalized to check movement of cash liquor, drugs and other freebies in Nagaland. The vehicles used by flying squads has been fitted with GPS to track their movement and prompt action. 29 check posts of Excise Department has been working in the State to check the movement of liquor. Movement of money through banking channels is monitored and fool-proof arrangements

To ensure free and fair elections, web-casting will be done in all those sensitive polling stations where internet connection is feasible and rest will be covered by videography by fixed cameras and micro observers, the CEC stated. Providing the figures for the aforementioned, he said webcasting will be done at 555 polling stations, videography at 1601 polling stations and Micro Observers at 1010 polling stations.

have been made to monitor suspicious banking transactions. Air Intelligence units have been set up at the Agartala, Dimapur, Shillong, Imphal, Guwahati and Silchar airports.

A comprehensive, robust and reliable Public Grievance Redress System has been developed to provide a common platform for all complaints, grievances, concerns and suggestions lodged by any member of the public, including various stakeholders like political parties, candidates, civil society groups etc. A single window system has been deployed for giving election-related permissions/clearances within 24 hours. In this system, candidates and political parties can apply for permissions for meetings, rallies, vehicles, temporary election office, loudspeakers etc., at a single location, where back-end convergence of various authorities/departments has been done, Rawat informed. This system is put in place at every RO level in each sub-division, which will provide for applying, processing, granting and monitoring permissions in a synergistic manner.

The CEC also informed of the All Women Managed Polling Station to be set up in at least 25 assembly constituencies.

On accessible election, the CEC said the Commission has laid special emphasis on making the election process accessible for all sections of the electorate, especially the Persons with Disabilities (PwDs), aged and infirm electors etc. A data base of PwD voters has been created and such electors are enrolled and mapped with PS and the list has been provided to the BLOs for providing special assistance. Special facilities to PwD voters like wheel chair to the extent possible, waiting area, queue assistance, ramps, escort and braille ballot paper for easy readability by the visually impaired voters would be provided, he added.

The Commission, Rawat stated, has directed the State level and District level election machinery to be fearless, unbiased, neutral and independent from any influence to realize its committed to maintain purity of elections and to deliver free, fair and transparent elections.

She informed them that at HSLC Examination 2018, a total of 21,712 candidates will be sitting for the examination at 80 centres. For HSSLC Examination

2018, there are 15281 candidates who will appear at 54 centres.

Asano Sekhose also informed that two new centres for HSLC Examination has been created at Government Higher Secondary School, Longkhim and Government Higher Secondary School, Niuland. For HSSLC Examination, a new centre was also created at St. Paul Higher Secondary School, Dimapur. Class XI Promotion Examination, 2018 shall be held simultaneously with the HSSLC Examination, 2018 where a total of 17704 students have been enrolled to appear the Class XI Examination in 161 centres, she added.

Controller of Examinations, Rangumbing Nsarangbe dwelled on the rules for conduct of examinations. Issues to be taken into account pre, during and post examination were also discussed at length with the Centre Superintendents.

Senior Academic Officer, Iluheing Nsarangbe delivered the welcome address. Principal, Don Bosco Higher Secondary School, Wokha, Fr. T. T. Joseph pronounced the invocation prayer.

GENERAL ELECTIONS TO THE 13th NLA

KOHIMA:

The General Elections to the 13th Nagaland Legislative Assembly Constituency for 14 Southern Angami-1 Assembly Constituency was conducted on 27th February 2018 in a total of 20 polling stations with around 13 thousand voters. Four candidates Vikho-o Yhoshü NDPP, Khrielezo Bio NPF, Medokul Sophie NPP and Nagakul Tase INC contested from the 14 Southern Angami - 1 A/C.

Among the voters was Vilhelie Kere, 23 years old Person with Disability (PwDs) from Kigwema village who also exercised

his franchise. A villager who was present nearby to cast his vote narrated how Vilhelie despite his disability is a skilled carpenter and takes care of his parents and siblings.

The GHS Jakhama town in 14 Southern Angami-1 A/C was manned by all women presiding officials and security personnel. The purpose of having an all women team is to encourage women participation in the electoral process.

Video surveillance were fixed in all the polling stations and facilities like chairs, drinking water, waiting shed, toilets and wheel chairs for PwDs were also provided for the voters. Young, old and differently abled actively participated in the electoral process.

The 10 Northern Angami-1 Assembly Constituency had two all women polling stations at 20 Baptist Higher Secondary School and 21 GMS Keyake.

In the 9 Kohima Town Assembly Constituency, at URA College of Teacher's Education, D-Block Middle, two elderly people, Rhonthungo, 99 years (male) and Kehrino haralu, aged 80 (Female) cast their votes. In another polling station, one elderly female Neikuonuo from Naga Bazar upper cast her vote at the age of 90 plus knowing that she can change the future with her one vote.

MOKOKCHUNG:

Polling to the 13th Nagaland Legislative Assembly in Mokokchung district ended peacefully with no untoward incident in any of the polling conducted in the 226 polling stations. In some of the polling stations, polling was delayed due to

minor technical problems related to EVMs and VVPAT machines. However, timely rectification by the authority, the polling could be conducted smoothly.

As per the directives of the Election Commission of India, in all the polling stations, PwDs and elderly citizens were given priority in exercising their franchise. Sporadic disturbances was reported from some of the polling stations but were brought under control by the timely intervention of the Sector Officer/Magistrate and security personnel. By and large, the polling in Mokokchung district ended peacefully through the co-ordination and co-operation of District Administration, all officials, Village Councils, Ward Authorities and deployment of adequate security personnel.

WOKHA:

For the first time in Wokha district, one of the polling stations under 38 Wokha Assembly Constituency was manned by highly qualified and dedicated differently abled polling officials, who are working in different departments and banking institutions holding responsible jobs.

PEREN:

According to official reports, in 6 Tening Assembly Constituency, due to technical matter, the polling began late in some polling stations. Polling was by and large peaceful in all the polling stations.

The District Election Office of Peren informed the total voters turn out for two seats was 78.48 percent in a total of 124 polling stations.




SIGNATURE CAMPAIGN ON CLEAN ELECTION HELD AT TSEMINYU
