OFFICIAL ORDERS AND NOTIFICATIONS

NBSE NOTIFIES PAST HSLC & HSSLC EXAMINATION TOPPERS

The Nagaland Board of School Education (NBSE) has notified for information of all the students who passed their HSLC & HSSLC examination from NBSE and placed in Rank 1(one) as the topper from 1975 till 2021 (from 1975 for HSLC examination and from 1997 for HSSLC examination), to share their success stories and achievements by registering themselves in the Board's Portal at nbsenl.edu.in (Toppers Bio-data).

This initiative is taken to track and connect with the toppers of NBSE with an objective to let the achievers share their success stories to encourage and motivate the upcoming students. Therefore, NBSE has requested the toppers to log in to the Board's Portal and register themselves and share their experiences.

STATE GOVERNMENT INFORMS

The State Government has informed that in pursuance of the Gauhati High Court, Kohima Bench Order dated 01.09.2021 in PIL No 10/2021, the Personnel & Administrative Reforms Department's Office Memorandum No.AR-5/ASSO/98 (Vol-I) dated 16th July 2021 for partial lifting of appointments, shall remain suspended till further orders.

All the departments have been requested to take note and comply with the said Order.

STATE LEVEL ENVIRONMENT IMPACT ASSESSMENT AUTHORITY CONSTITUTED

In exercise of the powers conferred by Sub-Section (3) of Section 3 of the Environment Protection Act, 1986 and in pursuance of the notification dated 14th September 2006 of the erstwhile Ministry of Environment & Forests, the Central Government vide gazette notification dated 20th October 2020 has notified the constitution of State Level Environment Impact Assessment Authority (SEIAA) for Nagaland.

The Committee comprises of the following members, namely:

The Authority will function from the Office of the PCCF and HoFF, Environment, Forests & Climate Change, Upper Forest Colony, Kohima. The Authority shall exercise such powers and follow such procedures as specified in the above mentioned notification (as amended from time to time).

ACTION AGAINST PERSONS NOT WEARING MASKS IN PUBLIC PLACES

Many persons are being found not wearing masks in public places in violation of the directives issued by the Government for preventing the spread of COVID-19 in the State. As per Order NO.GAB-1/COM/GEN-4/2020 dated 12.11.2020 and Para E3 and Para J of Order NO.NSDMA-ER-COVID19-30I/2020(Part-II) dated 29.04.2021, action is to be taken against those found not wearing masks and a

penalty of Rs 200/- is to be imposed every time the offence is committed. The ASI and above level officers of Police, and Assistant Road Safety & Enforcement Inspector and above level officers of Transport Department are the enforcement agencies for the aforesaid provision.

All the District Task Forces have been directed to take urgent steps for ensuring enforcement of the directive for wearing masks in public places by the people, and for taking action against those violating in their respective jurisdictions.

Further, all the District Task Forces will submit daily reports to the State Level War Room on the number of persons found not wearing masks in public places by the enforcement agencies and the total fine collected from the violators.

GOVERNOR'S EXCELLENCE AWARD IN SCIENCE STUDY OF HSSLC EXAMINATION

Governor of Nagaland, R. N. Ravi has instituted an award to encourage the students of Nagaland to excel in the study of Basic Sciences. The award, known as 'Governor's Excellence Award in Science Study of HSSLC Examination,' will be given to the best 6 (six) students in science stream with the following subject combination:

- I. Physics, Chemistry & Mathematics (PCM) - 3 Awards
 - 1st – Rs. 1,00,000 (Rupees one lakh)
 - 2nd – Rs. 50,000 (Rupees fifty thousand)
 - 3rd – Rs. 25,000 (Rupees twenty-five thousand)
- II. Physics, Chemistry & Biology (PCB) - 3 Awards
 - 1st – Rs. 1,00,000 (Rupees one lakh)
 - 2nd – Rs. 50,000 (Rupees fifty thousand)
 - 3rd – Rs. 25,000 (Rupees twenty five thousand)

The following guidelines shall govern the 'Governor's Excellence Award in Science Study of HSSLC Examination:

1. The award will go to the best six (6) students in order of merit in the HSSLC Examination in science stream conducted by the Nagaland Board of School Education (NBSE) with Physics, Chemistry & Mathematics (PCM) subject combination – 3 (three) students and Physics, Chemistry & Biology (PCB) subject combination – 3 (three) students.
2. The award will carry a citation and cash prize.
3. Only students belonging to any Indigenous Scheduled Tribe of Nagaland as notified by the Government from time to time will be eligible for the award.
4. The students should secure 80% or more in their aggregate to avail the award.
5. The student's performance in PCM and PCB will determine the award in each category.
6. The best students in PCM and PCB combination will be selected in order of mark secured and it will be placed as 1st, 2nd and 3rd in each category i.e. students who have opted Mathematics as their main elective subject as PCM category, and students who have opted Biology as their main elective subject.
7. The candidate scoring the highest aggregate in Physics, Chemistry & Mathematics (PCM) or Physics, Chemistry & Biology (PCB) will be considered.
8. In case of tie in the marks and aggregate, whosoever secures higher marks in the external marks of PCM or PCB will be considered.
9. In case of another tie, the following norms shall be followed:
 - a. PCB: The marks of Chemistry to be considered first, followed by the marks of Biology,

- whichever is higher.
- b. PCM: The marks of Mathematics to be considered first, followed by the marks of Physics, whichever is higher.
10. In case of further tie, the award will be shared.

Celebrating 75 years of India's Independence – Azadi Ka Amrit Mahotsav, along with the rest of the country, the Nagaland Board of School Education (NBSE) has, so far, conducted the following activities with its registered institutions:

1. From 12th March 2021 to 12th April 2021 (Essay/Creative writing) Classes VIII to XII.
2. From 1st July 2021 to 31st July 2021. (Activity A) (Craft Making and Drawing Competition) Classes VIII to X.
3. From 1st August till 14th August 2021. (Activity B) (Essay writing) Class XII.

The winners of each category based on the entries and activities submitted by the students were announced on the occasion of Independence Day i.e. 15th August 2021. The winners, the list of participants and the best entries have also been made available in the Board's Portal (www.nbsenl.edu.in).

In continuation of the Azadi Ka Amrit Mahotsav celebrations, all the registered schools of the Board are reminded once again to undertake the following activities which were notified vide Notification No. 67/2021 dated Kohima the 27th August 2021:

1. Activity 'A' - Classes VIII to XII (1st September 2021 to 25th September 2021)
Essay/Poem writing/Drawing competition on the theme 'People who gave us the 75th year of India's Independence.'
Submission of best one (1) entry by the schools - 27th to 28th September 2021.
2. Activity 'B' - Classes X to XII (1st October 2021 to 25th October 2021)
Reading Comprehension Challenge.
Submission of best one (1) entry by the schools - 26th to 27th October 2021.
3. Activity 'C' - Class XII (1st November 2021 to 25th November 2021)
Essay/Poem writing/Drawing competition
Submission of best one (1) entry by the schools - 26th to 27th November 2021.

The above activities are to be conducted in virtual mode as per the timeline given and only the best one (1) entry is to be mailed in Word format to collessay21@gmail.com. Schools must write the name of the student, class and school clearly as any incomplete entry will be rejected.

FINANCE DEPARTMENT NOTIFIES

In exercise of the powers conferred by Section 128 of the Nagaland Goods and Services Tax Act, 2017 (4 of 2017) (hereafter in this notification referred to as the said Act), the Government, on the recommendations of the Council, and in supersession of notification of the Government of Nagaland, Finance Department (Revenue Branch) F.NO.FIN/REV- 3/GST/I /08(Pt-1)(Vol.II)/25 dated the 29th November 2020, except as respects things done or omitted to be done before such supersession, the State Government has waived the amount of penalty payable by any registered person under Section 125 of the said Act for non-compliance of the provisions of notification F.NO.FIN/REV-3/GST/I/08(Pt-1)(Vol.1)/66 dated the 21st March 2020, between the period from the 1st day of December 2020 to the 30th day of September 2021.

NBSE NOTIFIES

In pursuance of the Department of School Education & Literacy, Ministry of Education, Government of India letter D.O. 1-56/2021-DIGED dated 9th September 2021, the Nagaland Board of School Education (NBSE) has notified for information of all the Heads of Registered Institution under NBSE to be aware of the ill effects of online gaming addiction/ abuse among the students.

Online games can be found almost anywhere on any gaming platforms such as PCs, consoles and mobile devices. Online gaming can be accessed with the use of a phone or a tablet which is a common factor in online game addiction because children can easily play games anywhere and anytime, affecting their time for their school and social life. Moreover, the closure of schools due to the pandemic has increased use of mobile and internet by children.

Playing online games leads to a serious gaming addiction which has been considered as a gaming disorder. Playing online games without restrictions and self limit leads to addiction and are eventually diagnosed with gaming disorder.

Therefore, Heads of Institutions are requested to share the concerns and sensitize the parents and teachers about the harmful effects of online gaming.

NBSE ISSUES GUIDELINES

With the closure of schools from 30th April 2021 vide NO.NSDMA-ER-COVID19/301/2020 (Part-II) dated 29.4.2021 due to COVID-19 pandemic, schools were allowed to conduct classes through online mode w.e.f. 24th May 2021. However, it is observed that teachers, students and parents have faced challenges in adopting online teaching and learning due to various reasons such as digital divide and connectivity issues while trying to ensure effectiveness of online teaching.

In the backdrop of the above and as envisaged in the NEP 2020 where it speaks about transforming assessment to more regular and formative, the Nagaland Board of School Education (NBSE) has issued a revised assessment scheme for the conduct of Class VIII Examination 2021 (for government schools only) and Class IX Final Examinations 2021. All registered private schools shall also adopt this assessment pattern for Class VIII Examination 2021. The guidelines are given as below:

1. The two examinations shall be conducted in two phases (Phase I & Phase II).
2. The marks for each phase will be 50% of the total marks allotted for external examination for each subject.
3. The question paper will have all types/forms of questions as per the existing design of question paper of the Board.
4. The examinations will be of 90 minutes duration each.
5. The entire syllabus is divided into two (Subject-wise division of syllabus for Phase I & Phase II examinations are uploaded in the Board's portal).
6. The blueprint of the question papers will also be given out for each subject phase-wise later.
7. Question papers for each phase of examinations shall be made available in the Board's portal (www.nbsenl.edu.in) and schools shall download the question papers for each phase. Further details for downloading the question papers will be notified later.
8. The marks of Phase I & Phase II will be consolidated to prepare the final result of each student.
9. Schools shall carry out the internal assessment in all the subjects and record the marks for inclusion in the final results preparation.

10. The Phase I examination will be conducted in later part of October 2021 and Phase II examination will be conducted in December 2021. Detail routine and the time for submission of results will be given at a later date.
11. Depending on the situation, the mode for conduct of the two phase wise examinations will be made known to the schools.

Therefore, all the Heads of Registered Institutions of the Board have been informed to note the changes in the conduct of the said examinations of Class VIII and Class IX 2021, and instruct the teachers accordingly to follow the division of topics/chapters for each subject as given in the annexure. Students must be made aware of the changes in the examination pattern/scheme. Schools shall ensure that the given topics are covered and remedial teaching be taken up to ensure that students achieve the expected learning level.

DIPLOMA IN SCHOOL COUNSELLING COURSE INAUGURATED FOR 3rd BATCH

A programme for the inauguration of the 3rd batch of the 9-month diploma in school counselling was inaugurated at SIEMAT Hall, SCERT, Kohima on 2nd September 2021. The programme is sponsored by Samagra Shiksha, Nagaland.

Professor & Head, Guidance & Counselling Cell, SCERT, Dr. Zavise Rume said that guidance and counselling programme started only in the 1980s and gradually, it has become the most important cell for activities in SCERT. The proposal for upgrading the diploma course from 6 months to 9 months was approved in July 2017 and SCERT Nagaland was the first state in the whole country to approve school counselling in 2018. He said that every child will be required to go under counselling as it is an integral part of school education. Rume further said that the need for professional counselling is increasing in the present complexities of modern day lives, and every child is experiencing different kind of mental stress. Therefore, there is a need to focus on psychological, emotional and physiological well-being of children, and this programme will offer a hands-on skill based practical course which will ensure that the counselling practices will be integrated to the daily teaching learning process in schools.

Principal Director, School Education, Shanavas C, IAS in his inaugural speech, said that the pandemic has created a very tough time for

everyone especially the students. He said that it is an open fact that students from different kind of economic backgrounds usually study in government schools and they all go through a different kind of challenges. He also mentioned that adolescence is a very tricky phase where children at that age can be influenced into bad habits and whatever incidents that an adolescent faces in this phase stays with her/him throughout their life. Shanavas also said that counselling can help a lot of children especially in today's world where there are many students dealing with anxiety issues, depression and suicidal tendencies. He further said that when the teachers present go back to their respective schools, there will be a lot of expectations from them and they should lean to those expectations and asked them to be compassionate and passionate about counselling because they are dealing with children who are the future of the society.



He said that this year, the Government of India has allotted 60 seats for in-service government teachers to take up the diploma course. He further said that Samagra Shiksha mission's vision is that one day, the trained teachers will be deputed as full time counselling teachers in all the districts.

WRD SIGNS MoU WITH NINE SKILLED UNEMPLOYED WOMEN FOR PRODUCTION ACTIVITIES

Directorate of Women Resource Development, Government of Nagaland on 4th September 2021, signed a Memorandum of Understanding with nine skilled unemployed women for taking up collaborative programmes and production activities under Apparels & Accessories Programme of Transformative Livelihood Intervention Project of the Department for a period of two years on a 'Pay-Per-Production' basis on 3rd September 2021.

During the signing of the MoU at the Directorate, Director, Women Resource Development, Vilone Sakhrie mentioned that as part of Livelihood Intervention and Support programme of the Department, skilled unemployed women are being engaged for production works (tailoring, weaving and its related activities) initially for a period of six months purely on 'Pay-Per-Production' basis. He stated that engagement on Pay-Per-Production basis under this programme

started during 2019-20, where trainees from Multi Training Centres (MTCs) of the Department as well as other skilled unemployed women tailors and weavers were given the opportunity to enable sustainable livelihood as well as for enhancement of Myki apparels and accessories production output. Since then, every year, various skilled unemployed women individuals are being engaged in these activities.

Sakhrie further pointed out that provision was made for engagement of these skilled unemployed women for extending the period of their services through a MoU if their performance was found to be satisfactory and commendable after completing the initial period of six months. These women have been actively engaged in production of

three-layered face masks with the advent of COVID-19 pandemic in the State and subsequent lockdowns where production continued from their respective homes. This enabled the Department to produce a sizable quantity of face-masks, aprons and other products, most of which were donated to frontline workers, health workers and other local bodies engaged in combating the pandemic.

The Apparels & Accessories Programme of TLI Project continues to churn out a variety of products which are donated wherever necessary or otherwise sold at very reasonable prices, so that even the poorer section of the society can avail quality products. Moreover, it has also become a regular source of income for these women engaged in the activities.

STATE LEVEL TEACHERS' DAY CELEBRATION HELD

The State Level Teachers' Day celebration, organised by the Department of School Education, was held at the Directorate of School Education, Kohima on 5th September with Advisor, School Education, K. T. Sukhalu, IAS (Retd.) as the guest of honour.

Addressing the celebration, Sukhalu said that the Government make policies, but the implementation part lay with the teachers. He said that teachers are the builders of nations and

education being an ever changing aspect, both subject matter and the methods involved need constant upgradation. He called on the teachers to bring out the best of a child, adding that the current pandemic has given a clear picture as to how education needs to adapt with the change of time and the need to prepare to embrace such changes with time where inclusive education can create an inclusive society.

The Advisor mentioned that with the



introduction of the New Education Policy 2020, more changes are taking place rapidly and the primary level should be able to create a strong foundation where teachers are required to be able to nurture the potentialities of every student. He urged the teachers to not only emphasize on academic learning but also to emphasize on character building and added that to

have a better future, there is a need to introspect the role of educators in the society.

Advisor Sukhalu released the DoSE newsletter, which will be published quarterly on the role of the Education Department. Message on Teachers' Day from the Governor and Chief Minister of Nagaland were also read out.

The programme was attended by Union Minister for Education, Dharmendra Pradhan, Union Minister of State for Education, Annpurna

Devi and Secretary, Department of School Education & Literacy, Ministry of Education, Anita Karwal.

A total of 44 teachers from different states across the country were selected for the award of the prestigious national award and Swedesunuo Zao, Head Teacher, Government Middle School, Jakhama is one among them.

MINISTER NEIBA KRONU HIGHLIGHTS AGRI ACTIVITIES AT VIDEO CONFERENCE WITH 13 STATES

Minister for Planning & Coordination and Parliamentary Affairs, Neiba Kronu represented the Chief Minister and Minister for Agriculture, who are on tour, in the video conference meeting on the 7th September 2021 with the Union Minister for Agriculture & Farmers' Welfare, Narendra Singh Tomar. He was accompanied by Advisor, Horticulture, Mhathung Yanthan and Agriculture Production Commissioner, Y. Kikheto Sema, IAS.

The video conference meeting was attended by 13 States – Andhra Pradesh, Telangana, Tamil Nadu, Kerala, Karnataka, Assam, Arunachal Pradesh, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim and Tripura, represented by Chief Ministers, Agriculture Ministers and other officers. The topics for discussion during the meeting included Agriculture Infrastructure Fund (AIF), Pradhan Mantri Kisan Samman Nidhi (PM-KISAN), Digital Agriculture, National Mission on Oilseeds and Oil Palm (MNOOP).

Minister Neiba Kronu, speaking on behalf of the State of Nagaland, highlighted issues and

suggestions on the agenda that was discussed, as follows:

- 1. Agriculture Infrastructure Fund (AIF):** While thanking the Union Government for introducing such important scheme of Agriculture Infrastructure Fund (AIF), the progress of the AIF in the State has not been on expected lines as the lending institutions have been shying away from financing the farmers and entrepreneurs due to issues of collateral securities. Therefore, it was requested to the Union Government to help the State in creating more agriculture infrastructure in the State through Grant-in-Aids.
- 2. Pradhan Mantri Kisan Samman Nidhi (PM-KISAN):** He stated that as on 31st August 2021, a total of 2,00,082 farmers from Nagaland has been benefitted amounting to Rs. 265.52 crore transferred to their accounts.
- 3. Kissan Credit Card (KCC):** As on 30th June 2021, an amount of Rs. 223.54 crore have been extended to 35,959 KCC beneficiaries by the banks covering all districts.



4. **Digital Agriculture:** The State is yet to implement collection of digital database of land records because of the State's peculiar land-holding system. However, the Department of Agriculture and Soil & Water Conservation Department, along with GIS Cell of the State is working out to implement the same.
5. **National Mission on Oilseeds and Oil Palm (NMOOP):** The Department is implementing the scheme under NFSM (OS& OP) since 2014-15. So far, it has covered an area of about 4623 ha along the foothill areas of Mokokchung, Wokha, Mon, Dimapur, Peren and Longleng. The Department has targeted area coverage of 1100 ha during 2021-2022. The State Government is targeting only 15,000 Ha of wastelands for oil palm cultivation. This decision was taken on the basis of actual availability of the cultivable areas. They have also been asked to set up Oil Extraction Mill by August 2022.
5. **Export of agriculture products:** Despite the pandemic, the Agri and Allied departments organised several meetings, workshop and on 15th March 2021, a major consultative and buyer-seller

meet in partnership with APEDA was organized at Dimapur which was attended by the experts from within and outside the State.

Under the umbrella of Nagaland State Agriculture Marketing Board (NSAMB), market channels are opening up for export of local products to the metro cities under the brand name of "Naturally Nagaland." For the first time, Naga King Chilli was exported to London on the 29th July 2021. The others niche products such as Bamboo-shoot, Pineapple, Kiwi, Cardamom, Ginger, Sweet & Juicy Cucumber, Tree Tomatoes etc. are in the pipeline for export. However, Kronu stated the challenges of huge cost of transportation both inside and outside the State.

Minister Kronu further stated that the Naga Coffee which is one of the best quality is the first agriculture product that has been exported for the last few years to the international market. So far, about 10,000 ha of coffee have been planted and the State is targeting that by 2030, about 30,000 ha would be covered throughout the length and breadth of the State. Rubber is also one of the commercial crops exported to other states.

SPUNER ACTIVITIES HIGHLIGHTED AT VIDEO CONFERENCE

A meeting via video conference mode was held under the chairpersonship of Hibu Tamang, IPS Additional Commissioner Police, Special Police Unit of North-Eastern Region (SPUNER) Delhi Police.

The Commissioner Police, SPUNER thanked the officials from all the Bhawans for acting proactively to provide help to the North-Eastern people landing in Delhi for different purpose as well as for the good coordination between SPUNER and State Bhawans during present pandemic. He also informed the Board that a new building for SPUNER unit is coming up at Nanakpura and that Delhi Police has recruited around 1100 personnels from different North-Eastern states and they are deputed

especially in areas where North-Eastern people are residing in high numbers.

The purpose of the meeting is basically to re-activate the contacts with the North-Eastern Bhawans as no physical meeting has taken place during the last one and half years due to the present pandemic. Requesting all the Bhawans to keep in touch with SPUNER for security related issues if required, from Nagaland State, Chief Resident Commissioner, Nagaland House Delhi and Additional Chief Secretary, Jyoti Kalash IAS, Joint Resident Commissioner, Sarita Yadav IAS and Deputy Resident Commissioner, Wennyei Konyak attended the video conference.

CHIEF SECRETARY ADDRESSES AHOds & HOds MEETING

AHOds & HOds meeting was held at the Secretariat Conference Hall, Kohima on 10th

September 2021 under the chairmanship of the Chief Secretary of Nagaland, J. Alam, IAS.

During the meeting, the Chief Secretary urged all the departments having pending advertisement bills to pay their bills to the newspapers at the earliest. He also stressed on the importance of maintaining websites and asked all the departments to keep it updated, as it is the only source of keeping the citizens informed about the department. Such updation on the websites with the right and timely information will drastically reduce the number of RTI cases, he added.

Principal Secretary, Information Technology & Communication and Power, K. D. Vizo said out of 95 departments, only 72 departments have updated their websites and the remaining 23 departments are yet to update. He further mentioned the cabinet decision in 2016 which clearly stated that all the Government departmental websites are to be hosted at the State Data Centre.

Principal Secretary, Home, Abhijit Sinha IAS

asked all the departments to come up with activities and programmes, and submit reports to the Home Department in commemoration of the 75 years of India's Independence – Azadi Ka Amrit Mahotsav.

On attendance, the Chief Secretary asked the AHDs & HDs to continue monitoring the attendance of officers and staff and urged them to work in close association with one another.

During the meeting, the Department of Justice & Law notified on the subject "Engagement of Legal Consultants" with regard to discontinuation of appointment of Legal Consultants/Advisers/ Assistants. This notification supersedes all other notifications dealing with the engagement of Legal Assistant, Legal Advisers, Legal Consultants including the Finance Department's Notifications dated 24th August 2018 and 15th April 2019. A PowerPoint presentation on CAG Audit Report was presented by the Finance Department.

1st NAGALAND FUTSAL CHAMPIONSHIP AT DIMAPUR

The 1st Nagaland Futsal Championship organised by Nagaland Football Association (NFA) in collaboration with Dimapur District Football Association (DDFA) started at Dimapur District Sports Complex (DDSC) on 11th September 2021.

Speaking at the inaugural programme, Editor-in-Chief, Nagaland Post, Geoffrey Yaden who attended the programme as Special Guest, congratulated the NFA and DDFA for being able to arrange the tournament in a short period of time.



Citing the example of Dr. T. Ao, who was the first Indian Olympic Football Captain, he said that football is not new to the people of the State. He also recalled the Nagaland Police Football Team which was one of the toughest teams in the country and the

teams that won the Subroto Cup. He encouraged the participants to get inspiration from past sportspersons who brought laurels to the State.

NFA, President, Neibou Sekhose and President, DDFA also addressed the gathering.

STATE GOVERNMENT APPEALS

A meeting was held under the chairmanship of Deputy Chief Minister, Nagaland on 13th September 2021 in the Conference Hall of the Chief Secretary, Nagaland to deliberate for developing a comprehensive strategy for dealing with the complaints pertaining to illegal taxation/extortion in Dimapur district, and also for discussing the matter of collection of items tax/fees by Urban Local Bodies (ULBs) and certain other issues as contained in the representation dated 09.09.2021, submitted by the Confederation of Nagaland Chamber of Commerce & Industry (CNCCI) to the Chief Secretary, Nagaland.

The meeting was attended by Advisor, Urban Development and Municipal Affairs, Chief Secretary, Nagaland, DGP, Additional Chief Secretary & Finance Commissioner, Principal Secretary, Urban Development and Municipal Affairs, Principal Secretary, Home, Commissioner, Nagaland along with other senior officers. After due deliberations the following were decided in the meeting:

1. The collection of any kind of tax/fees on items/goods that comes under GST regime shall be immediately stopped by all the Municipals and Town Councils across the State. Any other Government Department/agency, which may be collecting tax on any items falling under GST regime shall also give directions for immediately

stopping such collections.

2. Commissioner of Police, Dimapur in consultation with PHQ will immediately put in place a security grid and take other measures, including stationing sufficient security personnel at various locations to check illegal taxation/extortion.
3. The Administrators of all the ULBs will take steps for including the representatives of the business communities of their cities/towns in their advisory committees for taking decisions in respect to various business related activities.

The necessary Orders/Directions, wherever required, for the decisions taken in the meeting would be issued shortly by the Government.

In the meeting, it was also informed that the application of the SARFEASI (Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest) Act, 2002 is under examination of the Select Committee of Nagaland Legislative Assembly.

In view of the above, the Government appealed to CNCCI to give support and cooperation to the Government Departments for tackling the menace of illegal taxation/extortion and also for assisting in further improving the ease of doing business in the State.

STATE FAREWELL PROGRAMME HELD IN HONOUR OF R. N. RAVI

Governor, Nagaland, R.N. Ravi was accorded a State Farewell programme at the State Banquet Hall, CM's Residential Complex, Kohima on 14th September 2021.

Chairing the programme, Chief Secretary, Nagaland, J. Alam, IAS mentioned that R. N. Ravi

belongs to the Indian Police Service of 1976 batch (Kerala Cadre), served the Indian Police Service with distinction, and retired in 2012 as the Special Director of the Intelligence Bureau. From 2014, R.N. Ravi has been functioning as the Interlocutor for Naga peace talk. He joined as the Governor of

Nagaland on 1st August 2019.

Speaking on the occasion, Deputy Chief Minister, Y. Patton lauded R.N. Ravi's passion for understanding the core issues concerning any development matters and using his good office for ensuring removal of any impediment or complications that may hamper the progress of that matter. He also mentioned that Governor Ravi ensured smooth and early completion of some critical and beneficial projects for the people of the State. Patton expressed his immense gratitude to Governor Ravi for his time and concern for the interest of the people of the State and said that the State will continue to be inspired by the advice and exemplary statesmanship of the Governor.

Leader of NPF Legislature Party, T. R. Zeliang said that R.N. Ravi's name and identity is synonymous with the Indo-Naga political issue, and expressed hope that the Governor will continue to support the Naga people for an amicable solution to the Naga political problems, keeping his close association with all sections of the Naga society.

Calling Governor Ravi as a genuine and a down to earth person, who worked without any pretensions in discharging his duties, a sincere and hardworking professional who does what he think is right without any fear, Chief Minister, Nagaland, Neiphiu Rio thanked the Governor for the many things he achieved in a difficult situation. As a person well acquainted with the Nagas and their long history of struggle and aspiration, Rio said that the Governor's tenure in the State has its fair share of challenges, of which a lot still needs to be achieved.

Narrating the story when some Naga leaders met Mahatma Gandhi in July 1947, he said Gandhiji advised them to choose the path of non-violence like him if they want to pursue their desire, and Nagas were united till the Naga National Movement remained non-violent. He added that violence has only divided the Nagas and brought much more miseries. The Governor said he and his family will always remain grateful to the people of Nagaland for their love and affection.

Earlier, the invocation prayer was pronounced by Pastor, Shan Kikon, and a musical and cultural programme was presented by TaFMA.

APC NAGALAND HIGHLIGHTS NEED FOR TECHNOLOGY FOR FARMERS IN VIDEO CONFERENCE HELD WITH MINISTRY OFFICIALS

A video conference meeting was held on 16th September 2021 in the office chamber of APC,

Government of Nagaland under the chairmanship of Vivek Aggarwal IAS, Additional Secretary (Digital





Agriculture), Ministry of Agriculture & Farmers Welfare for the project proposal submitted under the National e-Governance plan (NeGPA)/Digital Mission Agriculture (DAM) for 2021-22 titled "Soil & Water Resource Management and Meteorological Analysis and Forecasting System Using Remote Sensing, GIS Mapping, Drone and Emerging Technologies," submitted by the Government of Nagaland.

Y. Kikheto Sema IAS, APC congratulated the Ministry for the innovative digital MoU with five firms to provide various farmers advisories services launched by the Union Ministry on 15th September 2021. He particularly congratulated Additional Secretary (Digital Agriculture) and team Digital for their commendable services to the farming community. He gave a brief introduction on the proposal being forwarded and thanked the Ministry for sanctioning of setting up of Soil Testing Labs in all districts and mini labs in all 74 blocks.

Kikheto also stated that the farmers in the State still practice a traditional form of agriculture and there is a need to incorporate modern and emerging technologies in order to transform the agriculture sector of the State by adopting settled/permanent agriculture. He highlighted that

the rapid change in climatic conditions such as rainfall pattern, temperature etc. is leading to drought like situation and emergence of pests like Fall Army Worms that was never before experienced in the State. Therefore, it has become all the more important for the State to adopt latest emerging technologies so as to mitigate any eventualities by use of technologies such as weather forecasting, various farmers' advisory services and also by use of drones for quick assessment of the damages for interventions in real time.

The officials of the Department of Soil & Water Conservation and Nagaland GIS and Remote Sensing Centre, Government of Nagaland presented the proposal. The Additional Secretary (Digital Agriculture) in principle, agreed with the proposal and invited the State officials from Nagaland to the Ministry of Agriculture and Farmers Welfare for the finalization of the project proposal.

The meeting was also attended by K. Zhekheto Awomi, Director, officials of the Department of Soil & Water Conservation and Mhathung Kithan, Project Director, Nagaland GIS and Remote Sensing Centre besides other supporting officials.

UNION MINISTER VISITS NAGALAND FOREST MANAGEMENT PROJECT SITE AT PIPHEMA

Union Minister of State for Environment, Forest & Climate Change and Consumer Affairs, Food & Public Distribution, Government of India, Ashwini Kumar Choubey made his first official visit to Nagaland at Piphema Old Village on 20th September 2021.

Visiting the Nagaland Forest Management Project (JICA) site, Ashwini Kumar Choubey expressed his admiration to the people, the landscape and also the huge forest coverage in the State. He mentioned that in spite of the land belonging to the community, the government projects through Nagaland Forest Management Project (JICA), the percentage of forest is increasing and improving which is an exemplary challenge to other parts of the country. He stated that to improve and increase our rich biodiversity, we will have to protect and save our forests.

'Plant trees and save trees' was the word sent from the good office of the Prime Minister to the people, said Choubey and that he was happy to address the Nagas with this message to urge and motivate the people to plant more trees. Planting trees, be it traditional or medicinal, will ultimate benefit the land, for better climate, for pollution free

state and a better land to live in.

From the departmental point of view, Choubey also said that the Government is willing to help the Department and the State to improve the forest area and assured to also improve the status of the forest personnels and add more facilities for the departments.

Earlier, Choubey was accorded for a ceremonial plantation at the project site and appreciating the affectionate gesture towards him by the villagers, he also declared to aid a child financially from Piphema village.

DFO, Dimapur, Beizo Suokhrie, IFS highlighted on the management of forest under the village and mentioned the village has been identified as one of the Nagaland Forest Management Project (JICA) Villages and on 11th February 2020, the Piphema Old Village Council signed a resolution with the NFMP and thus, Piphema Old JFMC was included into the NFMP (JICA). He also added that the village has a thick forest coverage which provides a rich variety of flora and fauna, owing to which the villages practice forest conservation to maintain the forest areas for the benefit and sustainability of future generations. The village has





also taken the initiative for protection and conservation of forest and natural environment by banning hunting, fishing, deforestation, burning of forest in its jurisdiction.

Union Minister Ashwini Kumar Choubey also addressed the media at Hotel Vivor, Kohima on 20th September 2021. Saying that India will not move forward unless North Eastern states are developed, he added that the Central Government is concerned about the North Eastern states on all fronts and consider it as one of the most important parts of India. The Centre is focussing on NE states since the situation has improved to a great extent and there is

possibility for all round development in the region. He also emphasized on the importance of saving trees and protection of environment, which he said will be a boon to farmers and the environment as a whole. As proposed by the State Government, Rs. 20 crore have been sanctioned for rehabilitation and discouraging of Jhum cultivation in the State. He also mentioned that Kohima and Dimapur have been selected under Nagar Van Scheme which enforces people's participation and collaboration between the Forest Department, Municipal bodies, NGOs, corporates and local citizens on promotion and development of cleaner and greener environment.

VANIJYA UTSAV HELD AT URBAN HAAT DIMAPUR

To promote trade and export of local and Agri-Horti produces, processed food products, handloom and handicrafts and various exportable products from Nagaland, Department of Industries & Commerce, Government of Nagaland in collaboration with Agricultural and Export Products Development Authority of India (APEDA) and Directorate General of Foreign Trade (DGFT) organised a two day event, 'Vanijya Utsav' under the theme 'Showcasing India as a rising economic force,' on 21st and 22nd September 2021 at Urban Haat, Dimapur.

Gracing the event as the special guest, Advisor for Industries & Commerce, Labour and Employment, Skill Development and Entrepreneurship, Imnatiba Jamir observed that organising such events should bring end results with proper follow ups and urged upon the people to work and participate in the government initiatives. He informed that the Department has created world class export centre at Ganesh Nagar but regretted that the State has still not been able to attract even one investor. Mentioning that the unresolved Indo-Naga political issue as one major underlying problem, hampering the State to go forward at par with other states, Imnatiba encouraged all to cooperate and energize one another.

Delivering the keynote address, Commissioner & Secretary, Industries &

Commerce, Kekhrievor Kevichusa encouraged the gathering for focusing on the unique products of Nagaland which has high value. Nagaland is the only state where Special Economic Zone is developed and therefore, we need to encourage exports, he maintained. Observing that local economy has not been sustainable, Kevichusa informed that the Department has a vision for strengthening this sector and appealed to all to move forward together.

Economic Advisor, Department of Commerce, GoI, C. Vanlalramsanga called upon all the states to act immediately for taking up the ambitious challenge of 400 billion dollars export target for 2021-22. Observing that the North Eastern states including Nagaland has tremendous potential yet untapped for enhancing exports in various sectors, he encouraged all for taking part in the call and take immediate and immediate steps for rising to the challenge of achieving the merchandise export target for 2021-22. He also appealed to all the stakeholders for attending the event across the country for working together as a team towards achieving the goal of boosting exports and the economy as the country celebrates 75 years of independence.

Assistant General Manager, APEDA, Bidyut Baruah, admitted that NER has ample advantage for exports due to conducive climatic



conditions and also for sharing 98% of borders with different countries. While stating that APEDA bridges the gap between buyers and producers, he impressed on the need for good quality of

continuous supply of products. He also emphasized on the need for good testing laboratory, reminding about the sensitivity of international markets in terms of quality requirements.

CEO OFFICE ORGANIZES VIRTUAL TRAINING



Training on Special Summary Revision of Electoral Roll 2022 was conducted through virtual mode on 24th September 2021.

The Office of the Chief Electoral Officer (CEO), Nagaland organized a one day training programme through virtual mode on 24th September 2021 for Electoral Registration Officers (EROs), Assistant Electoral Registration Officers (AEROs) and Assistant Election Officers (AEOs) in connection with conduct of Special Summary Revision of Electoral Roll with reference to 01.01.2022 as the qualifying date.

There are 13 EROs, 60 AEROs and 10 AEOs in the State. The EROs/AEROs are

administrative officers: ADCs/SDOs(C)/EACs. All the districts participated in the training.

CEO, V. Shashank Shekhar appreciated the efforts of the Administrative and Election Officers while discharging their official duties. He reminded the officials that the Election Commission is monitoring the progress of various pre-revision and revision activities. He mentioned the important role of BLOs (Booth Level Officers) at the booth level. He also spoke on the importance of an accurate electoral roll in general. He stated that



through the Election Commission's SVEEP (Systematic Voters Education and Electoral Participation) programme, the voters in general and especially the new voters may be made more aware about the true spirit of democracy.

The technical session on legal provision and procedures on electoral roll was conducted by Assistant CEO, Ailla Chang and procedures on forms processing in ERONet by users was taken by Kitoka, Programmer.

The IT initiatives of the Election Commission were also explained during the training. These include the Garuda app through which the latitude/longitude, photos and AMF (Assured Minimum Facility) of the polling booth are being uploaded and the VHA (Voter Helpline App) through which the voter can apply online for inclusion, deletion, correction and transposition of his name in the voters list.

REVIEW MEETING OF STATE IMPLEMENTING DEPARTMENTS OF SCHEMES UNDER MINISTRY OF DoNER, TOURISM & CULTURE

Planning & Coordination Department held a review meeting of State Implementing Departments of schemes under the Ministry of DoNER at Hotel Japfu, Kohima on 24th September 2021, in the presence of Union Minister, DoNER, Tourism and Culture, G. Kishan Reddy.

Minister, Planning & Coordination, Land Revenue and Parliamentary Affairs, Neiba Kronu, addressing the meeting, said that the DoNER Minister visiting Nagaland shows renewed focus on North East Region (NER), adding that earlier, it was 'Look East Policy' but now it will be 'Act East Policy.'

Kronu stated that many SPA projects in Nagaland are pending as central funding has stopped, adding that these projects need special attention and intervention from the Ministry. He urged the DoNER Minister to revive the Swadesh Darshan scheme in tourism sector as this scheme was beneficial for many districts in Nagaland, and many districts are yet to avail this schemes. He also urged the DoNER Minister to revive the Tagore scheme as such scheme will be beneficial for Nagaland to promote and preserve our culture and traditions.

Joint Development Commissioner, Planning & Coordination, Augustine M Yanthan presented a PowerPoint presentation on the review of schemes and support required from Ministry of DoNER.

Union Minister, DoNER, G. Kishan Reddy said that DoNER Ministry is a coordinating agency and its purpose is to coordinate all the

schemes/projects of the Government of India and carry out its proper implementation in the NER.

Minister Kishan Reddy assured that he will hold review meetings with all the Ministries and discuss the schemes, projects with the Ministers, Senior Government officials of the Government of India, department wise. He also assured that he will review with Prime Minister Narendra Modi, adding that the Prime Minister is very keen on developing the NER, to make sure that the schemes are implemented properly and to make sure that the NER is at par with the rest of the country. He said that he wants to carry out regular persuasion of the major schemes, be it the railways, schools, hospitals, agriculture etc. of the NER. He also mentioned that out of Rs. 12,000 crore, Rs. 6,000 crore has been approved as Farmers' Incentives for the NER, and expressed confidence that even in the days to come, more schemes, projects be made available for the NER.

Minister Reddy cautioned that the State Government needs to pay more attention to proper implementation of schemes, as this will pave the way for more projects to come up in the near future. He assured that more priority will be accorded to Nagaland for more schemes/projects, and that he will discuss the issues on the loopholes and the constraints faced by the State, and work with commitment to bring more development to the NER, and to fulfill the expectations of the people of NER.

Joint Secretary, DoNER, Government of India, Anuradha Sharma said that, as pointed by



EFC, NLCPR projects are pending in the State since 2007, and such pending projects either needs to be completed or closed down, as these projects would have lost the impact they had in 2007, and no sanctions would be made available if the State Government fails to comply with these guidelines. Regarding NESIDS and NERSDS, though they are new schemes started in 2017, she requested that such projects should also be completed at the earliest. She said that DoNER with NITI Aayog has come up with NER District SDG Index Report, which is an important tool to check the status of each district, to check the gaps and work on that. Nagaland is ranked 21 among the 28 states, and she expressed hope that the ranking improve in the coming days, using this Index and Dashboard. She also said that many Ministries are not able to use the 10 percent GBS because projects are not going from the State, and in this regard, if there are any issues, it could be followed up, why projects from the North East are not getting approved and why the Ministries

are not able to spend the 10 percent GBS. This money has to be spent on the North East, it cannot be diverted to any other parts of the country. The aim should be to persuade to get those funds so that the fund situation also eases and do not lapse, because in the event that it lapses, neither the DoNER gets it, nor the states gets it, adding that it is the right of the NER states to get the fund.

The review meeting was chaired by Chief Secretary, Nagaland, J. Alam IAS who also delivered the welcome address. Vote of thanks was proposed by Commissioner & Secretary, Planning & Coordination, Imokaba Jamir IRS. Advisor K. T. Sukhalu, AHoDs and HoDs of all implementing departments, and a host of senior government officials also attended the review meeting. During the interaction session, various implementing departments highlighted the achievements on their ongoing projects and also highlighted their grievances and sought support for implementing various projects.

vaccination drives was conducted at District Veterinary Hospital, Kiphire on 28th September 2021 under the theme " Rabies: Facts, not fear." Chief Veterinary & Animal Husbandry Officer, Kiphire, Dr. Tsilise Sangtam stated that every year, the nation celebrates Rabies Day on 28th September as it marks the death anniversary of French chemist and microbiologist, Louis Pasteur, who first developed rabies vaccine. He also said that rabies is a communicable disease that can spread to people and pets if they are bitten by a rabies animal, and though the disease is fatal, it is preventable so, he urged everyone to be aware about the disease so as to be safe from rabies in the days to come. She also highlighted those indicators, as part of the North East Region SDG Index – Baseline Report 2021-22, which require improvement in Wokha district.

PEREN:

Sustainable Development Goals (SDG) Coordination Centre, Planning & Coordination Department, Government of Nagaland organised a District level workshop on building capacities for taking forward the SDG at DC's Conference Hall, Peren on 16th September 2021.

Deputy Commissioner (DC), Peren, Sentiwapang Aier in his opening remark said the SDG was adopted by all United Nations Member States in 2015 as a universal call to action to end poverty, protect the planet and ensure that all people enjoy peace and prosperity by 2030.

In the first technical session, SDG Officer, Abilo Humtsoe gave a brief highlight on SDGCC Nagaland. She said that SDGCC of the Planning & Coordination Department, Government of Nagaland was established with a mandate to act as a centre for knowledge dissemination, SDG monitoring, policy strengthening, and as an accelerator of SDG

implementation across the State.

Abilo also spoke on the topics - SDG Localisation & Integration in Nagaland with focus on Peren district. During the workshop the national level preparedness, State level strategy for achieving SDG, State and District level institutional mechanism, District SDG monitoring framework and NER District SDG Index - Overall performance of Nagaland and Peren, were highlighted.

MON:

District level workshop on building capacities for taking forward the Sustainable Development Goals (SDG) was held at DC's Conference Hall, Mon on 20th September 2021. The workshop was chaired by District Planning Officer, and other dignitaries present were Deputy Commissioner, Mon and district level department officials.

There were two technical sessions held by SDG Coordination Centre (SDGCC), Planning & Coordination Department as part of this workshop. The first technical session was held on SDG localisation and integration with a focus on Mon district. The national, state and district level institutional mechanism and strategy for SDG implementation, District Indicator Framework for monitoring the SDG and way forward was shared during this session. Through this presentation, those indicators (as part of the North East Region SDG Index – Baseline Report 2021-22) which require improvement in Mon district were also highlighted.

Following this session, the keynote address was shared by the DC, Mon, Thavaseelan K, IAS

who emphasized about the need to improve district SDG performance as highlighted in the NER-SDG Index that was recently released. He also highlighted that regular data monitoring will be critical in order to reflect the right data for the district.

The keynote address was followed by an interactive session which consisted of interactive exercises for identifying the priority areas and viable local level solutions for Mon district for all relevant departments.

KOHIMA:

District level workshop on building capacities for taking forward the Sustainable Development Goals (SDG) was held at Planning Conference Hall, Kohima on 22nd September 2021, organized by SDG Coordination Centre (SDGCC) and Department of Planning & Coordination.

District Planning Officer, Pudusul Luho said that Nagaland is engaged in the process of SDG integration and localization since 2018 with its SDGCC under the Planning & Coordination Department. He added that though SDG is a new policy to most of the departments, he called for coordination among the departments to understand and identify the challenges and its solutions.

During the workshop, SDG Consultant from all the departments highlighted on the localization and integration of SDG, and preparedness of the State. The main objective of the workshop is to sensitise all the district level officials for taking forward SDG and develop understanding of the SDG. Participants from 28 departments and the SDG Consultants from the SDGCC attended the workshop.

TRAINING ON USE OF WEBGIS PORTAL AND MOBILE APPLICATION ORGANIZED AT TUENSANG

A three-day training on PRA Map Exercise for Selection of Treatment Areas and refresher training on WebGIS portal and mobile application for monitoring and collection of field data under Nagaland Forest Management Project was organized at CKS Hall, Tuensang. The training is assisted by Japan International Corporation Agency (JICA) headed by the Chief Project Director-cum-

CEO, Dharmendra Prakash, IFS (PCCF and HoFF). It is a forestry intervention and biodiversity conservation project. The project aims to focus on different project works for livelihood improvement and forest community development.

The WebGIS portal and mobile application, are developed under the supervision of Project Director (M&E and IM), Vedpal Singh, IFS for



concurrent monitoring and evaluation. This training is conceived and organised by Samom Khelen Singh, DFO, Tuensang and DPD- M&E & GIS, heading GIS and MIS Cell at PMU.

DFO Tuensang, Samom Khelen Singh presented his views on the relevance of PRA Map Exercise and GIS and Remote Sensing on the opening day of the training, organized from 1st to 3rd September 2020. He also motivated the ground staff and participants to understand and use the applications.

The training was organized to improve the understanding of ground-level staff for collaborating with the villagers in decision making by organising PRA Map Exercise and collecting the forest related data with the help of a mobile app. It will also help the key stakeholders on different monitoring and evaluation related problems with the use of the

WebGIS Portal.

Three experts including Anurag Verma, GIS Expert, PMC NFMP, Limasanen Longkumer and GIS team member, PMU NFMP, Anamoa Imsong presented various modules of these applications and described their uses. A field visit to Kuthur village was also organized on 2nd September 2021 in this regard for the collection of data for plantation under different modules, JFM and SHG activities, and institutional strengthening with the help of a mobile app. The experts along with DFO, Samom Khelen Singh broadly discussed the different issues related to PRA Map Exercise and different modules of the WebGIS Portal and mobile application. The Chairman, Vice-Chairman, and Secretary of the Joint Forest Management Council were also present during these discussions.

PEREN HOLDS DPDB MEETING

LOTHA DICTIONARY RELEASED DURING DPDB MEETING

Anglo-Lotha Dictionary was released at Wokha by Advisor, Information Technology & Communication, Science & Technology and New & Renewable Energy, Mmhonlumo Kikon during the monthly District Planning & Development Board meeting held at Deputy Commissioner's Conference Hall, Wokha on 15th September 2021.

Mmhonlumo Kikon thanked the Department of Art & Culture and Lotha Academy for coming together in publishing the Anglo-Lotha Dictionary, which he said is very significant for the Lotha community and the Naga people, and expressed hope that this book will be used properly.

The Advisor also thanked Yanbeni Yanthan and Dr. Imlienla Imchen, Assistant Professor, Centre for Naga Tribal Language Studies, Nagaland University who have taken the initiative to bring out the dictionary with phonetic symbol properly ascribed. He added that in this day and age there is a realization that there should be a book or dictionary

in our own language to know about one's own cultural knowledge.

Director, Art & Culture Department, Adela Moa while speaking at the function said that in 2018 the Planning & Coordination Department had asked the Art & Culture Department to take up some programme of the Tribal Research Institute (TRI) under the Ministry of Tribal Affairs, Government of India (Gol) to bring out dictionary of different Naga languages.

As language is the basic foundation on which societies are built and knowledge system sustained, it is not only essential for communication but it is the storehouse of a community's history, legacy and also for the development of a community's literature, having a data based in regional language, which will enable people as well as interested scholars to learn the language. Against this backdrop, the Directorate of Art & Culture along with Yanbeni Yanthan and Dr. Imlienla Imchen



collaborated to document the regional language of the Nagas, starting out first with the Lotha language. The book is the first Naga regional dictionary to use the International Phonetic Alphabet which she believed will be beneficial for the Lotha language speakers as well as students and scholars to use the phonetic transcription for pronunciation.

On behalf of the people of the District, Vice-Chairman, Wokha DPDB and DC, Wokha, Orenthung

Lotha thanked the Department for this initiative. During the meeting, the Board also recommended to the higher authority for consideration the upgradation of Government High School, Sanis to Government Higher Secondary School.

The Department of Agriculture presented a PowerPoint on the Department's activities in the District. Chief Medical Officer, Dr. C.W Tungoe also highlighted on COVID-19 scenario in the District.

On 10th Northern Angami I - A/C recasting of Iconic Project under 2021 - 2022, the Board decided to recommend the change of programme, from cementing of one road to construction of clock tower, and forward it to Planning & Coordination Department to take up with the State Planning Board for necessary action.

Social Welfare Department gave PowerPoint presentations on their departmental activities under District Welfare Office by DWO, Akali Sema; Integrated Child Development Service by CDPO, James Ezung and Integrated Child Protection Services, Nagaland by Programme Manager, Raitalie Zeliang.

ZUNHEBOTO DPDB MEETING HELD

The monthly meeting of the Zunheboto District Planning & Development Board (DPDB) was held at Sumi Hoho Conference Hall on 15th September 2021. Deputy Commissioner, Zunheboto, Peter Lichamo chaired the meeting which was attended by Minister, Agriculture and Cooperation, G Kaito Aye; Advisor, School Education and Chairman, Zunheboto DPDB, K. T. Sukhalu; and Advisor, Food & Civil Supplies and Taxes, Pukhayi Assumi.

Zunheboto DPDB Chairman requested the Minister for Agriculture to give necessary help

to the farmers, especially for corn crop cultivators as their entire crops were destroyed this year due to Fall Army Worm, and also asked the farmers to send photos of destroyed crops to the Department so that they can compile and send it to the Government.

Minister, G. Kaito Aye in his speech asked the departments, especially agri & allied to keep in touch with the farmers, understand their problems and bring it to the Government. He said that he has apprised the Government to look into the problems of the farmers and provide modern agricultural



equipments.

MLAs and various NGOs expressed their displeasure over the slow pace of work of the NHIDCL and asked the company to expedite the work and also provide quality work according to the DPR. The General Manager, NHIDCL assured that they will try their best to complete the work in time and provide quality work with public support but also shared their problems regarding land compensation cases, as the land compensation demand is very high. He requested the members to help them so that there will not be any obstacles for completion of work on time.

Public Works Department (Roads &

Bridges) presented various departmental activities and the problems faced by the Department regarding the construction of various bridges and roads which are ongoing. The Department also shared the problem faced in non-payment of salaries of almost half of labourers under Zunheboto division for more than two years.

Health & Family Welfare Department shared on the present COVID-19 status of the District to the members, and informed that till now 49,237 people have been vaccinated, taking the vaccination percentage to around 65% and added that 13 villages have been declared as fully vaccinated village.

KOHIMA DDMA QUATERLY MEETING HELD

Quarterly meeting of Kohima District Disaster Management Authority (DDMA) was held at DPDB's Hall, Kohima on 15th September 2021.

Highlighting about IDRN, Senior Technical Director and DIO, DIC Kohima, J. G. Lorin Rengma stated that IDRN is a nationwide electronic inventory of resources that enlists equipment and human resources, collated from districts, states and national level line departments and agencies. He added that primary focus of IDRN portal (idrn.nidm.gov.in) is to enable the decision makers to find answers on availability of equipment and human resources required to combat any emergency situation. The database would also enable them to assess the level of preparedness for specific disasters. He informed that, to update data in IDRN, District Collector or Magistrate are the

authorized officials to get the latest information about disaster management resources available with various line departments and agencies, and information is uploaded in the portal using services of District Informatics Officers.

During the meeting, Chief Medical Officer, Kohima mentioned that positivity rate of COVID-19 has been declining to 2.6% from 10th September 2021 till date. She suggested to the members to reinforce COVID-19 protocols to minimize the impact of the third wave. She also informed that the vaccination for the second dose will be available at any of the sub-centres every Wednesday in Kohima town.

The meeting was chaired by Deputy Commissioner, Kohima, Gregory Thejawelie. He informed the line departments to prepare Disaster Management Action Plan within one month.

SENSITISATION PROGRAMME ON SCHOLARSHIP SCHEMES HELD AT NOKLAK

Sensitisation programme on scholarship schemes was held at DC's Conference Hall, Noklak on 16th September 2021.

Speaking on the occasion, Deputy Commissioner (DC), Noklak, Hiazu Meru stated that, we are living in an age of Information Technology (IT) and all our working system is based on IT, therefore, all of us, specially the teachers need

to be updated and know what is happening around them, and advised the teachers to be well-equipped and update their skills.

Special Educator, Zurhetho Nyuthe, in his PowerPoint presentation explained in detail on how to apply for scholarships through online mode. He advised the trainees to read all the guidelines properly before applying online.

The seminar was organized by SDEO Office, Noklak and sponsored by Directorate of School Education. More than 44 trainees attended the training from both government and private schools under Noklak district.

Deputy Commissioner, Wokha, Orenthung Lotha who was the special guest said that the Department of Land Resources is one of the actively performing departments in the District, and is immensely contributing towards the upliftment of the general public with its economy. He also urged the WDC members from different villages, who had come to attend the programme, to play a proactive role as the successful implementation of the particular schemes largely depend on them.

District Project Officer, Wokha, Tepunol Yore while highlighting on IWMP expressed his optimism that the Department will continue and strive hard to achieve greater heights, keeping in mind, the works being well achieved in other programmes like RKVY, spring-shed and NAFCC. During the course of 5 years project plan many community assets were created and also plantations of various groups were achieved, under entry point activity, a total of 45 different structures were created such as resting shed (15), water reservoir tank (22), community hall (2), public toilet (1), project road extension (3) and an approach road foot step were constructed in one village.

DPO said that despite the COVID-19 lockdown the Department has done a tremendous job to uplift the economic status of the District by taking up various schemes, and added that the District has witnessed economic progress in 2020 through rubber tapping, the District has yielded 31.54 lakh Kg from 66 villages covering 1,013 households with a turnover of Rs. 37.84 crores, besides huge earning from other crops like tea, areca nut, coffee and parkia, besides other

horticulture crops.

DPO added that the District has currently achieved a total plantation area of 1,586 Ha under rubber plantation, 428 Ha of areca nut plantation, 414 Ha of coffee plantation and 29 Ha of tea plantation and he is expecting to earn a total of Rs.115.64 crore per year.

DIMAPUR:

Officials along with women entrepreneurs during a legal awareness programme on empowerment of women through entrepreneurship, organised by Nagaland State Commission for Women at Chizami, Phek on 23rd September 2021.

A one-day legal awareness programme on empowerment of women through entrepreneurship was organised by Nagaland State Commission for Women (NSCW) at Chizami, Phek on 23rd September 2021. The programme was attended by participants, existing and aspiring women entrepreneurs from Chizami town and neighbouring villages.

The NSCW led by the Chairperson, Khrienuo Tachü and Secretary, NSCW and Joint Secretary, Social Welfare Department, Bodeno S. Colo met with the Chizami Village Council leaders and conveyed their appreciation for including women in the Village Council and VDB as full-fledged members and for following 'equal wage for equal work' principle in the village.

Khrienuo Tachü in her keynote address stated that NSCW is committed to the empowerment of women and girls. She highlighted that there is a common perception that Naga women enjoys high and equal social status with men but in reality, Naga women continue to struggle and face multiple barriers owing to discriminatory customary practices. She noted that our women do not have inheritance rights and almost no participation in decision making in public spaces such as the Village Council at the grassroots, and therefore 'economic empowerment for women becomes critical to overcome such barriers.' She lauded Chizami village for including women in their decision making bodies. She added, when women become financially independent and stand on her own feet, she will be respected in the society and will claim her rightful space in society. She encouraged the participants to develop entrepreneurial skills, be focused and passionate, and to uphold the value of dignity of labour.

Assistant Legal Remembrancer and Under Secretary, Justice & Law Department, Government of Nagaland, Weko-u Mero highlighted the various legal rights for women guaranteed by the Indian

Constitution, such as the Code on Wages 2019, Indecent Representation of Women Act, Sexual Harassment of Women at Workplace Act 2013, Protection of Women from Domestic Violence Act (PWDVA) 2005, Medical Termination of Pregnancy (MTP) Act, Protection of Children from Sexual Offences Act (POCSO) 2012, and Maternity Benefit (Amendment) Act 2017.

Principal, Japfü Christian College, Dr. Visakhonü Hibo facilitated the session on 'Vocational Education – Upskilling and Reskilling,' where she encouraged the participants to develop skills and utilise our rich biodiversity i.e. plants, fruits, livestock, etc. for enhancing one's livelihood. She also shared and demonstrated several food processing recipes using indigenous fruits, spices and plants. Further, she highlighted the need to maintain hygiene, quality control, use good packaging, develop marketing skills in order to make any enterprise a successful one.

Speaking on 'Naga Textiles – Chizami Weaves and Livelihood opportunities,' Honorary Member, North East Network (NEN), Seno Tsühah shared the case study of Chizami Weaves (CW) – its objectives, the journey of CW in enhancing the earning capacities of women towards sustainable livelihoods and social justice, and the lessons learnt. She emphasised on the need to develop a good plan before starting any business enterprise – to explore opportunities, identify an area of interest, locating assets, develop a business plan that includes a good marketing strategy amongst others.

Director, Life Ministries, Colo Mero presented on 'Entrepreneurship - Opportunities and Challenges.' He stressed on the need to prepare our children for entrepreneurship or any other livelihood options by imparting life skills and values of hard work at a young age, that starts from home as this is foundational.

ADVOCACY WORKSHOP ON SMOKE FREE KOHIMA CAMPAIGN HELD

An advocacy workshop on tobacco control and initiation of the Smoke Free District Headquarters campaign was held at Kohima Municipal Council's (KMC) Office building on 24th

September 2021.

Administrator, KMC, Lanusenla Longkumer chairing the workshop said that the campaign for Smoke Free Kohima city was launched on 29th April



2016, following which sensitisation and other programmes on Smoke Free District Headquarter campaign were carried out. She said that to achieve Kohima district as 'Smoke Free District Headquarter,' every stakeholder and individual must support and contribute towards the endeavour.

District Nodal Officer, National Tobacco Control Programme (NTCP), Kohima, Dr. Arenla Walling speaking at the workshop said that smoke free campaign was to strengthen the enforcement of Section 4 of Cigarettes and Other Tobacco Products Act (COTPA) 2003, which bans smoking in identified public places. She said that the Health & Family Welfare Department alone cannot enforce or implement the provision of law under the Section and sought cooperation from all the enforcement officers and stakeholders to contribute their support to achieve a smoke free district.

Dr. Arenla stated that smoking should be banned because the smoke contains more than 7000 harmful chemicals, of which 100 are toxic and about 70 of them causes cancer. Smoking and exposure to second hand smoke can cause cancer, CV diseases, stroke, pneumonia and can damage the reproductive system, increase chances of TB infection, and women and children suffer the most from second hand smoke, she added.

On smokers and COVID-19, Dr. Arenla said that be it first or second hand smoke, it reduces lung capacity and increases the risk of many respiratory infections and can increase the severity of respiratory diseases. She said COVID-19 is an infectious disease that primarily attacks the lung, smoking impairs lung functions making it harder for the body to fight the virus and other respiratory diseases.

NSCW ORGANIZES LEGAL AWARENESS PROGRAMME AT KIPHIRE

A one-day seminar on legal awareness programme on 'Women and Health' was organised by Nagaland State Commission for Women (NSCW), supported by National Commission for Women (NCW) and in coordination with Akehda Sangtamlarü Thsingmüjang (AST) at Kiphire town on 24th September 2021.

The programme was chaired by Member NSCW, W. Nginyeih Konyak. In the introductory note, Member NSCW, Chongliu acknowledged and appreciated Chairperson NCW, Rekha Sharma for

extending full support to NSCW. Resource person, Dr. Tiakala Walling, Senior Medical Officer spoke extensively on 'Women and Health' and Hotingkyu Sangtam, Advocate, elaborated on 'Legal services to mentally ill and mentally disabled persons with reference to women.'

climatic conditions give surplus production, most of the time the produce get spoilt for lack of proper packaging and cold storage facilities. She encouraged the farmers to go for crops that suit the soil and climatic conditions and informed that the recent inauguration of Soil Testing Laboratory in Kohima will be able to identify the types of crops, which will be able to boost the production level.

Joint Director, Er. Y. Lipongse Thongstar in his keynote address said that Exporters' Conclave is to showcase export oriented products in order to



promote trade and export of local agri-horti produces, processed food products, handloom, handicrafts and various exportable products and also to commemorate the 75th Anniversary of India's Independence under the theme 'Showcasing India as a Rising Economic Force.'

KEZOCHA PHC UPGRADED TO CHC

Minister, Health & Family Welfare, S. Pangnyu Phom as the special guest inaugurating

the upgraded Community Health Centre (CHC) at Kezocha, Kohima on 9th September 2021 stated that

CHC is a whole-of-society approach to health and it ensures the highest possible level of health service and well-being by focusing on people's needs. He added that the State should not lack in health sector, therefore medical facilities and services is being prioritised at large by the Government.

Pangnyu highlighted that the health centre at Kezocha was established on 13th July 1979 and after a long gap of more than 30 years it has been upgraded to the status of CHC. Stating that some PHCs and CHCs across the State could not be inaugurated till date because of land issues and disputes, Pangnyu expressed happiness to the community for not having such issue and achieving the upgradation, and encouraged them to be a role model for the rest of the State.

Pangnyu stressed on the importance of vaccination and testing for COVID-19 and mentioned that the only solution to be safe is to get vaccinated. He also appreciated that the status of vaccination in the area is about 63% of the population and urged for more social participation for enhanced self-care and self-reliance in health issues.

Pangnyu assured that as per the CHC status, all the facilities for a CHC will be added in due course of time and asked the leaders of the community to take equal responsibilities and be a guardian and a model in taking care of the centre.

Advisor, Youth Resources & Sports, Er. Zale Neikha acknowledging the Minister, H&FW and H&FW Department remarked that the upgradation to CHC was a long cherished dream and the need of the hour of the Kezo range villages and this accomplishment will be recognised as a major development and achievement of the range.

Neikha requested the H&FW Department to provide facilities, manpower and infrastructures provided in a standard CHC in rural areas and also urged the people to support the medical experts and staff in proper functioning of the health centre and further requested them to cooperate and coordinate to make the CHC a stable and sustainable centre.

Minister, Public Works Department (Housing and Mechanical), Tongpang Ozukum in his note addressed the three categories in health services i.e the primary, secondary and the tertiary, and stated that CHC being in secondary category is a vital and basic category in health sector. The Minister was concerned over the gap between the trust of public in availing the facilities of government health centres and also requested the H&FW Department to provide all the facilities, infrastructure and manpower to progress smoothly.

Advisor, Horticulture and Border Affairs, Mhathung Yanthan emphasised the correlation between the importance of agricultural sector to health sector and stated that the ultimate development in organic farming leads to better health and generation of sustainable livelihood. The inaugural programme was attended by government officials including Additional Superintendent of Police, Peren and different NGOs.



During the programme Advisor, Imnatiba also launched MIS portal and released the Digital Literacy Book. The programme was organized by NIELIT in collaboration with the Department of Industries & Commerce. The project is implemented by National Institute of Electronics and Information Technology, Kohima and sponsored by the Ministry of Electronics and Information Technology, Government of India.

UNION MINISTER INAUGURATES SOIL TESTING LAB

Union Minister for Tourism, Culture and Development of North Eastern Region, Government of India, G. Kishan Reddy inaugurating the State Soil Testing Laboratory at Directorate of Soil & Water Conservation, Kohima on 24th September 2021 stated that the Government of India has been at the forefront for ensuring that soil quality is effectively managed to make agriculture more productive and sustainable. Soil management is one of the most important interventions under the national mission for sustainable agriculture therefore, establishment of a soil testing lab will help and boost the rural farmers and agri sector by enabling systematic correction of the soil samples and analysis by generating timely test results.

Reddy stated that, with the breathtaking landscapes, peaks, rivers and valleys, the North Eastern states have wealthy tourist destinations. NE states are the land of opportunity, the land of investment, employment generation, tourism and medicinal plants, etc. and Nagaland being the home of Naga king chilli, kiwi, cardamom, pineapple, bamboo shoot, etc., achieving to export the products to UK for the first time this year, has boosted the farmers to market the products not only in other states but export it to other countries as well, he said.

Reddy said that he is from a rural background and understands that technological intervention in agri and horti product yields a major difference in quality and quantity. He also expressed contentment over the



quality of the lab equipments, with instruments to analyse both micro and macro nutrients.

Reddy concluded that the Prime Minister is regularly discussing on the importance of NE states and with this special focus, the Government of India has allocated Rs. 6000 crore to the NE states on farmer scheme this year.

Director, Soil & Water Conservation, K. Zhekheto Awomi while giving the technical report of the project 'Establishment of State Soil Testing Laboratory Building & Equipment at Kohima, Nagaland' said that the project was funded by North Eastern Council (NEC), Ministry of DoNER, Government of India and the date of approval was on 29th June 2017 and the actual commencement of project was undertaken on 29th March 2018. He added that the cost of the project was Rs. 371.70 lakh with NEC share (90%), Rs. 334.53 lakh and the State share (10%), Rs. 37.17 lakh.

The Director also said that the aim and objective of the project is to assess the nutrient and fertilizer status and requirement of the soil, to

create awareness about the importance of maintaining soil health for sustainable production of agricultural commodities, to issue soil health card as per requirement after appropriate testing and analysis of soil sample and Soil Health Management through creating awareness on balanced use of fertilizers.

The Director said that the soil samples are collected from the fields from all the respective districts and that the laboratory can test more than 1 (one) lakh samples per year for 13 (thirteen) parameters such as primary and secondary macronutrients, micronutrients and other soil parameters.

Minister, Planning & Co-ordination, Land Revenue, Parliamentary Affairs, Neiba Kronu while congratulating the Soil Department for achieving to establish the Soil Testing Laboratory, he said the Department requires infrastructures in all the districts of the State so as to reach out to all the blocks and added that though the soil of the State is fertile, soil testing have become very important for agriculture in the State to check its acidity.

Modi, wants to increase all infrastructure activities in the NER. In this regard, he urged the people to discuss with the existing government, and to support development of the region. He assured that the Government would implement all Gol schemes with commitment.

Deputy Chief Minister and also Minister, Home and Roads & Bridges, Nagaland, Y. Patton mentioned that roads are the only means of transportation and communication within the State, Nagaland being landlocked the socio-

economic activities of the State entirely depends on road infrastructure. He impressed upon the DoNER Minister that the State would require more assistance from the Ministry of DoNER for construction and improvement of road infrastructure for promoting tourism, trade, industry and all round development. He therefore requested the Union Minister that funding under NESIDS be extended till the roads are fully developed and road conditions of the State are at par with that of other states in the country.

UNION MINISTER LAYS FOUNDATION STONE FOR TRAINING-CUM-EXAM CENTRE AT MEDZIPHEMA

Union Minister, Tourism, Culture and Development of North Eastern Region (DoNER), Government of India, G. Kishan Reddy unveiled the plaque and laid the foundation stone for In-Service Teachers Training-cum-Examination Centre with residential facilities at Pherima, Medziphema on 25th September 2021.

While addressing the foundation programme, G. Kishan Reddy said it is one of the important events of education department in the state level to have this training centre for teachers with residential facilities. He was glad that there is focus for ensuring teachers for crash programme and upgrade teacher's skills with all kinds of infrastructure. This training centre will focus in training teachers so that various modes of learning can be imparted in all schools which is very important during this time of pandemic. The residential facilities will also benefit both student and teacher, he said.

Reddy also mentioned on Narendra Modi's New Education Policy which includes the inputs for education policy for every state in India, which gives priority and protects local culture, festivals, songs in education. He requested Nagaland to pledge for 100% literacy, as Nagaland

is one of the opportunity state which is rich in natural resources and can also create employment and fulfill the dream of Naga people.

The Minister also urged the village to give importance to education as without it no state or country will develop. He further called upon the District Administration to fully utilise the flagship programme for each individual and Self Help Groups. He promised to work for the North East people, cooperate in all the developmental activities and develop the North East region.

Advisor, School Education, K. T. Sukhalu in his short speech briefed on the concept of the training centre, the changes in the School Education Department and the need for upgrading teaching in the State.

Advisor, Sericulture, Excise and Minority Affairs, Zhaleo Rio thanked the Centre for sanctioning the programme and building the centre of excellence. He also submitted a representation by the village for approach road.

Minister, Planning & Co-ordination, Land Revenue and Parliamentary Affairs, Neiba Kronu also in his short speech thanked the Union Minister for his concern for Naga people by accepting the proposal for building the training centre.

DISTRICT COURT COMPLEX INAUGURATED AT WOKHA

The long cherished dream to have a separate Judiciary District Court became a reality for the people of Wokha district as the Department of Justice & Law, Government of Nagaland inaugurated the District Court Complex at Wokha on 28th September 2021.

The District Court was inaugurated by the Chief Justice of the Gauhati High Court (High Court of Assam, Nagaland, Mizoram and Arunachal Pradesh), Justice Sudanshu Dhulia. While congratulating the district for having a new District

Court, he stated that it is good to have good infrastructure but dispensation of justice is not merely having a good infrastructure, but dispensation of justice should be in the mind and heart of a judge and of a lawyer, because they are the wheels of the same vehicle and added that ultimate aim should be to bring peace to disputes.

Principal Secretary, Department of Justice & Law, R. Ramakrishnan, IAS said Mokokchung and Tuensang District Court Complex which is on the verge

of completion, will be inaugurated very shortly, and construction of Noklak and Mon District Court Complex will be taken up in the next financial year. Ramakrishnan also urged the District Administration as well as the people of the district to give support to the judiciary so that they will have a vibrant District Court in Wokha.

Executive Engineer, Civil Administrative Works Department, Nagaland while giving the technical report said the building which

commenced in the year 2012 was constructed at a cost of Rs. 662.50 lakh with a total plinth area of 27,984 sq. ft.

Short speeches were also delivered by Judge, Gauhati High Court, Justice S. Hukato Swu, Justice Songkhupchung Serto and President, BAR Association, Wokha, Oren Humtsoe. Secretary Judicial, Law & Justice Department, Nino Iralu proposed the vote of thanks.

CHILD FRIENDLY COURT INAUGURATED AT WOKHA

In a first of its kind for the State of Nagaland, a child friendly court named as Children Zone in the District Court Complex, Wokha was inaugurated by Justice Sudhanshu Dhulia, Chief Justice of the Guahati High Court of Assam, Nagaland, Mizoram and Arunachal Pradesh and Patron-in-Chief Nagaland, SLSA at Wokha on 28th September 2021.

Initiated by the Nagaland State Legal Services Authority (NSLSA), the Children Zone is an extension of free legal services scheme for children under National Legal Services Authority (NALSA), with the aim to set up child friendly court room for children. The Protection of Children from Sexual Offences (POCSO) Act mandates that child-friendly environment be set up to make the criminal justice system less traumatic for the child survivor and their family.

According to statistics, the case of girl child abuse in the State in 2019 was 0.72 % and in 2020 the cases has risen to 4.93% in Nagaland. The establishment of Child Friendly Zone in all the districts in Nagaland remains vital in safeguarding the interest and wellbeing of children in every stage of judicial process, incorporating child friendly procedures.

Children are produced at the court multiple times for recording statements at the call of the magistrate on a case, they have to sit in the courtroom

in the presence of the police, lawyers, and accused people in most of the cases, including POCSO cases.

Court trials and sessions are daunting and stressful, not only for the accused but the staff and their families too. Even for adults, court dates would put a lot of strain, especially if the victim or the accused has an infant which has to be taken care of. In such cases children can be taken care of, in the Child Friendly Zone which would have crèche facility not only for the victims or the children of accused but also the children of the staff of the office.

The Children Zone is aimed to resolve cases related to crime against children in a friendly environment with state-of-the-art provision facilities as per the guidelines provided in the Protection of Children from Sexual Offences Act 2012, where the child can feel at ease to reveal the ordeal without any hesitation. The child friendly zone will provide a child a safe and stress free environment for the court to record statements and to improve the efficiency of the welfare services for a girl child and speedy disposal of child sexual abuse cases.

A child victim along with their family/support person, can access the court through an entrance so that they are not compelled to see the accused persons, the police, etc. while they enter the court, and to maintain their privacy.



VARIANTS OF COVID-19 AND IMPORTANCE OF VACCINE

(A DIPR feature)

Why is COVID-19 still around?

- * The virus that causes COVID-19 continues to mutate, and so new variants emerge.
- * A major worry right now is Delta, a highly contagious virus strain, which was first identified in India in December 2020.
- * It has been called a variant of concern by the World Health Organization (WHO) because of its high transmissibility.
- * In Nagaland, 99% of the result of samples sent for genome sequencing are found to be of the Delta Variant of concern. (Source: IDSP, DoHFW)
- * In Nagaland, 78% of positive cases in the second wave are among the unvaccinated and 14 % of positive cases had received a single dose. (Source: Weekly Bulletin, IDSP, DoHFW)

Are there more variants to COVID-19?

All viruses, including the virus that causes COVID-19, change over time. Some of these changes may affect the virus's properties, such as how easily it spreads, the associated disease severity, or the performance of vaccines, therapeutic medicines, diagnostic tools, or other public health and social measures. World Health Organisation (WHO) has classified each emerging variant as either a Variant of Concern (VOC) or a Variant of Interest (VOI). The Alpha, Beta, Gamma and Delta variants fall under Variants of Concern. While, the Eta, Iota, Kappa and Lambda fall under Variants of Interest.

What is a Variant of Concern? (Source: WHO)

For Variant of Concern, clear evidence is available indicating a significant impact and rise on transmissibility, an increase in fatality and significant decrease in effectiveness of vaccines, therapy and other measures. Possible attributes of a variant of concern:

- Evidence of impact on diagnostics, treatments, or vaccines
- Possibility of interference with test results.
- Evidence of substantial decreased effectiveness to treatments.
- Possibility of getting reinfected.

- Evidence of reduced vaccine-induced protection from severe disease.
- Evidence of increased transmission.
- Evidence of increased disease severity and mortality.

What is a Variant of Interest?

For these variants, evidence is available that could imply a significant impact on transmissibility, severity and/or immunity, realistically having an impact on the epidemiological situation. However, the evidence is still preliminary or is associated with major uncertainty.

Evidence from multiple countries with extensive transmission of VOCs has indicated that public health and social measures (PHSM), including infection prevention and control (IPC) measures, have been effective in reducing COVID-19 cases, hospitalizations and deaths.

Is the Delta variant more contagious?

Yes. The Delta variant is highly contagious, about twice as contagious as previous variants. However, the same precautions, such as avoiding crowded spaces, keeping your distance from others and mask wearing, still work against the Delta variant.

Are the COVID-19 vaccines effective against the Delta variant?

Yes. The WHO-approved COVID-19 vaccines continue to be highly effective at preventing severe illness and death, including against the Delta variant. When it's your turn make sure to get vaccinated. If your vaccination involves two doses, it is important to receive both in order to have the maximum protection. The vaccines protect most people from getting sick, but no vaccine is 100 per cent effective.

Will I be fully safe from COVID-19 after vaccination?

Not everybody who receives vaccines has 100 percent protection. You might still get COVID-19 after being vaccinated. This is called as breakthrough infection. This does not mean that the vaccines are not working or that, something is wrong



with the vaccines. But the vaccine will give you a really good chance of not developing the disease.

The degree of severity of disease among people who have a breakthrough infection is less severe than the severity of disease among people who are not vaccinated. If you have been fully vaccinated but are showing symptoms of COVID-19, you should contact your doctor about whether you should get tested.

What to expect after vaccination? What are expected immediate and delayed side effects of this vaccine?

Covishield: Some mild symptoms may occur like injection site tenderness, injection site pain, headache, fatigue, myalgia, malaise, pyrexia, chills and arthralgia, nausea. Very rare events of demyelinating disorders have been reported following vaccination with this vaccine but without the causal relationship establishment.

Sputnik V: Short term general chills, fever, arthralgia, myalgia, asthenia, general discomfort, headache.

- Local: injection site tenderness, hyperaemia, swelling
- Less common: nausea, dyspepsia, loss of appetite
- Occasionally: enlarged regional lymph nodes

Is the vaccine safe? How was the vaccine developed in such a short time?

Developing a vaccine generally involves years of research. First, we need a vaccine candidate

that is evaluated in animals for its safety and efficacy. After a vaccine candidate passes a pre-clinical trial, it enters the clinical trial phase. While scientists have worked round the clock in the laboratory, even regulatory approvals which used to take several months have been fast-tracked. It helped eliminate all the time lapses between the preclinical and clinical trial stages. Earlier, the vaccine development involved a series of steps, but in the case of the coronavirus vaccine, the scientists and regulators worked in tandem, accelerating the whole process without compromises on any protocols and any step.

How long I will remain protected after vaccination?

Longevity of the immune response in vaccinated individuals is yet to be determined. Hence, continuing the use of masks, hand washing, physical distancing and other COVID-19 appropriate behaviours is strongly recommended.

Vaccination is the best protection against COVID-19. The main aim of vaccination is to break the chain between positivity and hospitalization or death. Vaccinated people still must wear a mask, follow hand hygiene and avoid crowded places.

* Avail all recommended doses of COVID-19 Vaccine to get the optimum level of protection. Always follow the precautionary measures of Wear a Mask, Washing Hands Frequently, Maintaining Social Distance and do not go out of the house un-necessarily.

THE ILL EFFECTS OF ONLINE GAMING ADDICTION/ ABUSE AMONG THE STUDENTS

In pursuance of the Department of School Education & Literacy, Ministry of Education, Government of India letter D.O. 1-56/2021-DIGED dated 9th September 2021, the Nagaland Board of School Education (NBSE) has notified for information of all the Heads of Registered Institutions under NBSE to be aware of the ill effects of online gaming addiction/ abuse among the students.

Online games can be found almost anywhere on any gaming platforms such as PCs, consoles and mobile devices. Online gaming can be accessed with the use of a phone or a tablet which is

a common factor in online game addiction because children can easily play games anywhere anytime affecting their time for their school and social life. Moreover, the closure of schools due to the pandemic has increased use of mobile and internet by children.

Playing online games leads to a serious gaming addiction which has been considered as a gaming disorder. Playing online games without restrictions and self-limit leads to addiction and are eventually diagnosed with gaming disorder.

Therefore, Heads of Institutions are requested to share the concerns and sensitize the



parents and teachers about the harmful effects of online gaming.

Advisory To Parents And Teachers On Children's Safe Online Gaming

Don'ts:

- * Do not allow in-game purchase without parental consent. To avoid in-app purchases, OTP based payment methods may be adopted as per RBI's guidelines.
- * Avoid credit/debit cards registration on apps for subscription. Place an upper limit or expenditure per transaction.
- * Do not let children buy directly from the laptop or mobile they use for gaming.
- * Advise children not to download software and games from unknown websites.
- * Tell them to be beware of clicking links, images and pop-ups in the websites as they may contain a virus and harm computer and may contain age inappropriate content.
- * Advise them not to give personal information over the internet while downloading games.
- * They should never share personal information with people in games and on gaming profile.
- * Advise them not to communicate with strangers including adults, through web cam, private message or online chat as it increases the risk of contact from online abusers or bullying from other players.
- * Advise them against engaging in game for long hours without taking a break considering health aspects and addiction.

Do's:

- * While playing online games, if something wrong happens, stop immediately and take a screenshot (using the 'print screen' button on the keyboard) and report it.
- * Help your child to protect their privacy online, get them to use a screen name (avatar) that does not reveal the real name.
- * Use antivirus/spyware programmes and configure web browsers securely using firewall.
- * Activate parental controls and safety features on the device or in the app or browser as it helps restrict access to certain content and limit

spending on in-game purchases.

- * Notify if a stranger tries to start a conversation about something inappropriate or requests personal information.
- * Check the age rating of any games your child is playing.
- * In case of bullying, encourage your child not to respond and keep a record of the harassing messages and report the behaviour to the game site administrator/block, mute or 'unfriend' that person from their players list, or turn off the in-game chat function.
- * Play alongside your child to get a better sense of how they are handling their personal information and who they are communicating with.
- * Help your child understand that some features in online games are used to encourage more play and spending. Talk to them about gambling, what it is and its consequences both online and in the physical world.
- * Always ensure that your child accesses internet from a computer placed in the family space.

Keep your eyes open for:

- * Unusually secretive behavior, mostly related to their online activity:
 - A sudden increase in the time they spend online, especially social media.
 - They seem to change screen on their device when approached.
 - They become withdrawn or angry after using the internet or sending text messages.
 - Their device suddenly has many new phone numbers and email contacts.
- * Install internet gateway at home which has features like monitoring, logging and controlling the types of content that the children can access.
- * Teachers need to keep an eye on falling grades and social behaviour of the students.
- * If teachers observe something that may seem suspicious or alarming, they should inform the school authorities immediately.
- * Teachers should ensure that children are sensitized about the pros and cons of the internet from time to time.
- * Teachers should train students for secure configuration of web browsers & web applications.


