

OFFICIAL ORDERS AND NOTIFICATIONS

NBSE NOTIFIES ON VIDYANJALI 2.0

The Nagaland Board of School Education (NBSE) has notified for the information of the Heads of Registered Institutions that the Ministry of Education, Department of School Education & Literacy, Government of India has launched Vidyanjali 2.0 programme, a school volunteer programme which aims to enhance the quality of school education through community and volunteers' participation by allowing them to connect directly with the Government and government aided schools, and share their knowledge and skills as well as contribute in the form of assets/materials/equipments.

The broad categories of contribution by a volunteer include inter-alia, services such as subject assistance, teaching yoga, art & craft, vocational skills, assistance for Divyang students, adult education etc. and assets and materials such as basic civil infrastructure, electrical infrastructure, digital infrastructure, equipment for extra-curricular activities & sports, yoga, health and safety aids, teaching learning materials, maintenance & repairs, office stationary/furniture etc. Contribution of assets/materials/equipments cannot be in the form of any monetary support.

Schools having UDISE+ code shall register on Vidyanjali 2.0 portal and post the required service/activity or assets/materials/equipments on the web portal. Depending on the request raised by the school, a volunteer based on his/her area of expertise/interest on assets/materials can express his/her interest to partially/fully contribute to the schools who have requested for assistance. The Vidyanjali 2.0 portal may be accessed at <https://vidyanjali.education.gov.in>, and a mobile app for the same will be launched shortly.

Therefore, all Heads of Institutions have been requested to take note of the above programme, register themselves, post request for contribution and invite individuals/organisations/NGOs for the contribution in line with the guidelines of the programme.

TRANSPORT DEPARTMENT NOTIFIES ON RETRO-REFLECTIVE TAPE

In pursuance of the Ministry of Road Transport & Highways directive vide Letter No. RT-11036/19/2021-MVL dated 06.09.2021, the Transport Department has notified that vehicle owners may get their vehicles affixed with retro-reflective tape from any vendor if the retro-reflective tape has been type-approved as per AIS-090 by any of the testing agencies specified under Rule 126 of the Central Motor Vehicles Rules, 1989.

FINANCE DEPARTMENT MAKES AMENDMENTS TO EARLIER NOTIFICATION

Finance Department (Revenue Branch) has notified that in exercise of the powers conferred by Sub-Section (1) of Section 9 and Sub-Section (5) of Section 15 of the Nagaland Goods and Services Tax Act, 2017 (4 of 2017), the State Government, on the recommendations of the Council, has made the following amendments in the notification of the Government of Nagaland, Finance Department, Revenue Branch, F.NO.FIN/REV-3/GST/1/08(Pt-1)'D' dated the 30th June 2017, namely:

In the said notification:

- In Schedule II - 6%, S. No. 243, and the entries relating thereto shall be omitted;
- In Schedule III - 9%, against S. No. 452P, in column (3), the words "in respect of Information Technology software" shall be omitted.

NOTIFICATION ON SALE OF SECURED ASSETS BY FINANCING INSTITUTIONS

The Finance Department, Government of Nagaland has issued a Notification No. FIN/GEN/SLBC/12/2012 dated 10th December 2021 stating that in conformity with the special provision conferred by Article 371A (1) (a) (iv) of the Constitution of India, the Governor of Nagaland has notified the implementation of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (SARFAESI Act, 2002) in Nagaland with effect from the date of this notification.

OFFICIAL ORDERS AND NOTIFICATIONS

In so far as the sale of secured assets taken over by the banks and financing institutions is concerned, it can be sold only to indigenous inhabitants of Nagaland in accordance with provisions of the Nagaland Land and Revenue Regulations (Amendment) Act, 2002.

HOME DEPARTMENT NOTIFIES ON ONLINE INNER LINE PERMIT


The State Home Department stated that in exercise of the powers conferred by Section 4 of the Bengal Eastern Frontier Regulation, 1873, and in continuation of its office notification of even number dated 08.11.2019, the provision for online application and issue of Inner Line Permit (ILP) has been extended with immediate effect to the non-indigenous persons belonging to the categories of trader/businessman/labourer/student/priest for the entry and temporary stay in Nagaland as per the provisions of Inner Line Permit regime laid down in the Home Department office notifications of even number dated 03.05.2018 and 09.12.2019. It stated that the application for issue of online ILP by the person concerned may be made by registering on the site www.ilp.nagaland.gov.in, providing all the requisite details, uploading photograph, valid government recognized photo IDs, address proof, and paying the prescribed fees as per the laid down instructions/guidelines on the website.

The guarantor for the persons seeking ILP online will also be required to register on the site www.ilp.nagaland.gov.in, by providing the required details, uploading the valid government recognized photo IDs, address proof, and other necessary documents as per the instructions/guidelines on the website. The digital copy of the ILP card generated or its hard copy shall be considered as valid ILP document when carried along with a government recognized photo ID by the person concerned. The facility of online ILP will be in addition to the existing manual/offline mode of obtaining ILPs.

In a press release, the Home Department stated that the online ILP module for all the categories, i.e. for businessman/trader/labourer/student, in addition for tourists, for whom the online facility has been operational since 8th November 2021, was launched on 16th December 2021 by Chief Minister, Neiphiu Rio in his office at the Chief Minister's Residential Complex, Kohima in the presence of Advisor, Information Technology & Communication, Science & Technology, New & Renewable Energy, Mmhonlumo Kikon. The online ILP module functions in line with the existing provisions of ILP and has been developed and made operational by the Department of Information Technology & Communication, Government of Nagaland in consultation and guidance of the Home Department, Government of Nagaland.

Anyone who wants to get an online ILP, may visit the online site www.ilp.nagaland.gov.in, get registered using his/her phone number, provide all the necessary details, upload the proof of identity and address, and the filled up application will be thereafter electronically transmitted to the Deputy Commissioner concerned who after carrying out the necessary checks, and on being satisfied of the eligibility of the person concerned, may approve for issue of ILP. On approval by the Deputy Commissioner, the applicant will proceed for payment of the requisite ILP fee in the portal, and on successful payment, the person concerned can download or print the ILP card. A soft copy of ILP card will also be sent to the email of the person concerned along with an SMS to registered mobile number with ILP number and validity. The digital copy of the ILP generated, or its hard copy, will be considered as valid ILP document when carried along with a government recognized photo ID by the person concerned. The guarantor for the persons seeking ILP online will also be required to be registered online on the site www.ilp.nagaland.gov.in, by providing his/her phone number, the required details, his/her government recognized photo IDs and address proofs.

Each guarantor will be given a unique number which the ILP applicant will be required to fill up, and on doing so, the guarantor will get an OTP on his/her phone which will have to be provided to the applicant for filling up for proceeding further with his/her application. This way, the guarantor can keep a check whenever anyone is making an application using his/her name as guarantor, and his/her unique number, for getting an ILP. As provided in the present guidelines, the online system doesn't allow anyone to become a guarantor for more than 10 (ten) persons. Further, one can remain and function as a guarantor for a maximum of 1 (one) year at a time. If one wants to function as a guarantor beyond 1 (one) year, one needs to renew on the online system. The Online ILP module is another significant step towards the commitment for making public services available in a more efficient and user-friendly manner. It besides making the entire process of obtaining an ILP convenient, and transparent, will further improve monitoring, generation of accurate and up-to-date data, and the overall quality of implementation of the ILP regime in the State.



NAGALAND CELEBRATES 59th STATEHOOD DAY

The 59th Statehood Day was celebrated at Nagaland Civil Secretariat Plaza, Kohima on 1st December 2021.

Chief Minister, Neiphiu Rio delivering his speech, appealed to the people to rededicate and work for peace, growth and development, and provide better standard of living for all citizens. He emphasized on the need to further improve our administrative and governance systems and added that the citizens have to join hands with the Government to usher in a new era of peace, development and prosperity.

Rio said that this year's celebrations also coincide with the ongoing nationwide celebrations to commemorate 75 years of India's Independence 'Azadi Ka Amrit Mahotsav' and the great achievements of its people. Close to six decades since statehood, the quality of life of our people has improved significantly, remarking that despite achievements in the expansion of health and education facilities, the road and power infrastructure need to improve. Rio added that the Government is committed to take necessary steps for all round development and to ensure that our people are provided with the best opportunities for growth and progress.

Rio said that our State occupies a unique position in the Indian Union with special provisions in the Constitution and as the wait continues for a solution of the Naga Political Issue, the dialogue and negotiations between the Government of India and the Naga Political Groups have reached a stage giving us hope for an early resolution. He said all the elected leaders of the State have come together to form an opposition-less government in the form of United Democratic Alliance to facilitate an early settlement of the Naga Political Issue.

The Chief Minister expressed grief and sympathies to those families who have lost their near and dear ones to COVID-19. He applauded the healthcare workers, frontline workers, the district administration and the civil societies and church leaders for their ceaseless hardwork. He added that

the Government has constantly monitored the situation and taken timely decisions which helped in dealing with the first and the second waves effectively. He stated that in order to improve the health infrastructure, hundreds of doctors and nurses were recruited by creating additional posts. Oxygen generation facilities were set up, added more hospital beds including a modern, state of the art 200-bedded Acute Care Hospital Block in CIHSR, Dimapur and deployed advanced equipment. He added that the facility at CIHSR Dimapur will help the State to be better prepared for future COVID-19 waves and other medical emergencies.

Rio cautioned the public to continue to be watchful and take all preventive steps as we open up and start the festive season. He said that vaccine hesitancy in some pockets of our districts is a matter of great concern. He remarked that within Nagaland, people in Kohima and Dimapur have taken the vaccine with great enthusiasm and these towns are safer today. Rio congratulated the villages which have completed 100% vaccination of their eligible population and appealed to all to come forward and take the vaccine as this will keep everyone safer against any future COVID-19 outbreaks.

Rio remarked that the Government's continuous endeavour is to improve the quality of education in our schools and colleges. 31 colleges out of the 66 colleges in Nagaland have been accredited by the National Assessment & Accreditation Council-NAAC, and many other college applications are in the pipeline. The Department of School Education has commenced implementing the National Education Policy 2020 in a phased manner and various innovative projects are being introduced, such as making the teaching-learning process joyful and productive to both students and teachers.

The Chief Minister said that electricity is the driver of all development and as we are heavily deficient in power generation, we need to quickly



enhance our capacity. He also said that the State received approval for two Externally Aided Hydro Electric Power projects, namely 42 MW Y Lower Tizu and 24 MW Zungki, with estimated costs of Rs. 529.78 crore and Rs. 367.21 crore respectively. In order to further augment our power generation capacity, we will be setting up solar power plants of 10-20 MW during the coming year, Rio added.

Rio mentioned that road network in the State is expected to see a further boost with Nagaland PWD and the NW DCL carrying out several projects in the State. Prominent among them are 78 Km two-laning in Wokha-Mokokchung sector of NH-2, strengthening of existing pavement in NH-2, NH-202 & N 702-A, the four-lane RCC Sanuoru bridge on the way to the New Capital Complex, the first four-lane bridge in the State was completed and opened to traffic on 29th November 2021. Further, 89 Roads & Bridges projects, including 22 Bridges are being constructed under PMGSY, covering a total length of 1107 Km, with a total sanctioned amount of Rs. 2284 crore. DPRs are also under preparation for the East-West corridor and North-South corridor in the State.

To showcase our tradition, culture and talents, the much awaited Cultural Hall, Kohima was inaugurated with a seating capacity of 1850 and it will be one of the premier Cultural Halls in the country.

The Chief Minister said that Nagaland witnessed a drought-like situation this year and in order to deal with the delayed and erratic rains, implemented a Crop Contingency Plan to help affected farmers with input support during Rabi season. Our State is giving more focus to organic farming not only to help farmers fetch better prices for their produce, but also to provide healthy and nutritious food, Rio added. He also mentioned that during the three years Convergence Programme of MGNREGA with North East Initiative Development Agency & Land Resources Department, a notable achievement was also made in our rural areas by successfully completing 105 Spring Shed Management

projects in 97 villages.

Rio stated that with the outbreak of African Swine Fever in neighbouring states this year, Department of Animal Husbandry & Veterinary Services performed well to prevent spread of the disease in our State by enforcing strict bio-security measures.

Rio commented that during the recently concluded session of the Nagaland Legislative Assembly, we passed the resolution for implementation of the SARFAESI Act in Nagaland. The act will pave way for providing finance facilities by the banks to our promising entrepreneurs.

The other highlights of the programme included launching of NIPUN Bharat Mission in Nagaland and inauguration of photo exhibition 'Glimpses of the history of the State' by Chief Minister Neiphiu Rio. A musical presentation 'The Gael' was presented by NPTS Brass Band and 15th NAP (IR) Mahila Pipe Band. Deputy Commandant NAPTC, Dr. Kupe Kapfo Commander led the parade with Assistant Commandant 15th NAP (IR) Battalion, Medemkala as the second-in-command. Cultural display was presented by Aong Reju Cultural Organisation (Ao), Pfushin Thuringia Cultural Troupe (Rengma) and Khianmniungan Cultural Troupe (Kohima).


BHANDARI:

arts and craft, folklore etc.



Proprietor, Portrait Studio & Eastern Art Council, Myinthungo Ezung stated that HIPFEST started in the year 2008 and has come a long way as part of Hornbill Festival. HIPFEST has brought photographers, artisans and enthusiasts not only from the State but from all over the world under one roof. He stated that the exhibition shows every aspect of Naga way of life through photographs.

The Hornbill International Photo Fest also displayed photos by Tom Potisit, an award winning professional photographer from Thailand. Tom is well known for stimulating conversations on social and environmental issues across various mediums and industries.

Altogether, there were 46 participants with 116 entries. The results were declared at Kisama on the 2nd day of the Hornbill Festival with Photographer Kehkriezhazo Machieo, Freelancer Merimvu Doulo

and Media Officer to the Chief Minister, Ayieno Kechü as the judges. Rio in his speech stated that he along with his colleagues were there to mourn together with the people of Mon. He stated that the whole State is with the Konyaks and the ENPO to observe 4th and 5th December 2021 as Black Day, against the incident



which took the lives of innocent Nagas by the Indian Army. This day will go down in the history of our people, where our brave sons sacrificed their lives for our land, he added. He stated that the challenge of removing the tag of "Disturbed State" on Nagaland and the prevalence of Armed Forces Special Powers Act in the State is a continuing challenge which the State Government is fighting against.

Rio assured the people that the components of the joint memorandum submitted by the KU, KNSK and KSU, which falls under the State's prerogative will be looked into and for those under the Centre, the State Government will work towards its fulfillment. He declared an

ex-gratia of Rupees Five (5) Lakh for the family of each victim by the State Government. He also stated that the Union Home Minister, Amit Shah, has announced an ex-gratia of Rupees Eleven (11) Lakh and a government job to the family of each victim.

Representatives from Konyak Legislators, ENPO, Konyak Union, KNSK, ENSF, KSU, Village Council of Oting, Jakphang and Chi delivered speeches condemning the incident and the cruel and draconian provisions of AFSPA.

The service was chaired by Vice-President, KSU, Yuwang Konyak. The invocation prayer was pronounced by Pastor KBCM, Rev. Nahngom and the lastrites were performed by Executive Secretary, KBBB.

NAGALAND OBSERVES WORLD SOIL DAY 2021

KOHIMA:

World Soil Day 2021 under the theme "Halt soil salinization, boost soil productivity" was held at the Directorate of Soil & Water Conservation, Kohima on 5th December 2021.

Gracing the occasion as the Special Guest, Agriculture Production Commissioner, Nagaland, Y. Kikheto Sema, IAS said that since 70% of the farmers are engaged in agriculture activities depending on Agri & Allied activities and out of that 73% are dependent on jhum and shifting cultivation, not knowing the warnings about the safety of soil so he urged all to play the role in spreading awareness about taking care of the soil by not misusing and overusing the same soil without any treatments, and letting them know that sick soil would not be able to yield crops as desired.

APC stated that the Department of Soil & Water Conservation has been given the responsibility for soil health management, where Soil Testing Laboratory for 12 districts and 74 blocks are to be set up and two more bio-fertilization are to be established. He also requested all Agri & Allied department to have discussions about the importance of soil and sent advisors to the farmers before their new cultivation. He also advised that with availability of water source, both animal and crop farming can be taken up side by side leading to

development of the area which would further bring road connectivity and market for the produces. He also called upon the church members to spread awareness about the importance of soil in the churches.

Professor & Head, Department of Agricultural Chemistry and Soil Science SASRD, Nagaland University, Medziphema, Dr. A.K. Singh who was the resource person in his PowerPoint presentation pointed out that World Soil Day is an international day celebrated to focus attention on the importance of healthy soil for sustainable management of soil resources and the day signify the importance of soil in our ecosystems

To achieve food security in the country, we need to focus on both area expansion under agriculture and rise in food production. In his PowerPoint presentation, he illustrated the global scenario of soil salinization, area under soil degradation and the status of salt affected soils in India and also about food security in India through reclamation of salt-affected soils.

The programme was chaired by Commissioner & Secretary, Soil and Water Conservation and Geology and Mining, K. Libanthung Lotha, IAS, while welcome speech was delivered by Joint Director, Soil & Water Conservation, Denis Angami and vote of thanks by

Addressing a press briefing at the Nagaland Civil Secretariat on 7th December 2021, spokesperson for the State Government and Minister for Planning & Coordination, Neiba Kronu stated that an emergency cabinet meeting was called to discuss the firing incident in Mon district and the subsequent incident that followed in Mon town.

Kronu stated that the Cabinet was briefed on the actions taken by the Government including

setting up of a Special Investigation Team headed by an IGP and consisting of four other members, and it was decided that the SIT should complete its investigation and submit its report by one month time. The Cabinet has also decided to write to the Government of India to immediately repeal the Armed Forces Special Power Act, 1958 from the State, he added. He also stated that the Cabinet has decided to support the demands put forward by the Konyak Union to the President of India.

PAINTING COMPETITION ON ENERGY CONSERVATION

As part of the national campaign on energy conservation 2021, a state level painting competition on energy conservation was organised by the Ministry of Power on 8th December 2021 at the East Gate Hotel, Kohima.

Director, School Education Department, Nagaland, Wonhungo Tsopoe said he was happy to see great turnout of students in the competition which will encourage the spread of knowledge about energy conservation. He expressed the need for a wider participation of students from different districts in future. He said education should be for the all round development of a child and children should think out of the box.



IN MEMORIAM: A TRIBUTE PROGRAMME

'In Memoriam,' a tribute programme for the Oting tragedy was held on 9th December 2021 at the Capital Cultural Hall, Kohima.

Chief Minister, Neiphiu Rio in his memorial message stated that the Oting incident was a misuse and abuse of the Armed Forces Special

Powers Act (AFSPA) 1958. He added that the Act is violative of human rights and the Naga people have opposed it for decades.

Rio expressed his condolences to the bereaved families of the 14 victims. He also urged the public to remain strong and courageous, and appealed not to retaliate. He said that it is the time to defeat violence with non-violence and asked the people to shun away from violence and show the nation that AFSPA is not needed. He added that the society cannot allow any force to derail the hard won peace process. The Chief Minister hoped that the country and the rest of the world will not only understand the Nagas' story but also the want for lasting peace.

Former Chief Minister, T. R. Zeliang called for repeal of AFSPA stating that it brought only pain and suffering. He said that no amount of reason can justify the killing of innocent civilians and urged the Government to leave no stones unturned to bring the perpetrators to justice. Zeliang said that when the

Nagas are anticipating the final breakthrough in the Indo-Naga political issue, the Oting incident had come as a rude shock.

President, Konyak Union Kohima, H. Angnyei Konyak shed light on the Oting incident. He called for revocation of the AFSPA adding that the country do not want to see another Oting incident. He also lamented at the misinformation being spread by the media. Konyak expressed his gratitude at the solidarity shown by various sections of the society.

Musical performances were presented by Kewhira Strings Quartet, Nagaland Conservatory of Music Choir, Sanctuary Choir, Union Baptist Church, Chubatolalmsong, Tali Angh & friends, Konyak Youths (East Story), Bozio Nienu and Ameü Üsou Zao Choir.

Chairperson of the programme, Senior Pastor, Kohima Ao Baptist Church, Rev. Sentisashi Aier gave the introductory remark. Deputy Chief Minister, Y. Patton delivered the vote of thanks.

The First Runner's up was bagged by Chaangsangla Y of Wela Foundation School, Tuensang and Second Runner's up was bagged by Arizongla of Jubilee Memorial School, Mokokchung.

APC NAGALAND FORWARDS SEVERAL PROPOSALS DURING ICAR MEETING

APC, Nagaland, Y. Kikheto Sema IAS, representing the State, attended the 25th Regional Committee Meeting of the Indian Council of Agricultural Research (ICAR) through Video Conference on the 11th December 2021. The meeting was chaired by Dr. T. Mohapatra, Secretary, DARE & Director General, ICAR, and attended by the senior officials of Government of India, Vice Chancellors, Heads of ICAR institutions, scientists

and officials of Agriculture & Allied Departments of the North-East Region (NER). Kikheto commented that even after 59 years of Statehood, there is no worth mentioning National or Regional Institute in the State of Nagaland and appealed to consider the following proposals:

- 1. College of Agriculture under Central Agriculture University (CAU), at State**





Agriculture Research Station (SARS) Yisemyong, Mokochung

Kikheto stated that about 70 % of the State's population is engaged agriculture, out of which 73% is under jhum agriculture, which is neither economically viable nor ecologically sustainable. However, it cannot stop jhum cultivation, hence there is a need of College of Agriculture specializing in upland or hill agriculture technologies which will benefit not only Nagaland but the entire hill region of United States of NE India. SARS, Yisemyong is located at 1050 above mean sea level and having 132 hectares of State Government land.

2. Regional Centre for Soil & Water Conservation at State Soil & Water Conservation Training Research and Demonstration Institute at Sechu-Zubza, Kohima

Kikheto spelled out the need to conserve soil and water and creation of water bodies like ponds, spring sheds, revival of springs, rainwater harvesting, check dams, etc. He also stated that after 59 years of Statehood, the Union Government has recently sanctioned for Soil Testing Labs (STLs) in all the 11 districts and Mini STLs in all the 74 blocks of the State. He therefore proposed for a Regional Centre for Soil & Water Conservation to be established at Sechu-Zubza where the Soil & Water Conservation Research and Training Centre have sufficient area of 21 hectares. By this intervention, it would provide a platform to conduct basic and applied research in the field of soil and water conservation in the NER.

3. Regional Livestock Centre on Pigs at Zunheboto

Nagas are mostly non-vegetarian and mostly pork lovers, the requirement being met through imports from other states. It was estimated that meat worth about Rs. 1,000 crores are imported annually to meet the local requirement. Therefore, it is proposed for Regional Livestock

Centre on Pigs at Zunheboto district, which is centrally located in the State where pig feeds can be easily procured and processed even from nearby districts also.

4. Establishment of an Organic Hub with quality control facilities

The State is by and large organic by default. However, there are no Institutes established to facilitate and screen for the quality parameters including certification body. The normal organic certification process takes three years. However, jhum fields remain productive only for two years during which most of the vegetables are produced. Therefore, possibility of certifying as organic after two years was also proposed.

5. Naga Integrated Settled Farming (NiSF)

Kikheto also urged the August House about adopting the Naga Model of Integrated Settled Farming. He stated that NiSF should be adopted by all the Agri & Allied departments in a cluster mode. The most important factor under this model is the availability of water. The components includes agriculture, horticulture, plantation crops, livestock, fisheries, sericulture, post - processing plants, farm roads, power connectivity etc, forming into an economic or business hub, where the educated unemployed can also gainfully participate, ultimately turning into an Agro-Eco tourism.

The APC also informed that already this model is being implemented at Boke-Botsa under Kohima district as a pilot project and if Government of India promotes this model, jhum areas can be reduced and forest protected, thereby increasing ecological services.

The APC also proposed for a Krishi Vigyan Kendra (KVK) for the new district of Noklak. He further assured that the State's Agri & Allied departments will continue to closely work with ICAR and KVKs for the benefit of the farming community.



THREE HEALTH WORKERS FROM NAGALAND AWARDED FOR BEST PERFORMANCE

Three Health Workers from Nagaland have been awarded for Best Performance in New Delhi on 13th December 2021. The three health personnel - Community Health Officer, Viseno Dolie of Anatonger Health & Wellness Centre (HWC), Kiphire; Rhikiuchi, ANM of Phelungre HWC Kiphire and Kesangcette, ASHA of Pungwla HWC Peren were felicitated along with others from 36 States and Union Territories during the observance of Universal Health Coverage Day, 2021 with Union Minister of State, Health & Family Welfare, Dr. Bharati Pravin Pawar as the Chief Guest in New Delhi.

Mahila Shakti Kendra.

The moderator, Juliana Medom, BBBP State Team Leader gave an overview of the various activities conducted under BBBP in the State

including best practices and best performing districts.

Sarah R. Ritse, Commissioner and Secretary, Department of Social Welfare and Administrator, NSSWB urged the multi-sectoral districts to make the BBBP scheme more effective.

Khrienuo Tachü, Chairperson, Nagaland State Commission for Women applauded the District Administration for carrying forward the BBBP scheme in their districts. She further stated that

more interventions in remote villages will create a greater impact.

Neingusalie Theünuo, Assistant Director called for more awareness and training of Anganwadi Workers who are the grassroot workers of BBBP scheme.

The webinar ended with a Question & Answer session, where all the stakeholders shared their opinions and concerns.

MEMBERS VOICE ON REPEAL OF AFSPA DURING NLA SESSION

The Tenth Session of the Thirteenth Nagaland Legislative Assembly (NLA) was held on 20th December 2021 at the NLA Secretariat, Kohima. The members of the NLA observed two minute silence in memory and honour of the 14 (fourteen) people killed at Oting-Tiru village area of Mon district on 4th December 2021.

Commissioner & Secretary, NLA, P. J. Antony reported the assent of the Governor of Nagaland to the following Bills:

1. Nagaland Appropriation (No. 5) Bill, 2021
2. Nagaland Appropriation (No. 6) Bill, 2021
3. Nagaland Appropriation (No. 7) Bill, 2021

Initiating the discussions on the Armed Forces Special Powers Act (AFSPA) Deputy Chief Minister, Y. Patton stated that as per Section 3 of the AFSPA, 1958, the provisions of the said Act come into force in any area to which the Act extends, which gets declared as a 'disturbed area' by the Central Government or the Governor of that State, if in the opinion of either, the area is in such a disturbed or dangerous condition that the use of armed forces in aid of the civil power is necessary. He mentioned that the Government of India has been declaring the entire State of Nagaland as a 'Disturbed Area' by issuing notifications every six months, and thereby keeping the provisions of AFSPA, 1958 operative in the State for the past many decades. The latest notification issued by the Government of India was on 30th June 2021, and it is operational up till 29th of December 2021.

Patton said the provisions of AFSPA, by its nature, scope and intent, gives undue and excessive

powers to the security forces to take several coercive actions like search, seizure, arrest of suspected persons and use of firearms, even to the extent of causing death; for all the actions that may be taken by the personnel of the security forces, there is a great deal of immunity provided to them. He pointed out that the power and immunity has led to many instances of gross abuse by the members of the security forces, over the years, the most recent being the ghastly firing incident in Oting-Tiru village area of Mon district which led to the loss of the lives of 14 (fourteen) Konyak brothers.

Patton informed that the Government of India seeks the opinion of the State Government, before deciding on extending the Notification for Disturbed Area in the State, every six months. The State Government has consistently opposed the Notification declaring Nagaland as a Disturbed Area on the grounds that the overall law and order in Nagaland has been good for many years now, and on and on, many crime and other similar indicators, the situation is found to be better than many other states of the country. Further, all the Naga Political Groups are in ceasefire with the Government of India for many years now. In addition, the ongoing peace talks are proceeding in the right direction giving hope of an early solution to the Naga Political Issue. The Government of India, however, has always been, based on its own assessment, extending the Notification declaring our State as a 'Disturbed Area.' Patton added that the sentiments of our people are strongly against the continuance of AFSPA anymore in our State, that we do not deserve



to be designated as a 'Disturbed Area.' Henceforth, he urged each and every Member of the House to unitedly call upon the Government of India to see the situation on the ground, listen to the voice of the people, and take the most justified and correct step by withdrawing the operation of the AFSPA, 1958 from the State of Nagaland.

Participating in the discussion, Dr. Chumben Murry expressed that the dark side of Indian democracy created by the AFSPA is such that, horrendous acts of omission and commission have been committed under the Act and has caused mistrust, fear and untold miseries on the people of the State. It has served to alienate Nagas from rest of the Country rather than bring them closer for peaceful co-existence. Even after 60 years of the draconian Act, many Indian leaders and the Indian Army alike have not realised or choose to ignore that application of AFSPA continue to result in fostering anti-Indian feelings amongst the people of the State. He stated that at a time when people were hopeful that solution is around the corner, the unfortunate gruesome massacre in Oting, Mon district has created confusions in the minds of the people as to the sincerity of the Central Government as far as the Naga Political Issue is concerned. The intention to hide the crime and misinforming the Union Home Minister to give a wrong statement in the Parliament further angered the people of Nagaland. It is an unforgiveable crime and will never be forgotten. The ghastly act of the Army will definitely be written in the hall of infamous crimes and grievous violation of human rights. Therefore, he appealed to the House to repeal the draconian AFSPA 1958.

MLA, Imkong Imchen said that the 'genocide' committed on 4th December 2021 at Oting village under Mon district is one of the most glaring examples of the thousand genocides committed by the Indian security forces during the last 70 years, calling it a well and pre-planned incident. He added that there were loopholes even on the part of the District Administration and Police, and said it should be thoroughly probed and investigated by a competent authority even higher than the State SIT,

preferably a judicial probe headed by a retired Judge of a High Court or the Supreme Court. He condemned the Union Home Minister's wrong statement of the 4th December 2021 Oting firing incident, calling it misleading and not based on the factual happening, adding that the investigating agency should also take into account of this specific episode. He appealed that the August House passes a resolution urging the Government of India to Revoke/Repeal the AFSPA 1958 from the law of the land in India and make it a redundant/invalid law.

Regarding the Naga Political Issue, Imkong stated that it is almost 25 years since the ceasefire declaration and peace talks in 1997. Till date, there is no sign of any progress/headway being made out of this countless rounds of talks, adding that Naga people deserve to know what is happening to their destiny. Absolute secrecy and confidentiality may be good but only to a certain extent.

Minister Paiwang said that even after the attainment of statehood on 1st December 1963, AFSPA continues to be enforced despite resistance by the Nagas and killings of innocent Naga lives. AFSPA gained more hatred after the Oting-Tiru tragic incident where 13 civilians were killed and another one at Mon Hq. and many critically injured, and be it in the Region, State, North East, National and Internationally, we are witnessing the demand for justice in the form of repealing AFSPA and to punish those people who were responsible for the tragic killing in Tiru and Mon. He said that Nagaland is witnessing peace except for cases of extortions and illegal taxation here and there, we can now see shops and business establishments opening up and leading to economic expansion. So, now is the appropriate moment to repeal the AFSPA and the Disturbed Area Act and make the people of Nagaland and the North Eastern States closer to the nation.

Paiwang said on 4th December 2021 evening, sometime around 16:30 hours, the 21 Para Special Force ambushed and killed six civilians and two persons were critically injured, and after almost five hours gap at around 21:30 hours, another clash took place with the public from the village who came

down looking for the boys who had left the coal mine areas on a pickup bolero towards the village. In the second incident, seven more civilians were killed after which the army fled towards the Assam side. He said that on 5th December 2021, accompanied by Nagaland Commissioner, Nagaland DGP, they reached Oting village and held meeting with the Village Council, pastor and church leaders, GBs, VGs and the village elders, where the government assured them that the high level Special Investigation Team was constituted and justice would be served. He mentioned that the State Government has extended the ex-gratia of Rs. 5 (five) lakh each and the Central Government Rs. 11 (eleven) lakh each to the dead, Rs. 1(one) lakh each to those seriously injured and Rs. 50,000 (fifty thousand) to those with minor injuries.

Paiwang mentioned that justice as demanded by the Eastern Nagaland People's Organisation is repealing of AFSPA from Nagaland and awarding befitting punishment to those responsible for the tragic incident, but equally important is compensating the victims' families in providing government jobs as committed by the Union Home Minister and, he appealed that it must be done at the earliest.

MLA, Y. Vikheho Swu pointed that in the campaign for repeal of AFSPA, so many regional civil society organisations have lent their support. In mainland India too, organisations like the People's Union for Democratic Rights (PUDR) and People's Union for Civil Liberties (PUCL) have championed the effort to have the Act repealed. However, all these efforts have come to no fruition as yet. The latest killings in Oting village have brought the notoriety of the Act into the limelight once again and we must use this opportunity to once again make a concerted effort to have the Act repealed from the law-books of the land where it continues to make an enormous blight. In the light of the above, it is crystal clear that AFSPA has no regard whatsoever for even international laws and the international community has been trying to get the Indian Government to repeal it.

Dr. Chotisuh Sazo, taking part in the


discussion, compared the Armed Forces (Special Powers) Act, 1958 to the Rowlatt Act, 1919. He said that the Act is a tool of State abuse, oppression and discrimination. He added that it promotes a culture of impunity, discards the rule of law and grants a license to kill. Sazo cited various incidents of abuse of the Act by the security forces over the years. He urged for a humanitarian approach rather than the use of force through AFSPA for lasting peace. He suggested Chief Minister, Rio to call upon the Chief Ministers of the North Eastern states to come together and urge the central government to repeal the Act from the region. He also urged the MPs from Nagaland to do same with their counterpart MPs from the region.

Minister, Planning & Coordination, Land Revenue and Parliamentary Affairs, Neiba Kronu advocated for a final solution through trust and understanding rather than the use of force. He stated that the purpose of the UDA Government should not be defeated and that more effort should be given at the juncture. Kronu opined that it is the right time to make the leaders at the Centre to understand the reality.

Leader, NPFLP, T. R. Zeliang taking part in the discussion, stated that no amount of reason can justify the killing of innocent civilians. He said that for a lasting peace in the region, AFSPA needs to be repealed. Stating that justice delayed is justice denied, Zeliang called for justice to be delivered on time. The former Chief Minister lamented at the absence of a State Human Rights Commission and to which, he urged that necessary actions be initiated and the Commission be set up at the earliest.

Minister for Higher Education and Tribal Affairs, Temjen Imna Along while participating in the one-day special discussion on the AFSPA 1958, said that the Oting incident has brought back memories of atrocities meted out to our people through the draconian Act. He said there is no space for such kind of act in a democratic country like India. He strongly condemned the act and appealed for its revocation not only in Nagaland but also in the whole North Eastern region of India.





MLA, Yitachu said the basic fundamental rights including the essence of life are being denied with the existence of AFSPA. He said the Act has no place in a democratic and civilised country. The special provision for Nagaland enshrined in the Constitution of India becomes meaningless because of this very Act. He also vehemently condemned the Act and urged for its revocation.

Advisor, Food & Civil Supplies, Legal Metrology & Consumer Protection and Taxes, Pukhayi said that the law is undue to the North Eastern people of India. He said as long as the Act is in existence, there is no certainty that similar incident would not happen anywhere in Nagaland.

MLA, C. L. John while deliberating on the issue said that the Act should not go hand in hand with democracy in a country like India. He said any prospering country cannot afford to give a step motherly treatment to its citizens. John strongly condemned the incident at Oting under Mon district and appealed to the Government for immediate revocation of the Act. He strongly appealed to the Central Government that intelligence failure and mistaken identity should not be an excuse. Instead, he asked the Central Government to ascertain the case before making any statement.

Chief Minister of Nagaland, Neiphiu Rio in his concluding remark on the one-day special discussion on the Armed Forces Special Power Act, 1958, said AFSPA had its origin in the Naga Political Issue, and the armed insurrection that followed. It was enacted by Parliament in 1958 in order to give the Indian Security Forces certain special powers to deal with Naga armed insurgency; and it was in force only in the then Naga Hills District of Assam. Later on, one by one, it spread to other North Eastern States. At present, it is still in force in Nagaland State, Assam, Manipur (excluding Imphal Municipal Area), and the Naga inhabited districts of Arunachal Pradesh, namely, Changlang, Longding and Tirap. It is also in force in some areas of Arunachal Pradesh, bordering Assam. Outside the North East, it is in force in Jammu & Kashmir since 1990.

In order to deal with the situation, the then Assam Government imposed the Assam

Maintenance of Public Order Act 1953 in the Naga Hills District, and intensified police actions. As the situation became worse, the Assam Government started deploying the Assam Rifles in the Naga Hills, and enacted the Assam Disturbed Areas Act, 1955, arming the State Armed Police and the Assam Rifles with certain special powers to deal with Naga insurgency, but as the State Armed Police and Assam Rifles could not contain the insurgency situation, the Government of India promulgated the Armed Forces (Assam & Manipur) Special Powers Ordinance in 1958, which was subsequently converted into an act by Parliament in the same year. This Act has been generally referred to as AFSPA since then.

There have been many instances of misuse or abuse of the provisions of the AFSPA at the hands of the Security Forces while carrying out their operations in Nagaland and other parts of the NE States, particularly in Manipur and Assam. The latest instance of such abuse being the killing of 14 innocent civilians at Oting and Mon on the 4th and 5th of December 2021 in Nagaland State.

The Nagaland Legislative Assembly is the democratically elected representatives of the people, Rio said the August House must sound the desire of the people. The desire of the people is to repeal this undemocratic and draconian law. Therefore, he urged all the Members of the House to unite in one voice and send out a clear and loud message to the world that Nagas do not want to see this Act anymore. We also need true peace to realise lasting political solution. Impediments like the AFSPA must be removed so that hurdles which are in the way for lasting peace are removed. Removing AFSPA will also contribute towards confidence building, strengthening trust and removing the feeling of alienation in the people's mind.

Nagas have made significant contributions towards the nation building process and our people, especially the youth, are keen to continue making efforts to strengthen the foundations of the country. Therefore, it is all the more crucial to make every effort to build confidence and trust and remove the negative impediments.



Ex-gratia and employment to the next of kin of the deceased families have been assured by the Central Government. However, in case the families of the deceased prefer a job in the State Government, we are ready to give grade III or grade IV as per their qualifications. Medical expenditure for all the injured will be borne by the State, Rio said

Rio appealed to the citizens of Mon district

and its civil societies to extend cooperation to the Government and its agencies in our collective efforts to restore normalcy in the interest of all the citizens. The House appreciated and supported the demand of the citizens and civil society in their demand for justice, while appealing to all sections to follow democratic norms in our collective endeavour towards realisation of justice.

NLA PASSES RESOLUTION

The following resolution was passed during the 10th Session of the Thirteenth Nagaland Legislative assembly:

1. The Nagaland Legislative Assembly (NLA) vehemently condemns the massacre that took place in Oting-Tiru Village area in Mon district on 4th December 2021 in the indiscriminate firing by the 21 Para Special Forces of the Indian Army in which 13 innocent people were killed, followed by killing of one innocent person by security forces at Mon town on 5th December 2021, and injuring of 35 persons during the incidents.
2. The House calls for an apology from the appropriate authority, along with an assurance that justice will be delivered by applying the laws of the land upon those who perpetrated the inhuman massacre and upon those who are responsible for the incident.
3. The House appeals to the citizens of Mon district, its civil societies, the citizens of the State and mass based organisations to extend cooperation to the Government and its agencies in our collective efforts to

demand justice, and to restore normalcy in the interest of all the citizens. The House appreciates and supports citizens and civil society organizations in their demand for repealing of AFSPA and delivery of justice, while appealing to all sections to follow democratic norms and non-violence in our collective endeavour towards realisation of peace and delivery of justice.

4. The Naga people have been crying for peace and an early solution for the long pending Naga Political Issue. It is of paramount importance that the people's voice is heard and respected. The House, therefore, once again appeals to the negotiating parties of the Indo-Naga political dialogue to bring the talks to its logical conclusion by reaching a settlement that is honourable and inclusive at the earliest.
5. The NLA unanimously resolves to demand that the Government of India repeal the AFSPA 1958 from the North East, and specifically from Nagaland, so as to strengthen the ongoing efforts to find a peaceful political settlement to the Naga Political Issue.

During the meeting, Principal, Government Higher Secondary School, Peren said the school building was established in the year 1947 and is in dilapidated condition. She has submitted the agenda for renovation of classrooms and

construction of additional three to four rooms for science laboratory. After taking views and suggestions, the Board agreed to endorse the proposal and further directed the Principal to prepare necessary and relevant documents in support of the proposal.

The Board also approved the proposal for registration of Mithun Society, Tening village, which was forwarded by ADC, Tening.

DC, Peren shared concern in regard to the low coverage of vaccination drive in the district. He said that assistance from the district heads and stakeholders are required in order to ensure 100% successful vaccination drives.

Discussion in regard to strict monitoring of vaccination card at check gates, village adoptions where vaccination coverage is low was also held in the meeting.

ZUNHEBOTO DPDB HOLDS MEETING

Deputy Commissioner (DC), Zunheboto, Peter Lichamo addressing the monthly Zunheboto District Planning & Development Board meeting at DC's Conference Hall, Zunheboto on 8th December 2021.

The monthly Zunheboto District Planning & Development Board (DPDB) meeting was held at Deputy Commissioner's (DC) Conference Hall under the chairmanship of DC, Zunheboto, Peter Lichamo on 8th December 2021.

In an issue raised by one of the members, the Board discussed that unlike many other sub-

divisions of other districts, sub-divisions under Zunheboto are yet to have a fire and emergency services station in its jurisdictions. The Board acknowledging the importance asked the concerned officials to notify and update the details in the next board meeting. The DC lauded the efforts of Public Works Department in improving some key



routes under their jurisdictions connecting Zunheboto to other districts and also appealed to the Heads of Offices to continue to do so in various other possible ways.

The members thoroughly discussed the district not having proper uniformity in its inter and intra district taxi fare, it concluded with the decision

of following the rates which were agreed during the meeting held in the month of March 2021. The concerned administrative heads were also informed to properly monitor whether the rates are being followed. The Board also decided to monitor through proper channel, the legality, rates and quality of LPG and fuel depots in the district.

DC KOHIMA INFORMS ON FIREWORKS

Deputy Commissioner, Kohima, Gregory Thejawielle informed all concerned that bursting of fireworks in 'Silence Zones' that is, an area of at least 100 metres away from hospitals, nursing homes, primary and district healthcare centres, education institutions, courts and religious places is strictly prohibited

The order also added that only crackers with reduced emission (improved crackers) and green crackers will be permitted to be sold through licensed traders and used. The manufacture, sale and use of fire-crackers generating noise level exceeding 125 Db or 145 Db at 4 metres distance from the point of bursting shall be prohibited and the manufacture, sale and use of joined firecrackers (series crackers or laris) have been banned as the same causes air, noise and solid waste problems.

Fireworks containing barium salts are also banned.

On festival days like Diwali, Gurupurab, etc. when fireworks generally are used, the same will be allowed strictly till 10:00 PM only and not beyond. On Christmas Eve and New Year's Eve, when such fireworks start around midnight i.e., 12:00 AM, it would be permitted from 11:55 PM till 12:30 AM only.

DC also informed that as per the Supreme Court directives, though there is no total ban on use of firecrackers, the general public, however, are advised to refrain from and minimize the usage of the same.

The Order have been issued for strict compliance by all concerned to take note of the above directives and ensure strict adherence to the same and the defaulters are liable to be penalized under relevant sections of the law.

INFORMATION EDUCATION & COMMUNICATION (IEC) AWARENESS CAMPAIGN IN MON DISTRICT

Turning Point Organisation which was empanelled by the Public Health Engineering Department (PHED), Mon Division as Implementing Support Agency (ISA) to facilitate constitution of Gram Panchayat i.e. Village Council/ WATSAN Committee, etc. carried out Information, Education & Communication awareness campaign as Jal Jeevan Mission Support Activity starting from 30th November 2021 in 30 villages under Mon district where JJM is being implemented and also in villages where the scheme is currently ongoing.

During the course of the campaign with the Village Council, WATSAN committee, GBs, Asha and Anganwadi workers, church bodies, students, etc., it was highlighted by ISA that in order to implement JJM in their concerned villages for water

supply in adequate quantity on regular and sustainable basis to households and also to provide piped connection to Anganwadi centres, schools, health centres and community hall, the villagers should actively participate in implementation of JJM schemes and contribute 5% in the form of labour/kind/cash which is pre-requisite for implementation of JJM schemes, to have at least five women representative in WATSAN committee for water quality monitoring and surveillance and also to levy water user fee/charge for sustainable Operation & Maintenance (O&M) of the scheme in future and also reiterated that every new household constructed should have its own latrine and open defecation to be totally prohibited in the village and every household should manage grey water from



kitchen and toilet for safe disposal and not to allow it to remain stagnant, which is hazardous and unhealthy.

ISA also impressed upon the villagers to pass resolutions to totally ban Single Use Plastic

(SUP), littering and burning of plastics in the village and that community level awareness campaign around the elimination of SUP will be launched and proper management of the plastic waste will be implemented as per the guidelines issued.

The NEMIS is made in such a way that it can be modified and more features can be added in future as per the needs of the Department.

The e-Classroom Program: The concept of e-Classroom has been introduced in the State even before the onset of the pandemic. During 2020-21, the Ministry of School Education & Literacy, Government of India has approved the use of e-Classroom for 191 Elementary Schools (Classes 6 to 8) and 282 Secondary Schools (Classes 9 to 12) in the State. One of the main purposes for providing



e-Classroom is to enable the students to cope up with their interrupted learning due to lockdown.

The e-contents of each lesson class-wise have been developed according to the SCERT/NBSE curriculum. The pre-loaded video lessons are embedded in pen drives and shall be transacted through Smart TVs. The e-content modules are incorporated with 2D, 3D animations, videos and illustrations to make lessons easier,

engaging and more interactive. The lessons can be updated according to changes in the curriculum. Samagra Shiksha, Nagaland has partnered with Bright Tutee for e-content development.

The ICT e-Classroom program will help the students understand their lesson/concepts better, develop more innovative ideas, queries and solutions to broaden their domain of knowledge and achieve academic excellence.



also stressed on the need to use technology to achieve self-sufficiency. Rio expressed his happiness at various progress and development among farmers and their use of technology.

Minister, Soil & Water Conservation, Geology & Mining and NSMDC, V. Kashiho Sangtam, speaking at the inaugural programme highlighted the activities and projects undertaken by the Department of Soil & Water Conservation while also giving a brief history of the Department. He said that the Department is currently working towards setting up of mini soil testing laboratories in all the 74 blocks in the State. He further shed light on the importance of the soil testing laboratories and how it was helping the farmers in the State. Sangtam also said that the laboratories will benefit not just the farming community in the State but also other State departments who are in the construction sector and

also students and research scholars who can utilize the laboratories for their research and for conducting practicals. In conclusion, he emphasized on the need for everyone to be aware of the importance of soil health and encouraged all to actively participate in keeping the soil alive.

Agriculture Production Commissioner, Y Kikheto Sema, IAS gave the keynote address while the technical report was shared by the State Nodal Officer, Soil Health Management & Additional Director, K Khekiho Shohe. Executive Director/CEO, Octopus Inc, Omesh Boni delivered the commissioning report.

The programme was chaired by Commissioner & Secretary, Soil & Water Conservation and Geology & Mining, K Libanthung Lotha, IAS while Director, Soil & Water Conservation delivered the vote of thanks.

ENTREPRENEURSHIP DEVELOPMENT CENTRE (EDC) LAUNCHED AT GHSS KIPHIRE

Deputy Commissioner, Kiphire, T Wati Aier inaugurated the Entrepreneurship Development Centre at Government Higher Secondary School (GHSS), Kiphire in the presence of Joint Director, Industries & Commerce, Youth Net Kohima, DEO and the staff of GHSS Kiphire on 7th December 2021.

Aier in his speech encouraged the students to make best use of the centre and to set education as the first priority in their life. He stated that skill development is a process of identification of the skill gap in youth and providing training and employment benefits to them. He expressed hope that EDC will benefit the students as well as the unemployed people and requested them to use the centre wisely even in the days to come.

Joint Director, Industries & Commerce, Lipongse Sangtam lamented that the people in the State does not know what entrepreneurship is about.

He added that many people only want to start their business on a large scale and fail. The DC appealed to all the students to take advantage of the EDC and look at the future and to be prepared. He stated that if anyone is interested in online entrepreneurship development course from recognised institutions, they can go for free admission and free course and right after completion of the course, they will be reverted back by the State Government. Sangtam urged all the students to take it as a privilege since the Department will assist them financially in every aspect.

An overview of EDC was given by Youth Net Kohima. The programme was led by S. Imtinano.

EDC is a hands on entrepreneurship mindset programme which gives participants an opportunity to develop essential mindset and skills through the experience of doing a real business.

ICMR DRONE RESOURCE AND OUTREACH LAUNCHED AT MOKOKCHUNG

In order to ease the numerous challenges in vaccine delivery, especially in the hilly areas and remote villages, the Indian Council of Medical Research (ICMR) has taken the initiative in the

implementation of drone resource and outreach in parts of India. Based on suggestions of Ministry of Health & Family Welfare, and permission granted by Directorate General of Civil Aviation, Ministry of Civil



Aviation, two states and one union territory i.e. Manipur, Nagaland and Andaman & Nicobar Islands were considered for this pilot study.

In this pilot project for studying the feasibility of the drone technology in delivery of medical supplies, two districts in Nagaland i.e. Mokokchung and Tuensang were chosen.

The formal launch of the i-Drone activity in Mokokchung was held on 14th December 2021 from Chief Medical Officer's Office to Primary Health

Centre (PHC) Longsa village in the presence of Deputy Commissioner, Superintendent of Police and Deputy CMO, Mokokchung.

Normally, it takes more than one hour to reach Longsa village from Mokokchung town, to cover a distance of almost 30 Km, which may increase during monsoon due to bad road condition. With the drone, it will only take 8 minutes to reach PHC Longsa from Mokokchung town to cover an aerial distance of 11.5 Km.

CM LAUNCHES ONLINE ILP MODULE

Chief Minister, Neiphiu Rio launched the online ILP module portal on 16th December 2021 at the Chief Minister's Residential Complex, Kohima.

Rio stated that the module for online issue of ILPs for tourists was made operational in November 2019. He said the new module will cover other categories such as businessmen, traders, labourers, priests, students and expand online services. He added that it is part of the Government's effort for making public services available in a more efficient and user-friendly manner.

The Chief Minister said that ILP is a tool to protect the indigenous people of Nagaland and is enforced under the Bengal Eastern Frontier Regulation, 1873 and was also agreed as part of the 16-Point Agreement that led to the formation of the State. Similar provisions are also available in Arunachal Pradesh, Mizoram and Manipur. He

added that with strict timelines and monitoring, it should be possible to see that the approval process is not abused and the ILP applicants are also happy.

Rio said online ILP would enable authorities to capture all data of visitors to the State, analyse it and help in planning better for various facilities. He advocated more government services online so that the public can avail services through their computers, mobile devices or through Computer Service Centres. He also stated that websites should not be only tools for providing information but should provide services online within a short time limit.

Briefing on the online ILP module, Principal Secretary, Abhijit Sinha, IAS said that with the new module, all categories of visitors can now apply online for permits at the comfort of their homes and added that payment for applications can be made

online for all categories. Sinha informed that offline mode will continue for some time and the Government will take a final call on it later.

Advisor, Information Technology & Communication, Science & Technology, New & Renewable Energy, Mmhonlumo Kikon informed that till date, a total of 17,786 online ILP applications

have been received. He said that the new module is easy to use and it can be accessed by everyone. Kikon stated that with the new module in place, the State will be able to check the outflow and inflow of visitors to the State.

the District does not have COVID-19 RT-PCR testing facility.

The drone equipped with about 3000 units of medical supplies took about 26 minutes to reach Tuensang from Mokokchung. According to the iDrone project team, over 7000 units of medical supplies have been transported to Nagaland through this project


Y. PATTON INAUGURATES FAIRFILL FUEL STATION AT WOKHA

HEALTH CARE WITH COFFEE

(A DIPR feature by Kiso, IA, Peren)

Coffee is a brewed drink prepared from roasted coffee beans, the seeds of berries from certain coffee species. From the coffee fruit, the seeds are separated to produce a stable, raw product - unroasted green coffee.

The health benefits from coffee are as follows:

- * Two cups of coffee could cut post-workout muscle pain upto 48%.
- * **Increases fibre intake:** One cup of brewed coffee contributes upto 1.8 gram of fibre.
- * **Protects against liver cirrhosis:** Both coffee and decaffeinated coffee lowers the liver enzyme level.
- * **Lowers type two diabetes:** Daily cup of coffee consumed decreases type two diabetes by 9%.
- * **Lowers Alzheimer's disease:** There is considerable evidence that caffeine may protect against Alzheimer's disease (European Journal of Neurology).
- * **Reduces depression:** Harvard School of Public Health found that women who drink four or more cups of coffee were 20% less likely to suffer from depression.
- * **Protects against Parkinson's disease:** Research in Sweden revealed that drinking coffee reduces risk of Parkinson's even when genetic factors come into play.
- * **Coffee drinkers have less risk of heart disease:** Korean researchers found that participants who consumed three to five cups of coffee in a day were less likely to show signs of disease.
- * **Coffee drinkers have stronger DNA:** European Journal of Nutrition showed that the white blood cells of coffee drinkers had far less instance of spontaneous DNA strand breakage.
- * **Lowers risk of Multiple Sclerosis (MS):** At least four cups of coffee in a day help protect against the development and reoccurrence of MS.
- * **Reduces colorectal cancer risk:** Even moderate consumption of coffee could reduce the odds of developing colorectal cancer by 26%.
- * **Reduces liver cancer risk:** Researchers at USC Norris Comprehensive Cancer Centre found that those who consume one-three cups of coffee in a day have a 29% reduced risk of developing liver cancer.
- * **Less gout risk:** Risk of developing gout in man decreases with increase in coffee consumption.
- * **Prevents retinal damage:** A Cornell University study showed that coffee may prevent retinal damage due to oxidative stress.
- * **Black coffee prevents cavities:** Researchers in Brazil found that strong black coffee kills the bacteria on teeth that lead to tooth decay.
- * **May protect against periodontal disease:** The US Department of Veterans Affairs Dental Longitudinal study has linked coffee consumption to dental health.
- * **Reduces heart attack mortality risk:** Researchers found that those who drink two or more cups of coffee daily after having a heart attack have the least risk of dying from heart attack.
- * **USDA recommends for better health:** The USDA's new 2015 dietary guidelines recommend it for better health.
- * **Helps to get along with co-workers:** The Journal of Psychopharmacology showed that the workers/ work places who consume coffee have a more positive view of self and others.

NSBB APPEALS FOR BIODIVERSITY CONSERVATION*(A DIPR feature)*

The survival of human beings and animals, both directly as well as indirectly, depends on biodiversity, as their basic needs in the form of food, water, and shelter are met from biodiversity. In addition to these tangible benefits, biodiversity plays a key role in carbon sequestration, amelioration of environment and climate change.

The Convention on Biodiversity (CBD) was signed by the world leaders in the Earth Summit at the Rio de Janeiro in June 1992 by having realized the importance of biodiversity for survival and development of human beings. Different countries of the world enacted Acts and framed rules for conservation of biodiversity, its sustainable use and equitable distribution of benefits accruing from its use and associated traditional knowledge. In our country, the Biodiversity Act was passed in 2002 and the Biodiversity Rules were framed in 2004 for achieving the aforementioned objectives. The Biodiversity Act had been ratified by the State Legislators and the Nagaland Biodiversity Rules, 2012 had been made for biodiversity conservation.

With the active support of the Forest Department/ District Administration/ Rural Development Department, Biodiversity Management Committees (BMC) have been constituted in the State in 1266 villages out of 1285

villages for achieving the objectives of the Convention on Biodiversity (CBD). The constitution of BMC in remaining villages of the State is under progress.

The content of the Section 7 of the Biological Diversity Act, 2002 is as under:

'No person, who is a citizen of India or a body corporate, association or organisation which is registered in India shall obtain any biological resources for commercial utilisation, or bio-survey and bio-utilisation for commercial utilisation except after giving prior intimation to the State Biodiversity Board concerned.

Provided that the provision of this Section shall not apply to the local people and communities of the area, including growers and cultivators of biodiversity, and *vaid*s and *hakims*, who have been practicing indigenous medicine.' (Prior intimation to State Biodiversity Board for obtaining biological resources for certain purposes)

The Nagaland State Biodiversity Board has appealed to the public, government officials, Village Councils, army and para military personnel, students, NGOs and other stakeholders for protection and conservation of biodiversity. Any applicant, seeking extraction of biological resources for research or commercial purpose may apply to the Nagaland State Biodiversity Board.


