## **NOTIFICATION**

Whereas, the Government of Nagaland vide Notification NO.MA-65/2016 (Pt-I) dated 9<sup>th</sup> March 2023 in exercise of the powers conferred by Section 25 (1) of the Nagaland Municipal Act 2001, has issued direction to the State Election Commission, Nagaland to hold the General Election to constitute the Municipal Councils and Town Councils in the State of Nagaland along with 33 per cent reservation of seats for women as notified vide the said Notification, which are enclosed as Annexure-I and Annexure-II.

Now therefore, **I, Shri T. Mhabemo Yanthan**, **IAS**, State Election Commissioner, Nagaland in exercise of the powers conferred under sub-section (2) of Section 25 of the Nagaland Municipal Act 2001 read with sub-rule (1) and (2) of Rule 20 of the Nagaland Municipal Rules, 2003, hereby notify the **'Election Programme'** to conduct the general election to 3 Municipal Councils and 36 Town Councils in the State as per the schedule indicated hereunder:

#### **IDENTIFICATION OF VOTERS:**

In order to safeguard against personation under Rule 54 of the Nagaland Municipal Rules 2003, the State Election Commission has decided that compulsory identification of the voters will be made in the ensuing General Election to the Municipal Councils and Town Councils in the State. The State Election Commission shall issue separate instructions in this regard.

#### **MODEL CODE OF CONDUCT:**

With the announcement of the 'Election Programme' through this publication, the Model Code of Conduct for guidance of all the Political Parties and Candidates, adopted by the State Election Commission contained in the Model Code of Conduct for guidance of political parties and candidates, 2004 will come into force with immediate effect within the entire Municipal and Town Council areas going to poll. This will be applicable to all Candidates, Political Parties in the State and the State Government Machinery.
