SCHOOL EDUCATION CLARIFIES ON SMILE APP

The Department of School Education has informed in a notification that in connection with the implementation of SMILE App in all government schools and establishments under the Directorate of School Education (DoSE), the department has been receiving numerous queries regarding issues with the App. These concerns have been acknowledged and are being actively addressed. All concerned are thereby informed that the SMILE App has been updated since the pilot phase in May 2024.

To ensure that all employees have the latest version, the following instructions below are to be followed:

1. Uninstall the old SMILE App
2. Download the latest version of SMILE App that is available on Google Play Store for Android users and Apple App Store for iOS users.
3. If one is unable to mark attendance due to network issues, switch to offline mode. Once the network is available and stable, go back online to sync the attendance.
4. For any other queries, one can reach out to the helpline service numbers - 6909644519, 8974102488 and 6900222184.

H&FW INFORMS ON PACKAGED DRINKING WATER

The Department of Health & Family Welfare (H&FW) has informed that, in pursuance to Notification No.REG-11027/2/2022-Regulation-FSSAI, New Delhi, the 17th October 2024, some regulations under Food Safety and Standards (Prohibition and Restrictions on Sales) Regulations, 2011 has been amended and has come into force.

Under the Regulation 2.3, Sub-Regulation 2.3.14, Clause 17 and 18 mentions that “No person shall manufacture, sell or exhibit for sale packaged drinking water and mineral water except under the Bureau of Indian Standards (BIS) Certification Mark.” Clauses 17 and 18 have been omitted.

Therefore, Food Business Operators manufacturing water does not need to obtain BIS Certification Mark. However, they will have to mandatorily obtain Food Safety License Certificate through the online portal <https://foscos.fssai.gov.in>. Water test report shall be a mandatory document and the water needs to be tested in one of the Food Safety & Standards Authority of India Notified Laboratory having the scope of testing Packaged Drinking Water and Mineral Water.

The bottle of the packaged drinking water should be legibly marked with these details:

1. Name of the product
2. Name and address of the manufacturer
3. Brand name, if any
4. Lot/Batch number
5. Date of processing/packaging
6. Best before date

7. FSSAI logo and license/registration certificate number

This notification supersedes the previous notification NO.DHFW-21/FSSA/BIS/13/2021-22/274-79 dated 25th July 2024. For further assistance, one can visit the Food Safety Section, CMO's Office of Kohima, Mokokchung and Dimapur.

This is issued in the interest of public health. Failure to comply with the notification shall be a violation of Section 58 and 63 of FSSA 2006.

NHPS INFORMS ON ABPM-JAY AND CMHIS

The Nagaland Health Protection Society (NHPS) is the implementing agency of the Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB PM-JAY) with annual insurance cover of Rs. 5 lakh per household and Chief Minister Health Insurance Scheme for Employees and Pensioners (CMHIS) with annual insurance cover of Rs. 20 lakh per household for employees and pensioners and Rs. 5 lakh per household for families who are not covered under AB PM- JAY or not a government employee or pensioner.

The CMHIS is financed by converting 50% of the monthly medical allowance of employees and pensioners and the corpus is maintained by the Finance Department in a dedicated Savings Bank Account. Any additional expenditure beyond the insurance cover of Rs. 20 lakh per household for government employees is reimbursed through the salary head of the concerned department.

The AB PM-JAY is financed by the Central and State Governments in the ratio 90:10. However, the entral share for premium is capped at 90% of Rs. 1052/- per household and any excess amount beyond this ceiling is paid by the State Government in addition to the 10% State Share. As a result, for the Policy Year 2024 - 25, the State Government's Share is 51% and the Central Government's Share is 49%.

For the current policy period (April 2024 - March 2025), the implementing insurance company is Future Generali India Insurance Co. Ltd. (FGI). The discovered premium payable to the insurance company is Rs. 1950/- per household for insurance cover of Rs. 5 lakh (AB PM-JAY and CMHIS General Category) and the premium for CMHIS (EP) is Rs. 3860/- per household for insurance cover of Rs. 20 lakh. The premium is payable in three installments

and premium payments are made to the insurance company immediately upon fund release by the Government as insurance coverage cannot commence without upfront premium payment as per IRDAI regulations. Out of the total premium of Rs. 92 crore payable, a total of Rs.90 crore (upto third installment of state share and second installment of central share) have been paid to the insurance company as of date. Accordingly, there is no default on payment of premium to the insurance company.

As of 16th February 2025, the following claims have been processed by the Insurance Company:

For PMJAY: A total of 30,379 claims amounting to Rs. 57.34 crore have been approved. Out of these, 22,914 claims totaling Rs. 42.71 crore have been paid to various hospitals.

For CMHIS: A total of 17,501 claims amounting to Rs. 72.32 crore have been approved. Out of these, 11,638 claims totaling Rs. 47.20 crore have been paid to various hospitals.

H&FW INFORMS ON ASSISTANCE UNDER NIRAMAYA HEALTH INSURANCE SCHEME

The Department of Health & Family Welfare (H&FW) has informed that, with the aim at improving access to healthcare and support services to individuals with Autism, Cerebral Palsy, Mental Retardation and Multiple Disabilities, the Ministry of Social Justice and Empowerment launched the Niramaya Health Insurance Scheme administered by the National Trust.

The Niramaya scheme ensures comprehensive coverage, offering up to Rs.1 lakh annually to eligible beneficiaries for hospitalization, therapy, corrective surgeries and alternative medicines.

To avail the benefits, one must enroll and register with the National Trust. The following documents are required for registration- disability certificate having UDID card or UDID enrollment number with PWD certificate, Address proof, Income certificate (for Above Poverty Line), Enrollment fee Payment proof. The enrollment and application must be facilitated through any Registered Organization (RO) registered with the National Trust. The Registered Organization (RO) in the State are given below:

MANDATORY MALARIA SCREENING AND REPORTING: A CALL TO ACTION FOR ALL HEALTHCARE PROVIDERS

The National Vector Borne Disease Control Programme (NVBDCP), Department of Health & Family Welfare, Government of Nagaland urges all private and public healthcare providers to screen all fever cases for malaria. Since it is in the elimination phase, it is crucial that no malaria case goes undetected.

In the interest of public health and to ensure early diagnosis, proper case management, and a reduction in malaria burden, the Government of Nagaland, exercising the powers conferred under Section 2 of the Epidemic Diseases Act, 1897, mandates that all healthcare providers, NGOs, Civil Society Partners, and other stakeholders must report every malaria case to the respective authorities. The positive case details must be immediately conveyed to the Chief Medical Officer, the District Vector Borne Disease (VBD) Officer, or the State

Programme Officer to enable epidemiological assessment and the implementation of necessary preventive measures.

Case definition for Malaria:

Probable Malaria Fever:

- A suspected malaria case is defined as a patient with fever in an endemic area during transmission season or someone who has recently travelled to an endemic area.
- A case consistent with malaria symptoms, including high fever, chills and rigor, headache, body ache, nausea, vomiting, or unexplained fever.

Confirmed Malaria Fever (Pv/Pf): A malaria case is confirmed when the presence of the parasite is detected using at least one of the following diagnostic methods:

- Microscopy of blood for malarial parasite
- Antigen-based bi-valent Rapid Diagnostic Kit (RDT), and/or
- Molecular diagnostic test.

Mandatory Reporting by Healthcare Providers: For the purpose of this notification, healthcare providers include clinical establishments managed by the Government (including local authorities), private or NGO sectors, and individual practitioners registered under the Clinical Establishment (Registration & Regulation) Act, 2010.

Doctors in Government health institutions and registered private medical practitioners are required to immediately notify the District Health Authority if a confirmed malaria case is detected in their respective healthcare facilities.

Legal implications: Under the Epidemic Diseases Act, 1897 (Act No. 3 of 1897), failure to comply with these regulations will be deemed an offense punishable under Section 188 of the Indian Penal Code (45 of 1860). Strict legal actions will be taken against those who do not adhere to the mandatory reporting requirements.

NVBDCP seeks the cooperation of all healthcare providers, organizations, and individuals in this collective effort to eliminate malaria and safeguard public health.

MANDATORY DENGUE TESTING AND CASE NOTIFICATION: ADVISORY FOR HEALTHCARE PROVIDERS

The National Vector Borne Disease Control Programme (NVBDCP), under the Department of Health & Family Welfare, Government of Nagaland urges all private and public healthcare providers to adhere strictly to the issued notification regarding Dengue testing and reporting.

As clearly stated, a Rapid Diagnostic Test (RDT) positive result for Dengue is only indicative of a probable case. Therefore, all RDT-positive cases must be confirmed through ELISA testing at designated district hospitals in Dimapur, Mokokchung, Wokha, Kiphire, Mon, and NHAK.

In the interest of public health and to ensure early diagnosis, effective case management, and the reduction of Dengue transmission, the Government of Nagaland mandates that healthcare providers notify every Dengue case to the Chief Medical Officer of the district on a

weekly basis, and daily during the transmission period.

Case definition for Dengue:

Probable DF/DHF:

A case consistent with Dengue Fever symptoms include an acute febrile illness of 2-7 days duration with two or more of the following manifestations - Headache, Retro-orbital pain, Myalgia, Arthralgia, Rash, Haemorrhagic manifestations.

A case with a Non-ELISA based NS1 antigen/IgM positive result from an RDT will be considered probable due to the poor sensitivity and specificity of currently available RDTs.

Confirmed Dengue Fever: A case consistent with the clinical description of Dengue Fever and confirmed by at least one of the following laboratory tests:

- Detection of Dengue virus antigen in serum via NS1 ELISA
- Demonstration of IgM antibody titre by ELISA in a single serum sample
- Detection of viral nucleic acid through Polymerase Chain Reaction (PCR)
- Isolation of the Dengue virus from serum, plasma, or leucocytes
- IgG sero conversion in paired sera after two weeks with a fourfold increase in IgG titre

Mandatory reporting by healthcare providers: For the purpose of this notification, healthcare providers include clinical establishments managed by the Government (including local authorities), private or NGO sectors, and individual practitioners registered under the Clinical Establishment (Registration & Regulation) Act, 2010.

Doctors in Government health institutions and registered private medical practitioners are required to immediately notify the District Health Authority of their respective districts if a suspected Dengue case is reported in their healthcare facility.

All blood samples of suspected Dengue cases must be sent to the Sentinel Surveillance Hospital (SSH) for ELISA-based testing. A patient can only be declared Dengue-positive based on ELISA results and not on RDT results. RDT-based testing (using NS1 or IgM) can only indicate a probable Dengue case, while IgG testing alone is not a valid indicator.

Healthcare providers must promptly report all confirmed Dengue cases to the Office of the respective Chief Medical Officer immediately after diagnosis to facilitate proper epidemiological assessment and timely intervention.



SLA SCERT, NAGALAND GETS CERTIFICATE OF EXCELLENCE FOR 2nd CONSECUTIVE YEAR

The School Leadership Academy (SLA), SCERT, Nagaland was presented the Certificate of Excellence for the second consecutive year in recognition of its commendable work in School Leadership Development during the three-day National Review & Planning workshop held from 29th to 31st January 2025 at India Habitat Centre, New Delhi, organized by National Centre for

School Leadership (NCSL), National Institute of Educational Planning and Administration (NIEPA), New Delhi.

SLA, Nagaland, under the establishment of SCERT, caters to training of school leaders in the state, develops video documentary and case studies on the best practices by school heads in their schools.

ASSAM-NAGALAND STUDENT EXCHANGE PROGRAMME HELD

Three-day Assam-Nagaland Student Exchange Programme held under the theme “Discovering Neighbours,” successfully concluded on 1st February 2025 at Government High School, Tzürangkong. Organized by the Border Peace Coordination Committee (Assam-Nagaland) in collaboration with the Friendship Forum (Tembayim Committee, TATT, Tzürangkong) and the District Administration of Jorhat and Mokokchung, the programme aimed to strengthen cross-border ties and promote peaceful coexistence.

The culmination programme featured Deputy Commissioner of Mokokchung, Thsuvisie Phoji, who lauded the initiative as a significant step toward fostering lasting friendships between the people of both the states. Emphasizing the importance of countering antisocial elements that attempt to disrupt peace along the border, the DC said “We are not enemies but brothers and sisters. Such initiatives should not be confined to border areas but extended across

both the states to eradicate hatred and misunderstandings.’ Phoji also encouraged the students to cherish the experience and become ambassadors of peace.

A total of 30 students from two schools in Assam, along with 30 students from Government High School, Tzürangkong participated in the exchange programme. They were accompanied by parents, guardians and teachers, with the Assam students being hosted by families in Chungtiayimsen, Watiyim, and teachers of the host school. The participants engaged in sports, cultural exchanges, talent shows, and picnics, fostering deeper understanding and friendship.

This kind of exchange programme aims to heal historical tensions along the Assam-Nagaland border, emphasizing the shared heritage of both communities. By connecting young minds, it seeks to instill a sense of unity and responsibility in sustaining peace and cooperation for the future.

NAGALAND JOINS NATIONWIDE LAUNCH OF WATERSHED YATRA CAMPAIGN

A state level launch programme of Watershed Yatra was held at the Directorate

of Land Resources, Kohima on 5th February 2025 with G. Ikuto Zhimomi, Advisor, Land

Resources, Nagaland as the guest of honour.

G. Ikuto Zhimomi in his address, lauded the initiative and stressed on the need for collaborative efforts to address the challenges of water scarcity and land degradation. He reiterated the government's commitment to supporting community-based watershed management projects and empowering rural communities. He said that this mass outreach programme will help to ensure the sustainable use of land and water resources for our future generations.

Albert Ngullie, CEO, SLNA, Nagaland, and Director, Land Resources, delivered the keynote address, highlighting the importance of the Watershed Yatra in the context of the state's unique ecological landscape. He encouraged every citizen to create awareness at both an individual and community level for sustainable utilization and management of our natural resources.

A key highlight of the event was the felicitation of progressive farmers who have made significant contributions to water conservation and sustainable agriculture. This was followed by an experience-sharing session by Kekhrielezo Zuyie, Proprietor,

KK Wood Touch Furnitures, beneficiary of the Pradhan Mantri Kisan Sampada Yojana- Watershed Development Component (PMKSY-WDC 2.0).

The Yatra involves a series of activities including developing watershed projects like percolation tanks, check dams, Watershed Mahotsav to create awareness and encourage community participation, Watershed Ki Panchayat, to involve the community in developing and implementing policies around watershed development.

The State Level Launching Programme was followed by the National Level Virtual Launching Programme conducted through webcasting in which Shivraj Singh Chauhan, Union Minister of Agriculture and Rural Development flagged off the Watershed Yatra virtually.

The initiative aims to promote the adoption of scientific watershed management practices, enhance water security, improve agricultural productivity, and generate employment opportunities in rural areas, ultimately leading to the holistic development of the state.

The Watershed Yatra Campaign, a

20-Day Yatra, initiated under Ministry of Land Resources, Government of India and organised by the Department of Land Resources, Nagaland, covering four districts of Nagaland, culminated in its last destination at Asukiqa village, Zunheboto, incorporating four other villages in its area, namely Ghokimi, Kitami, Tsaphimi and Puneboqa, on 24th February 2025.

While delivering the keynote address, chairperson of the programme, Assistant Inspector, Land Resources, Roselyn Chishi highlighted that 'Watershed Yatra' is a mass outreach campaign to create awareness about watershed development activities carried out under Watershed Development Component of Pradhan Mantri Krishi Sinchayee Yojana (WDC-PMKSY 2.0) project areas across 27 States and 2 Union Territories, tentatively launched from 17th January 2025.

The nationwide campaign subsequently helps in achieving 'Community Driven Approach (Jan Bhagidari),' which needs to be adopted for implementation of watershed projects, as per extant guidelines, and also galvanise the implementation machinery at field level, Roselyn concluded. The programme witnessed 'Handing over of assets (Lokarpan)' wherein Alowoni SHG, Kitami village was felicitated with solar dryer under Livelihood, Micro-Enterprises and Business Development, which was administered by Additional Director, Land Resources, Hekato N.

Shramdaan activities comprising of 'Bush management at coffee plantations and digging of compost pits at coffee farms' by Watershed Committee, Ghokimi village was also carried out.

NHHDCCL ORGANISES NATIONAL HANDLOOM EXPO AT NEW DELHI

National Handloom Expo, which was organized by the Nagaland Handloom & Handicrafts Development Corporation Ltd. (NHHDCCL) - a Government of Nagaland undertaking, was inaugurated by Dr. M. Beena, IAS, Development Commissioner for Handlooms, Ministry of Textiles, Government of India at Handloom Haat, Janpath, New Delhi on 7th February 2025.

Dr. M. Beena, IAS expressed her happiness in the visibility that NE handlooms is gaining which, she added, is rightly deserved. She stated that weavers who come to the Handloom Haat, about 60% of them are from NE and that such handloom expo is to give the weavers an understanding of what the market and consumers are looking for, and help the weavers to cater to the choice of customers. Stating that the materials produced in NE has a lot of export potential,

Dr. M. Beena encouraged corporations, such as NHHDCCL to engage more with the Handloom Export Promotion Council, so as to increase exports internationally.

Dr. M. Beena stated that it is the right opportunity for the NE to come and showcase their handloom before the world and expressed confidence in the potential of handloom in the international market and said that we are in an era of 'slow fashion,' as consumers become more conscious of ethical and responsible fashion and with the handloom industry producing less carbon footprint, it can be a premium section in the international market.

Prasielie Pienyu, Chairman, NHHDCCL, Dimapur thanked the Office of the Development Commissioner, Ministry of Textiles, Government of India for sponsoring the National Handloom Expo and expressed

hope that more of such national expos will be held in the future as well.

Wennyei Konyak, Resident Commissioner, Nagaland House New Delhi, Er. Y. Lipongse Thongtsar, Managing Director, NHHDC, officials from Ministry of Textiles, GoI, NHHDC Dimapur and Nagaland House, New Delhi were among those present during the inaugural function. Altogether 80 stalls were set up.

JEE MAIN 2025: CSAB LAUNCHES AWARENESS DRIVE FOR NORTH-EAST STUDENTS

To raise awareness among students from North-East (NE) states about registering for JEE Main 2025, the Central Seat Allocation Board (CSAB) 2025 conducted a press conference at Kohima Press Club office, Kohima on 11th February 2025. The initiative aims to increase participation by highlighting reserved seats and dedicated support through the CSAB counselling process.

Officials emphasized the availability of nearly 24,000 seats across NITs in India, including 2,000 reserved seats under the State Quota for NIT+ institutions in NE states and 740 additional seats nationwide for NE students through CSAB-NEUT counselling.

The press conference was led by Prof. Anindya Basu, Chairman, Local Organizing Committee, CSAB 2025,

along with Prof. Pankaj Kumar Sa (Vice-Chairman), Prof. Surajit Das (CSAB 2025 Media Representative), Dr. J. Arul Valan (Admissions In-charge, CSAB 2025), and Dr. Wati Walling (Dean Academic, NIT Nagaland).

Despite over 15 lakh candidates appearing for JEE annually, participation from the North-East remains below 1%. CSAB officials stressed that increasing awareness and enrolment could provide significant educational and economic opportunities, benefiting both students and local communities.

JEE Main serves as the gateway to India's top technical institutions, collectively known as the NIT+ system, which includes 31 National Institutes of Technology (NITs), 26 Indian Institutes of Information Technology (IIITs), 3 Schools of Planning and Architecture (SPAs), 37 Government-Funded Technical Institutes (GFTIs) and IIST, Shibpur

Students who passed Class XII in 2023, 2024, or are appearing in 2025 are eligible to register for JEE Main 2025. The CSAB counselling process provides several advantages like exclusive seat reservations for NE students, multiple admission chances through two CSAB Special Rounds, seamless online counselling with multilingual support, diverse course options in emerging technology fields, enhanced career prospects with placements in PSUs, government agencies, and top tech firms.

With expanding career opportunities in NIT+ institutions, the CSAB 2025 team is urging students from Nagaland and the North-East to seize this opportunity. Officials are seeking support from local media, educational institutions, and government bodies to maximize awareness and participation.

INDIAN DELEGATION VISITS NEW ZEALAND TO STRENGTHEN COOPERATION IN KIWI FRUIT DEVELOPMENT

A five-member Indian delegation, including two representatives from Nagaland Meyasashi, Director of Horticulture, and S. Senka, Joint Director, Horticulture, Nagaland visited New Zealand from 12th to 15th February 2025.

The visit was organized by the New Zealand Embassy in Delhi as part of the roadmap and strategy for the development of the kiwifruit industry in India, in collaboration with Zespri International Limited, New Zealand. Over the course of four days, the delegation engaged in extensive discussions with key stakeholders in Auckland, New Zealand, including the Consul General of India, the India-New Zealand Business Council, scientists from Plant & Food Research and the Kiwifruit Breeding Centre, the CEO and officials of Zespri International Ltd. and Māori kiwi

fruit growers.

The team also visited multiple kiwifruit orchards, export packhouses, and kiwifruit nurseries to gain insights into best practices in cultivation, post-harvest management, and export procedures on kiwifruit.

Nagaland, being the second-largest kiwifruit producing state in India, stands to benefit significantly from international collaborations, especially with New Zealand, the world's leading producer and exporter of Kiwifruit. With initiatives undertaken by both the Central and State Governments to foster global cooperation in the kiwifruit industry, the exchange of expertise and advanced techniques is expected to enhance kiwifruit cultivation across the country, driving economic growth and improving the livelihoods of farmers, particularly in states like Nagaland.

NFMP WINS PRESTIGIOUS SKOCH AWARD

Nagaland Forest Management Project (NFMP) was awarded the prestigious SKOCH Award 2024 during an award ceremony organized for national award winners as part of the 100th SKOCH Summit held at Silver Oak Hall, India Habitat Centre, Lodhi Road, New Delhi on 15th February 2025. Anjo Konyak, DCF (HQ) and Deputy Project Director, NFMP along with Wennyei Konyak, Resident Commissioner, Nagaland House, New Delhi received the award on behalf of the Department of Environment, Forests & Climate Change (DEFCC), Government of Nagaland (GoN).

The NFMP is a project implemented by DEFCC, Government of Nagaland which is assisted by Japan International Cooperation

Agency (JICA). The project aims to improve forest ecosystems and support income generation by rehabilitating Jhum areas and supporting livelihoods. It focuses on sustainable forest and environment conservation and improving livelihoods in targeted villages through need based, village specific interventions led by Joint Forest Management Committees.

The project period is from 2017-2027. It will cover 185 villages in 11 districts and 22 Forest Ranges. It will cover an area of 79,096 hectare under Forest Intervention and also aims to form 555 Self Help Groups under livelihood component.

The SKOCH Award stands as one of the highest independent honors bestowed

upon states and organizations. The award is known for its rigorous and independent outcome based assessment process. SKOCH Group, the organizers of the award, is India's leading think tank dealing with socio-

economic issues, with focus on inclusive growth, since 1997. It has instituted India's highest independent civilian honours in the field of governance, technology, economics and social sector.

STATE TRANSPORT DEPARTMENT OFFICIALS AND PAWAN HANS LTD. VISITS KOHIMA

A team from Pawan Hans arrived in Kohima on 18th February 2025 to conduct inspections under the Regional Connectivity Scheme (RCS) UDAN. The assessment focuses on infrastructure and feasibility in five districts - Tuensang, Mokokchung,

Zunheboto, Kohima, and Phek (selected under the first phase of the scheme). The initiative aims to enhance regional air connectivity, improving accessibility and economic opportunities for residents in Nagaland's remote areas.

In a meeting with the inspection team and transport officials, Transport Secretary, Robert Longchari highlighted key developments and challenges. While infrastructure is largely in place, some financial approvals and minor modifications, such as fencing and helipad upgrades, remain. The government must also address legal and land acquisition hurdles before operations begin. He emphasized that

the helicopter service will significantly benefit not just district headquarters but also sub-divisions, particularly in medical emergencies and subsidized transport. Given Nagaland's challenging road infrastructure, air connectivity is expected to provide a crucial alternative.

Pawan Hans has begun evaluating the existing facilities, with plans to construct additional helipads over time.

DISTRICT ATTACHMENT PROGRAMME OF 54th BATCH NSS (P) HELD

1st SLCC ON 8th ECONOMIC CENSUS 2025-26 HELD IN KOHIMA

The first meeting of the State Level Coordination Committee (SLCC) on the 8th Economic Census was held under the chairmanship of Chief Secretary, Dr. J. Alam, IAS on 19th February 2025 at the Chief Secretary's Conference Room, Civil Secretariat, Kohima.

Secretary, Economic & Statistics, Akunu S. Meyase initiating the meeting, said that the Economic Census is the head count of all establishments/entrepreneurial units and workers employed within the geographical boundary of the country with particular focus on non-agricultural sector. Akunu also informed that till date, seven Economic Censuses have been conducted by the Ministry of Statistics and Programme Implementation (MoSPI) in collaboration with States and Union Territories.

Meyase added that the 8th Economic Census 2025-26 will be conducted in collaboration with States and Union Territories using advanced Information Communication Technology (ICT) platform which would facilitate geo-codes embedded data collection on mobile devices, real time data validation and scrutiny and interactive Management Information System (MIS)

dashboards for monitoring and supervision.

The meeting was convened for identifying the mechanism in which the State intends to fulfill the requirement of contractual manpower & IT personnel and identification of master trainers. The meeting also discussed the activation of District Level Coordination Committee (DLCC) in the district and requirement of IT expert for each district to resolve IT related issues. During the meeting the Department also briefed the members that government employees' service will be utilised from various departments and they will be deployed as enumerators and supervisors.

The Chief Secretary urged the Heads of Departments of the concerned departments to give instructions to the district level officials to provide all the support and necessary assistance, and asked all the Deputy Commissioners to conduct meeting and to start the census operations. He also nudged the Department to use social media platform to promote awareness and sensitised the public on the Economic Census.

The Department informed that 1st week of April is tentatively scheduled for roll out of the 8th Economic Census across the country.

Commissioner & Secretary, Information Technology & Communication, Mohammed Ali Shihab, IAS said there are 397 villages in Nagaland which are not covered with mobile

towers and informed that the Government is trying its best to provide with 4G network. He urged all the participants to pay attention and understand the problem of different network issue so that when one leaves his/her respective district, some improvements are made in addressing the problems of that area. He called on to emphasis on the importance of my Bharat Net, a robust technology to empower the future of internet.

Administrative officials from the 17 (seventeen) districts attended the two-day training which was hosted by the Directorate of Information Technology & Communication in Kohima. The training schedule included training on Online Inner Line Permit System, Training on Right of Way and Hands-on Training on Right of Way for Telecom.

Dr. Jamir encouraged the young people to focus on shaping a better future instead of dwelling on past conflicts and called on political leaders to create opportunities for the youth and ensure an inclusive, progressive future for Nagaland.

Member of Parliament, Rajya Sabha, Sushmita Dev addressed the event, emphasizing the importance of cultural

integration and respect among communities. She stressed that India would remain divided without mutual understanding and warned of the dangers of forgetting history.

Former MLA, Dr. Chumben Murry at the event, called for unity beyond ethnic and linguistic lines, suggesting that the term 'Non-Naga Linguistic Forum' replaces the word 'minority' to promote inclusivity. Murry also urged the youth to develop a global outlook, warning that neglecting to adapt to technological advancements and global issues could leave them behind in an evolving world.

The Technology Clinics successfully concluded with 40 participants in each session throughout the four-day programme.

With the themed "Innovating with Advanced Bamboo Technology," the clinic featured three sessions under the topics, Clinic 1: Bamboo Basic Course Clinic 2: Bamboo Handicraft and Utility Items

Training, and Clinic 3: Bamboo Furniture Training.

Dr. Tolto Metha, Team Member, NBDA and resource person, conducted Clinic 1, highlighting the diversity and economic potential of bamboo. He noted that Nagaland is home to 46 of India's 144 bamboo species, the highest among all the states. He emphasized the versatility of bamboo across various applications, including construction, furniture, bioethanol, ornaments etc. underscoring its transition from being called as the "poor man's timber" to "Green Gold" due to its immense economic value. The course also explored the potential of bamboo as a substitute for plastic and the importance of developing disposable bamboo products as sustainable alternatives.

Following the session, participants were taken on a guided tour of the Nagaland Bamboo Resource Centre, where they received demonstrations on bamboo processing technologies and machinery.

Clinic 2 and Clinic 3 were led by Master Trainers, Khrolo Naro and Rouvi Chuzho. These sessions included hands-on training

where participants worked with various bamboo species using advanced machinery available at the centre.

As part of the ongoing "TB Free Nagaland" campaign launched by the Directorate of Health & Family Welfare under the National Tuberculosis Elimination Programme, an awareness programme was held on 27th February 2025 at the Directorate of Information & Public Relations, Kohima.

The programme which was attended by the officials and staff of the Department

concluded with a "TB Mukta Bharat" pledge taking ceremony administered by Joint Director, IPR, Simon Teilia. This initiative aims to not only educate the public about the infectious nature of the disease and the steps to prevent its spread but also combat the stigma associated with the disease.

A significant component of the campaign focuses on dispelling myths and

misconceptions about TB. It highlights key preventive measures like respiratory hygiene - to cover the mouth and nose while coughing or sneezing, to avoid spitting in public places, proper sputum disposal, and maintaining well-ventilated living spaces.

The campaign also emphasizes the importance of completing the full course of Directly Observed Treatment, Short-course (DOTS), reassuring the public that TB patients are no longer infectious after two weeks of treatment. Furthermore, a toll-free Ni-Kshay Helpline (1800-11-6666) is available for individuals seeking information or support. This message aims to reassure the public and encourage compassionate support for individuals undergoing treatment.

The campaign focuses on early detection

and stresses that Cough is not the only symptom of TB but there are other equally important signs, including fever, chest pain, swelling in the neck or armpits, sudden physical changes, sudden weight loss, cough with mucus, blood in sputum and night sweats. Early detection is crucial for effective treatment and preventing further spread of the disease.

The awareness programme comes at a crucial time as Nagaland strives to meet the national target of eliminating TB by 2025. The success of the Tuberculosis elimination programme hinges on collective effort, public awareness and participation, preventive measures, and tackling the stigma associated with the disease, thereby ensuring a healthier future for Nagaland.

NAGALAND CINEFEST 2025 HELD AT KOHIMA

The Nagaland CineFest 2025 commenced on 28th February 2025 at the Heritage, Kohima, organised by the Department of Information & Public

To address this, the district administration will conduct surprise inspections to ensure vendors operate from their designated locations. Additionally, the board discussed the possibility of making non-judicial stamps available digitally to ease accessibility for the public.

The Transport Department delivered a PowerPoint presentation highlighting key safety initiatives.

The meeting concluded with discussions on streamlining the distribution process of non-judicial stamps and ensuring strict compliance with licensing regulations. The renaming of St. Anthony's School to Potentia School, Nagarjan, Dimapur, and registration of Tsunshiso Cultural Society was deferred to the next meeting.

NH 129A PACKAGE-1 OF PEREN TOWN FACILITATION MEETING HELD

The facilitation meeting for National Highway 129 A Package-1 Peren Town portion was held at Town Hall, Peren on 11th February 2025. Deputy Chief Minister and Minister in-charge of Planning & Transformation and National Highways, Government of Nagaland, T. R. Zeliang graced the facilitation meeting as the honoured guest.

Deputy Chief Minister, T. R. Zeliang stated the importance of good roads, and encouraged the public to co-operate with the District Administration and to settle the damage compensation at the earliest. Zeliang also informed that the Technical Evaluation is under process at NHIDCL Headquarter and four firms have participated in the bidding, and that the period for completion would be 18 months from the appointed date. The successful implementation of this project will change the face of Peren town.

Deputy Commissioner, Peren, Hiazu Meru, NCS said that good roads will promote development and progress in the region. He encouraged the Peren town public leaders to

have regular and timely meetings in order to give their support in the process of work development and to assist the workers.

In the meeting, short speeches were delivered by Machi Reunim, President of Peren Town Youth Organization on behalf of the affected owners, Hairiesong Siang, Liamchu Hega, Chairman of Peren Village Council, Gaigwang Hegeu, Convenor (JAC) Pelingrangle, President of Peren Town Women Welfare Organisation and Mireulung Sephe, Chairperson of Peren Town Council. The landowners and the affected landowners openly declared that they are willing to co-operate and give their land for the welfare of the public.

Deputy General Manager (Projects), NHIDCL, PMU-Dimapur, Anand Kumar, highlighting the project of NH 129A Package-1 of Peren Town Portion, stated that 129A Peren to Dimapur section starts from Dzukou River Steel Bridge (Manipur) border to 7th Mile Chumukedima, a total length of approximately 81 Km, divided into six packages. He stated that the project has

been conceived with the aim to provide good quality highway. He added that the National Highway 129A will serve as an alternate route to Manipur connecting Nagaland. Anand

Kumar highlighted that the Project Cost of 129A Package--1 Peren Town Portion is Rs. 106.32 crore.

NTCP ZUNHEBOTO UNIT LAUNCHES PROHIBITION DRIVE

National Tobacco Control Programme (NTCP), Zunheboto unit initiated a full scale checking of prohibited tobacco products, mainly targeting vicinity of educational institutions on 12th February 2025. The drive was carried under COPTA 2003, which prohibits advertisement and regulation of Trade and Commerce Acts under Section 6(b), which further prohibits sale of tobacco products within 100 meters of educational institutions.

The drive was collaborated with and followed physically by District Administration officials led by EAC, Zunheboto, Tsoinchu Sangtam, Dobashis, Police personnel under SP's Office, Zunheboto, Officials from Zunheboto Range Students' Union (ZRSU), Sumi Youth Organisation (SYO) and No Tobacco Club Zunheboto. The seized products were later disposed off as per the department's proposed disposal system.

She highlighted the importance of preventing migration due to water scarcity and urged the community to implement trenches, tanks, and water conservation structures to recharge land and maintain soil fertility for

future generations.

The DC pointed out that less than 50% of the rural population is engaged in agricultural work, with most focusing on plantations. He posed the question of whether this shift indicated progression or degradation. Acknowledging water scarcity issues in Mokokchung and other major headquarters in the state, he stressed the need for collective action to conserve and protect water resources.

The Department of Food & Civil Supplies presented an overview of its ongoing activities in the district.

KOHIMA DPDB DISCUSSES CHALLENGES OF KMC

The Kohima District Planning & Development Board (DPDB) held its meeting at the DPDB Hall, Kohima, on 15th February 2025, in the presence of DPDB Chairman, Dr. Tseilhoutuo Rhutso, MLA and Kevipodi Sophie, MLA. The meeting was chaired by Deputy Commissioner, Kohima, Kumar Ramnikant, IAS.

On the occasion of the 10th anniversary of the Beti Bachao Beti Padhao (BBBP) initiative, a district felicitation was held. Ketsino Jane Frances and Ketsole Mekro, the female toppers of the NBSE 2024 HSLC and HSSLC Exams were felicitated for their achievements. Also, Hili Kath Metsie-o, a woman police personnel, was recognized for her contributions to solving women-related cases.

Two organizations, Leal Group Society Kohima and Science and Technology Advancement and Research Society

delivered PowerPoint presentations seeking registration approval. After deliberation, the Board decided to approve their proposals for further action.

The Kohima Municipal Council (KMC) gave a PowerPoint presentation on its activities. CEO, KMC, T. Lanusenla Longkumer spoke about the inception, organizational structure, and revenue sources of KMC. She highlighted that sanitation was decentralized in 2013, and currently, KMC manages commercial waste using 9 vehicles, while the wards operate 39 vehicles for waste collection. She added that 65 sweepers are engaged in cleaning the town once a week.

Lanusenla also spoke about the PM SVANidhi scheme and the KMC website. Addressing the challenges faced by KMC, she mentioned salary shortfalls, making KMC dependent on government grants, lack of a proper office space for KMC operations,

ageing sanitation vehicles and the difficulty in removing collection points due to traffic congestion and vehicle sizes, non-functional septage management plant, lack of designated spaces for vendors, non-functional Kohima Super Market, development activities lacking coordination. She also outlined the initiatives undertaken by KMC.

Dr. Rhutso suggested that shopowners should take responsibility for maintaining

cleanliness in their designated areas. MLA Kevipodi Sophie emphasized the need for designated spaces for farmers to sell their produce, particularly in the morning hours.

After the meeting, a dedicated vehicle was launched for One Stop Centre for rescue and support of women affected by violence, in private and public spaces, within the family, community and at the workplace.

The Department is committed to supporting entrepreneurs, aiming to create jobs, increase income, improve food security, and promote sustainable aquaculture

practices. Ultimately, this initiative will create a brighter future for the communities.

In the technical session, resource person, District Fishery Officer (DFO), Dimapur, Imtisonep gave a detailed PowerPoint presentation on breeding methods of Common Carp. Assistant Fishery Inspector (AFI), Neimelu Noswe sensitized the farmers on NFDP-National Fisheries Digital Platform, PMMKSSY-Pradhan Mantri Matsya Kisan Samridhi Sah Yojana which is the sub-scheme of PMMSY-Pradhan Mantri Matsya Sampada Yojana & KCC-Kissan Credit Card Scheme.

During the training, the trainees were also given demonstration on preparation of fish feeds by ATMA, Jalukie Block. Altogether, 13 fish farmers from Jalukie Block actively attended the workshop programme.

DDSC REVIEWS PROGRESS AND EXPANDS TRAINING PROGRAMMES HELD AT DIMAPUR

The Office of the Deputy Commissioner, Dimapur held the final quarterly meeting of the District Skill Committee (DSC) on 19th February 2025. The meeting was chaired by, ADC, Dimapur, Zakabo V Rotokha, NCS.

In the review meeting, Gideon Sumi, District Employment Officer, Dimapur said that the Department of Employment, Skill Development & Entrepreneurship has launched multiple skill development programmes for 2024-25, where the State-Funded PACES Programme for training in electrician (160 candidates) and baking (160 candidates), and another initiative for 25 candidates yet to be finalized are the Centrally Funded SANKALP Project, Training in Assistant Electrician & Carpentry (50 candidates) and Food Processing (50 candidates).

These initiatives aim to enhance

employability and self-sufficiency for the youths of the district. Eligible candidates are encouraged to enroll. For further details, one can contact the Department of Employment, Skill Development & Entrepreneurship, Dimapur. He also said that the review highlighted achievements such as increased enrollment in technical courses, successful placements in various sectors, and collaborations with local businesses. Challenges, including infrastructure gaps and funding constraints, were also addressed, with plans for further improvement.

The district is positioning itself as a hub for skill development, with ongoing efforts to expand vocational training programmes. Authorities are working on introducing new policies to support employees in upgrading their skills, thereby boosting employment opportunities and economic growth.

AWARENESS CAMP ON PM VISHWAKARMA HELD

Under the Ministry of MSME Government of India, the MSME Development & Facilitation Office Dimapur in association with the Department of Industries & Commerce, Nagaland and District Administration organised a one-day Awareness-cum-GP Onboarding Camp on PM Vishwakarma on 6th February 2025 at Deputy Commissioner's Office Conference Hall, Wokha. The awareness programme was attended by Village Council Chairmen (VCC) from three blocks under Wokha, Chukitong and Wozhuro.

In his address, DC, Wokha, Vineet Kumar (IAS) said that this scheme was introduced by the Government of India to enable the recognition of artisans, craftsmen and craftspeople on various trades, and to provide skill upgradation to hone their skills and make relevant and suitable training opportunities available to them through various training programmes. Stating that verification of applicants is very important, the DC urged the VCCs to select and recommend genuine applicants and beneficiaries so that not only the applicants but the community gets maximum benefit out of this scheme.

Consultant, Ernest & Young Company, PM Vishwakarma (PMU), L.L. Victoria highlighted to the trainees about guidelines to be followed in the implementation of the scheme. She also informed the beneficiaries and applicants to do onboarding in coordination with the District Implementing Committee by providing a verified Aadhar seeded names and mobile numbers to be uploaded in the eGramswaraj portal.

Later in the day, five (5) beneficiaries who had undergone training under carpentry received toolkits from the DC.

A one-day awareness camp on PM

Vishwakarma was also held at Chessore village under Shamator district on 13th February 2025, Longkhim under Tuensang district on 11th February 2025, Tuensang village under Tuensang district on 12th February 2025, Shamator town on 14th February 2025, Noklak on 17th February 2025 and Longleng on 19th February 2025, wherein artisans applied for corrective measures in their Aadhaar such as seeding of their mobile number, change in residential address etc. Under the PMV scheme, it is mandatory for an artisan to have the following details corrected on their Aadhaar. The objective of this camp is to create ground awareness of schemes, onboard the village on the scheme portal and facilitate enrolment of the artisans. The events saw enthusiastic engagement from participants, reflecting a positive response toward the initiative.

The PM Vishwakarma Scheme was launched by the Government of India on 17th September 2023 to support traditional artisans and crafts people, collectively known as Vishwakarmas. This scheme aims to upskill artisans in their chosen trade through access to high quality training, upgraded tools and access to collateral free credit.

The 18 identified trades under the scheme are Carpenter, Goldsmith, Potter, Barber, Cobbler, Sculptor, Tailor, Washerman, Boat Maker, Mason, Armourer, Blacksmith, Hammer and tool Kit Maker, Locksmith, Stone Breaker, Basket/Mat/Broom Maker/Coir Weaver, Doll & Toy Maker, Garland Maker, Fishing Net Maker. Currently, the trades Carpentry, Masonry and Tailoring are on halt at the centre. The entire process of the scheme is digital and interested artisans can enroll at the nearest CSC.

RTA DIMAPUR HOLDS BOARD MEETING TO DISCUSS TRANSPORT REGULATIONS

The Regional Transport Authority (RTA), Dimapur held its board meeting on 20th February 2025, in the Office Chamber of the Deputy Commissioner, Dimapur. The meeting was chaired by Dr. Tinojongshi Chang, DC, Dimapur, who also serves as the Chairman of the RTA, and was attended by all board members and representatives.

During the meeting, key transport-related issues were discussed, including the restriction of heavy vehicle parking around Unity Gate and Patkai Bridge. The board also deliberated on relocating taxi and ticket counters to the Inter-State Bus Terminal (ISBT) and formed a committee to study its implementation. Discussions were held regarding restrictions and alternate routes for manual rickshaws and thela-walas, with the Dimapur Municipal Council (DMC) and the Officer in Charge (Traffic) assigned to study the matter.

The board also addressed concerns about parking fees at Dimapur Railway Station, where both railway authorities and

the DMC currently collect charges from taxis. It was decided that the DMC would engage in discussions with railway authorities to resolve the issue.

The RTA board also reviewed speed limits for different types of roads and decided to write to the State Government for official implementation. Additionally, the possibility of establishing separate RTA Boards for Chumoukedima and Niuland was discussed, with a decision to submit a proposal to the State Government.

A key topic of discussion was the issuance of two-wheeler taxi permits for Dimapur, Chumoukedima and Niuland. The board finalized conditions for granting permits, issuing forms, and related procedures. Plans to establish a prepaid taxi booth at Dimapur Airport were also deliberated.

Furthermore, the meeting discussed a sub-committee report on auto-rickshaw fares and parking under the RTA jurisdictions of Dimapur, Chumoukedima, and Niuland.

ORAL AND DENTAL HEALTH CAMP HELD AT NPTS

Oral cancer screening, consultation and tooth extraction was carried out during the camp. Free medicines were also provided to the patients.
